This marked the start of the operation of SCO as an international organization in its full sense. I am convinced that after becoming an observer in the General Assembly, SCO will take a more active part in international affairs, conduct wider cooperation with the United Nations and other countries and international organizations, and make its due contribution to maintaining regional and world peace and security and boosting regional economic growth. SCO will work tirelessly to this end.

## Annex I

### Explanatory memorandum

#### Shanghai Cooperation Organization

On 15 June 2001, the heads of State of the Republic of Kazakhstan, the People's Republic of China, the Republic of Kyrgyzstan, the Russian Federation, the Republic of Tajikistan and the Republic of Uzbekistan met in Shanghai, China, and declared the founding of the Shanghai Cooperation Organization (SCO). In June 2002, the SCO Charter was signed at the St. Petersburg summit. The Charter made clear stipulations on the purposes, principles, organizational structure, form of operation, cooperation orientation and external relations of SCO.

The main purposes of SCO are strengthening mutual trust, good-neighbourliness and friendship among member States; developing their effective cooperation in their political affairs, economic issues, trade, science and technology, culture, education, energy, transportation, environmental protection and other fields; working together to maintain and guarantee regional peace, security and stability; and promoting the creation of a new international political and economic order featuring democracy, justice and rationality.

The Shanghai Cooperation Organization advocates and observes the Shanghai Spirit, characterized by mutual trust, mutual benefit, equality, cooperation, respect for diversified civilizations and common development.

Since its founding two years ago, SCO has achieved gratifying results in the improvement of its institutional set-up and legal framework. More than 20 legal documents have been adopted to standardize the operation of the Organization. SCO has also established meeting mechanisms for heads of State, heads of Government, ministers for foreign affairs, defence, commerce, culture and transportation, leading officials responsible for law enforcement, security, border defence, procuratorial work, and emergency and disaster relief. With the formal launching of the secretariat based in Beijing and the Regional Anti-Terrorism Structure based in Tashkent, SCO has completed its initial phase of development.

Security and economic cooperation are two priorities of SCO. SCO security cooperation focuses on the fight against three forces, namely, terrorism, separatism and extremism, in order to maintain regional peace and stability. As the first international organization that explicitly advocates combating the above-mentioned "three forces", SCO adopted the Shanghai Convention against Terrorism, Separatism and Extremism upon its inception. Later, bilateral and multilateral joint anti-terrorism military exercises were successfully conducted within the SCO framework. At present, SCO is intensifying research on cooperative actions against narcotic drugs and preparing relevant documents for signing. For economic cooperation, the heads of Government of the six member States met in September 2001 to launch the negotiation process of trade and investment facilitation. The SCO heads of Government ratified the Plan for Multilateral Economic and Trade Cooperation of the SCO Member States in September 2003. The Plan explicitly identified priority areas, main tasks at the present stage and implementation mechanisms for economic and trade cooperation among the six SCO member States, and defined the goal of gradually realizing the free flow of goods, capital, service

and technology among them, reflecting the aspirations and determination of the member States in regional economic integration.

The Shanghai Cooperation Organization follows the principles of non-alignment, openness and not targeting any other country or region. It stands ready to conduct dialogue, exchanges and cooperation in all forms with other nations and international organizations. SCO will accept countries recognizing its purposes and principles first as observers, then dialogue partners and finally, new member States, on the basis of reaching consensus through consultations. At present, SCO is preparing legal documents in this connection.

The founding of SCO has attracted worldwide attention. A number of countries and international organizations have proposed to establish contacts and conduct exchanges and cooperation with SCO. The United Nations, the European Union, the Organization for Security and Cooperation in Europe and the Commonwealth of Independent States were represented at the ceremony of the establishment of the SCO secretariat. The Secretary-General, Zhang Deguang, met with their representatives respectively and discussed issues of bilateral cooperation with them. Representatives of SCO were also invited to attend anti-terrorism conferences of international organizations such as the United Nations and the Organization for Security and Cooperation in Europe.

With the concerted efforts of its member States, SCO is growing into an effective cooperation mechanism for the maintenance of regional security and stability and the promotion of the common development of its member States. In the future, SCO will surely become an important force in enhancing world peace and development.

#### **Observer status for the Shanghai Cooperation Organization in the General Assembly**

*The General Assembly,*

*Wishing* to promote cooperation between the United Nations and the Shanghai Cooperation Organization,
