Revitalization of the work of the General Assembly

Report of the Sixth Committee

I. Introduction

1. The item entitled “Revitalization of the work of the General Assembly” was included in the provisional agenda of the sixty-first session of the General Assembly in accordance with Assembly resolution 58/316 of 13 July 2004.
2. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.
3. The Sixth Committee considered the item at its 23rd meeting, on 21 November 2006 (see A/C.6/61/SR.23).

II. Consideration of draft decision A/C.6/61/L.19

4. At the 23rd meeting, on 21 November, the Chairman introduced the draft decision on the provisional programme of work for the sixty-second session of the General Assembly as proposed by the Bureau and contained in document A/C.6/61/L.19.
5. At the same meeting, the Committee adopted the draft decision on the provisional programme of work for the sixty-second session of the General Assembly (see para. 7).
6. The representative of the Syrian Arab Republic made a statement in explanation of position after the adoption of the draft decision (see A/C.6/61/SR.23).



III. Recommendation of the Sixth Committee
