Letter dated 13 June 2007 from the Permanent Representative of Cyprus to the United Nations addressed to the Secretary-General

Upon instructions from my Government and further to my letter dated 25 May 2007 (A/61/931-S/2007/317), I have the honour to draw your attention to new violations of international air traffic regulations and the national airspace of the Republic of Cyprus by military aircraft of the Turkish Air Force, recorded from 6 April to 31 May 2007.

On 6 and 8 April 2007, one Cougar and two Gulf Stream Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.

On 10 April 2007, two F-4 and three Cougar Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.

On the same day, four F-4 Turkish military aircraft coming in two formations violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.

On 11 April 2007, one Cougar and one C-650 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.

On 12 April 2007, two F-4 and two Cougar Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus twice.

On 13 and 15 April 2007, one CN-235, one Cougar and one Bell Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.

On 17 April 2007, one Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.



- On 18 April 2007, two C-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 19 April 2007, one Cougar and two C-160 Turkish military aircraft violated the international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.
- On 24 April 2007, one Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 25 April 2007, one Cougar, two CN-235 and two B-200 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus five times.
- On 26 April 2007, one Cougar and two C-160 Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.
- On 30 April and 1 May 2007, four Cougar and one CN-235 Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus five times.
- On 2 May 2007, one CN-235, one Cougar, four F-4 and two F-16 Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus four times.
- On 3 May 2007, four F-4, one Cougar and one CN-235 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus twice.
- On 4 May 2007, one Cougar, two C-160 and one AB 212 ASW Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.
- On the same day, four F-4, one CN-235 and one AB 212 ASW Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus once.
- On 7 May 2007, one C-130, two F-4, two F-16, one CN-235 and one Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus five times.
- On 8 May 2007, two F-16, two F-4 and one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 9 May 2007, two F-1, two F-4, one CN-235 and one Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus four times.
- On 10 May 2007, one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 14 May 2007, four F-16 and one CN-235 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus twice.

On 15 May 2007, one Turkish military aircraft of unknown type violated international air traffic regulations twice.

On 16 May 2007, two F-16, two F-4 and one CN-235 Turkish military aircraft violated international air traffic regulations five times.

On the same day, one C-130 and one Cougar Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.

On 17 May 2007, one C-160 and two Cougar Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.

On 18 and 20 May 2007, two F-4, one Cougar and one Turkish military aircraft of unknown type violated international air traffic regulations four times and the national airspace of the Republic of Cyprus once.

- On 21 May 2007, one C-130 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 22 May 2007, one Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 23 May 2007, one B-200 and three Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus five times.
- On 24 May 2007, two C-130 and two Cougar Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.
- On 31 May 2007, one CN-235 and one Cougar Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus twice.

On behalf of the Government of the Republic of Cyprus, I strongly protest the aforementioned violations, which, as indicated in our previous communications, blatantly endanger the safety of international civil aviation and contravene international law and air traffic regulations. These violations put at stake the peace and stability of the region, and I call for their immediate cessation.

The Government of Turkey should heed the call of the international community, abide by the Charter of the United Nations and respect the sovereignty, independence and territorial integrity of the Republic of Cyprus, thus contributing to the creation of the required conditions for the achievement of a just and viable solution to the Cyprus problem.

I would be grateful if the present letter could be circulated as a document of the General Assembly, under agenda item 19, and of the Security Council.
