## Letter dated 5 December 2011 from the Permanent Representative of Cyprus to the United Nations addressed to the Secretary-General

Upon instructions from my Government and further to my letter dated 4 August 2011 (A/65/923-S/2011/493), I have the honour to draw your attention to ongoing violations of the international air traffic regulations and the national airspace of the Republic of Cyprus by military aircraft of the Turkish Air Force, recorded from 1 August to 28 October 2011, as follows.

- On 1 August 2011, six F-16 and one CN-235 Turkish military aircraft violated the national airspace of the Republic of Cyprus twice.
- On 2 August 2011, two F-16, one Cougar and one S-70 Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus.
- On 3 August 2011, one Cougar, one C-160, one CN-235 and two Turkish military aircraft of unknown type violated international air traffic regulations six times and the national airspace of the Republic of Cyprus three times.
- On 4 August 2011, one Turkish military aircraft of unknown type violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 5 August 2011, one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 8 August 2011, four Cougar Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 10 August 2011, two Cougar, two F-4, one CN-235 and one C-130 Turkish military aircraft violated international air traffic regulations six times and the national airspace of the Republic of Cyprus four times.





- On 11 August 2011, one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 12 August 2011, one Cougar and one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 16 August 2011, two F-16, one CN-235 and one Turkish military aircraft of unknown type violated international air traffic regulations four times and the national airspace of the Republic of Cyprus twice.
- On 17 August 2011, one B-204 and one B-200 Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.
- On 18 August 2011, one CN-235 and one Cougar Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus.
- On 22 August 2011, one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 23 August 2011, three CN-235, two F-16 and one Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus three times.
- On 24 August 2011, three CN-235, one C-130 and one Cougar Turkish military aircraft violated international air traffic regulations six times and the national airspace of the Republic of Cyprus five times.
- On 25 August 2011, three CN-235 and two Cougar Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.
- On 30 August 2011, two Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 4 September 2011, one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 7 September 2011, one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 8 September 2011, one Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 9 and 11 September 2011, one GLF-4 and one CN-235 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.

- On 13 September 2011, one CN-235 and two F-4 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 14 September 2011, two F-16, two CN-235, one B-200 and one Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus five times.
- On 15 September 2011, one Cougar Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 16 and 18 September 2011, two F-16, two S-70 and four CN-235 Turkish military aircraft violated international air traffic regulations nine times and the national airspace of the Republic of Cyprus seven times.
- On 19 September 2011, two F-4, one CN-235, two S-70 and one Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus three times.
- On 20 September 2011, two F-16, seven CN-235, four S-70 and one Cougar Turkish military aircraft violated international air traffic regulations 17 times and the national airspace of the Republic of Cyprus 14 times.
- On 21 September 2011, two F-16, two CN-235, two S-70 and two Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus five times.
- On 22 September 2011, two Cougar Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 26 September 2011, three S-70 and one CN-235 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus four times.
- On 27 September 2011, two F-16, three CN-235, one S-70, one Cougar and one C-560 Turkish military aircraft violated international air traffic regulations 10 times and the national airspace of the Republic of Cyprus 8 times.
- On 28 September 2011, two F-16, three CN-235, two Cougar and one Turkish military aircraft of unknown type violated international air traffic regulations nine times and the national airspace of the Republic of Cyprus seven times.
- On 29 September 2011, one CN-235 Turkish military aircraft violated international air traffic regulations and the national airspace of the Republic of Cyprus.
- On 30 September 2011, two F-16, two S-70, one CN-235 and one Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus five times.
- On 3 October 2011, two F-4, four CN-235, one Cougar and two S-70 Turkish military aircraft violated international air traffic regulations 12 times and the national airspace of the Republic of Cyprus 10 times.

- On 4 October 2011, two Cougar Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 5 October 2011, two CN-235 and two Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus four times.
- On 7 and 9 October 2011, two CN-235, two S-70 and one Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus three times.
- On 11 October 2011, two F-16 and one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus.
- On 12 October 2011, four F-16, one CN-235 and one B-200 Turkish military aircraft violated international air traffic regulations four times and the national airspace of the Republic of Cyprus twice.
- On 13 October 2011, four F-16, two F-4 and two CN-235 Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus five times.
- On 17 October 2011, two F-16 and one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 19 October 2011, two F-16, one CN-235, one C-160 and two Cougar Turkish military aircraft violated international air traffic regulations six times and the national airspace of the Republic of Cyprus four times.
- On 20 October 2011, two F-16 and one CN-235 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.
- On 21 October 2011, two F-16 and one Cougar Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus.
- On 24 October 2011, four F-16 and one CN-235 Turkish military aircraft violated international air traffic regulations three times and the national airspace of the Republic of Cyprus three times.
- On 25 October 2011, two CN-235 and two Cougar Turkish military aircraft violated international air traffic regulations five times and the national airspace of the Republic of Cyprus five times.
- On 26 October 2011, two CN-235, four F-16, one B-200 and one Cougar Turkish military aircraft violated international air traffic regulations seven times and the national airspace of the Republic of Cyprus three times.
- On 27 and 28 October 2011, one C-160 and two F-16 Turkish military aircraft violated international air traffic regulations twice and the national airspace of the Republic of Cyprus twice.

On behalf of my Government, I strongly protest the continuing violations by Turkey of international air traffic regulations and the national airspace of the Republic of Cyprus and call for their immediate cessation.

These systematic abuses by Turkey of the sovereignty and territorial integrity of the Republic of Cyprus blatantly violate international law and air traffic regulations and seriously jeopardize the safety of international aviation in the region. Such actions are particularly counterproductive at the present period of ongoing negotiations in search of a just, lasting and peaceful solution to the Cyprus problem.

Cyprus, once again, calls upon the Turkish Government to abide by the Charter of the United Nations and its international obligations and respect the sovereignty, independence and territorial integrity of all Member States of the United Nations. Rather than pursuing this decidedly provocative path, Turkey should heed the call of the international community and act in a constructive spirit to create the necessary conditions for reaching a viable solution to the Cyprus problem, in accordance with the agreed basis for such a solution, endorsed by numerous Security Council resolutions.

I should be grateful if you would have the present letter circulated as a document of the General Assembly, under agenda item 43, and of the Security Council.
