Vilnius Declaration on the ratification of the United Nations Convention against Transnational Organized Crime and its Protocols

4-5 June 2002

We, the representatives of Central and Eastern European countries, namely Albania, Armenia, Belarus, Bulgaria, Croatia, Estonia, Georgia, Hungary, Latvia, Lithuania, Poland, Republic of Moldova, Romania, Russian Federation, Slovakia, The former Yugoslav Republic of Macedonia, and Ukraine, participating in the Ministerial Seminar on the United Nations Convention against Transnational Organized Crime and its Protocols,

Deeply concerned about the impact of transnational organized crime on the political, social and economic prosperity, stability and security of our countries,

Noting that the global nature of transnational organized crime demands a global response,

Convinced of the urgent need to work together to combat organized crime, in all its forms and manifestations, and also terrorism,

Recalling United Nations General Assembly resolutions 55/25 of 15 November 2000 and 55/255 of 31 May 2001, which adopted the United Nations Convention against Transnational Organized Crime and the three protocols thereto, which constitute effective tools for international cooperation in combating transnational organized crime,

1. *Express appreciation* to the Government of Lithuania for hosting the Ministerial Seminar in Vilnius, organized by the United Nations Centre for International Crime Prevention (CICP);

2. *Also express appreciation* to the Government of the United Kingdom of Great Britain and Northern Ireland for its generous voluntary contribution, which made the seminar possible;

3. *Commend* those countries of the Central and Eastern European region that have signed and the United Nations Convention against Transnational Organized Crime and its Protocols;

4. *Recommend* that those countries that have not yet signed the Protocols consider doing so as soon as possible;

5. *Express our satisfaction* that several countries that have signed the Convention and its Protocols are at an advanced stage in the process of ratification of these instruments;

6. *Commend* those countries of the region that have ratified the Convention and its Protocols, as appropriate, and *urge* those countries that have not done so to undertake all necessary efforts and complete all requirements, in accordance with

domestic law, in order to ensure the submission to national parliaments of the necessary legislative proposals for their ratification;

7. *Reaffirm* the commitment to enhance multilateral cooperation and to take further initiatives in this direction, in coordination with CICP;

8. *Recognize* the importance of reviewing and improving national legislation against transnational organized crime, in accordance with the Convention and its Protocols, as appropriate;

9. *Endeavour* to review progress in the ratification and early implementation of these instruments in six months and to provide relevant information to the Centre for International Crime Prevention;

10. *Call upon* donor countries and relevant international and regional organizations to enhance financial and material assistance to support the efforts of countries of the region in ratifying and implementing the Convention and its Protocols, through regular voluntary contributions to the special account established under the United Nations Crime Prevention and Criminal Justice Fund, in accordance with article 30 of the Convention;

11. *Urge* countries of the region to continue participating actively in the negotiations of the new United Nations Convention against Corruption, and invite donor countries to support such participation;

12. *Invite* the Chairman of the Seminar to bring the present Declaration to the attention of the Commission on Crime Prevention and Criminal Justice at its twelfth session.
