### Appointments to fill vacancies in subsidiary organs and other appointments

## Appointment of members of the Joint Inspection Unit

### Note by the President of the General Assembly

1. As indicated in paragraph 3 of the note by the Secretary-General of 25 April 2001 (A/56/107), the General Assembly is required, during its current session, to appoint five members of the Joint Inspection Unit to fill the vacancies that will arise from the expiration on 31 December 2002 of the terms of office of Fatih Bouayad-Agha (Algeria), Homero Luis Hernández Sánchez (Dominican Republic), Eduard Kudriavtsev (Russian Federation), Francesco Mezzalama (Italy) and Khalil Issa Othman (Jordan).

2. In accordance with the procedures described in article 3, paragraph 1, of the statute of the Joint Inspection Unit, the President of the General Assembly, having consulted the regional groups, and on the basis of the candidates submitted by the African, Asian, Eastern European, Latin American and Caribbean and Western European and other States (see annexes I to V), as well as through a consultation by secret ballot with the General Assembly, requested China, Cuba, the Russian Federation, the United Republic of Tanzania and the United States of America to propose candidates.

3. The President of the General Assembly has held the consultations described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General, in his capacity as Chairman of the United Nations System Chief Executives Board for Coordination. The replies received from the President of the Council and from the Secretary-General to identical letters addressed to them on 31 January 2002 by the President of the Assembly are attached (see annexes VI and VII).

4. Having completed the required consultations, the President of the General Assembly has the honour to submit to the Assembly the following list of candidates for appointment as members of the Joint Inspection Unit for a five-year term beginning on 1 January 2003 and expiring on 31 December 2007:

Mr. Even Francisco Fontaine Ortiz (Cuba)

Mr. Tang Guangting (China)

Mr. Victor Vislykh (Russian Federation)

Ms. Deborah Wynes (United States of America)

Mr. Muhammad Yussuf (United Republic of Tanzania).

**Annex I****Note verbale dated 9 January 2002 from the Permanent Mission of the United Republic of Tanzania to the United Nations**
