

Offers by Member States of study and training facilities for inhabitants of Non-Self-Governing Territories

Report of the Special Political and Decolonization Committee (Fourth Committee)

I. Introduction

- 1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-seventh session the item entitled "Offers by Member States of study and training facilities for inhabitants of Non-Self-Governing Territories" and to allocate it to the Special Political and Decolonization Committee (Fourth Committee).
- 2. At its 1st meeting, on 26 September 2002, the Fourth Committee decided to hold a general debate covering agenda items 19, 80, 81, 82, and 12, and 83. The general debate on the items was held at the 2nd, 3rd, 5th and 6th meetings, on 30 September and on 1, 3 and 4 October (see A/C.4/57/SR.2, 3, 5 and 6). The Committee took action on item 83 at its 6th meeting, on 4 October (see A/C.4/57/SR.6).
- 3. For its consideration of the item, the Committee had before it the following documents:
 - (a) Report of the Secretary-General (A/57/90 and Add.1);
- (b) Letter dated 20 August 2002 from the Permanent Representative of Fiji to the United Nations addressed to the Secretary-General, transmitting the communiqué of the thirty-third meeting of the Pacific Islands Forum, held in Fiji from 15 to 17 August 2002 (A/57/331).

II. Consideration of draft resolution A/C.4/57/L.3

- 4. At the 4th meeting, on 2 October, the Chairman drew attention to a draft resolution entitled "Offers by Member States of study and training facilities for inhabitants of Non-Self-Governing Territories" (A/C.4/57/L.3), sponsored by Algeria, Argentina, China, Cuba, Egypt, Ghana, India, the Islamic Republic of Iran, the Philippines, Singapore, Thailand and the United Republic of Tanzania, subsequently joined by Nigeria.
- 5. At its 6th meeting, on 4 October, the Committee adopted draft resolution A/C.4/57/L.3 without a vote (see para. 6).

III. Recommendation of the Special Political and Decolonization Committee (Fourth Committee)

6. The Special Political and Decolonization Committee (Fourth Committee) recommends to the General Assembly the adoption of the following draft resolution:

Offers by Member States of study and training facilities for inhabitants of Non-Self-Governing Territories

The General Assembly,

Recalling its resolution 56/68 of 10 December 2001,

Having examined the report of the Secretary-General on offers by Member States of study and training facilities for inhabitants of Non-Self-Governing Territories, prepared pursuant to its resolution 845 (IX) of 22 November 1954,

Conscious of the importance of promoting the educational advancement of the inhabitants of Non-Self-Governing Territories,

Strongly convinced that the continuation and expansion of offers of scholarships is essential in order to meet the increasing need of students from Non-Self-Governing Territories for educational and training assistance, and considering that students in those Territories should be encouraged to avail themselves of such offers.

- 1. Takes note of the report of the Secretary-General;¹
- 2. Expresses it appreciation to those Member States that have made scholarships available to the inhabitants of Non-Self-Governing Territories;
- 3. *Invites* all States to make or continue to make generous offers of study and training facilities to the inhabitants of those Territories that have not yet attained self-government or independence and, wherever possible, to provide travel funds to prospective students;
- 4. *Urges* the administering Powers to take effective measures to ensure the widespread and continuous dissemination in the Territories under their administration of information relating to offers of study and training facilities made

by States and to provide all the necessary facilities to enable students to avail themselves of such offers;

- 5. *Requests* the Secretary-General to report to the General Assembly at its fifty-eighth session on the implementation of the present resolution;
- 6. Draws the attention of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples to the present resolution.
