Report of the Second Committee*

1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-seventh session the item entitled:

"Macroeconomic policy questions:

- "(a) International trade and development;
- "(b) Commodities;
- "(c) Science and technology for development;
- "(d) External debt crisis and development;
- "(e) International financial system and development;
- "(f) Preparations for the International Ministerial Meeting on Transit Transport Cooperation"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 8th, 11th, 30th and 31st meetings, on 3 and 16 October and on 11 and 12 November 2002.
