### Sustainable development and international economic cooperation

#### Report of the Second Committee\*

1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-seventh session the item entitled:

“Sustainable development and international economic cooperation:

- “(a) Implementation of the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and implementation of the International Development Strategy for the Fourth United Nations Development Decade;
- “(b) Integration of the economies in transition into the world economy;
- “(c) Culture and development;
- “(d) High-level dialogue on strengthening international economic cooperation for development through partnership”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 12th, 13th and 36th meetings, on 17 and 18 October and on 15 November 2002. An account of the Committee’s discussion of the item is contained in the relevant summary records (A/C.2/57/SR.12, 13 and 36). 5. At the 36th meeting, on 15 November, the Director of the New York Liaison Office of the Food and Agriculture Organization of the United Nations made an introductory statement under the item as a whole (see A/C.2/57/SR.36).
