Fifty-seventh session Agenda item 87

Environment and sustainable development

Report of the Second Committee*

Rapporteur: Mr. Walid A. Al-Hadid (Jordan)

1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-sixth session the item entitled:

"Environment and sustainable development:

- "(a) Implementation of Agenda 21 and the Programme for the Further Implementation of Agenda 21;
- "(b) International Strategy for Disaster Reduction;
- "(c) Protection of global climate for present and future generations of mankind;
- "(d) Implementation of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa;
- "(e) Convention on Biological Diversity;
- "(f) Further implementation of the Programme of Action for the Sustainable Development of Small Island Developing States"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 14th to 16th and 33rd to 36th meetings, on 21 and 22 October and from 13 to 15 November 2002.
