# **Report of the Secretary-General on the activities of the Office of Internal Oversight Services**

# I. Introduction

1. At its 19th plenary meeting, on 20 September 2002, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-seventh session the item entitled "Report of the Secretary-General on the activities of the Office of Internal Oversight Services" and to allocate it to the Fifth Committee.

(i) Report of the Office of Internal Oversight Services on the inspection of programme management and administrative practices in the Economic Commission for Latin America and the Caribbean,<sup>9</sup>

(j) Report of the Office of Internal Oversight Services on the audit of the policies and procedures for recruiting staff for the Department of Peacekeeping Operations,<sup>10</sup>

1. *Takes note* of the reports of the Office of Internal Oversight Services listed above;

2. *Requests* the Secretary-General to conduct, through the Office of Internal Oversight Services, a further audit of the policies and procedures for recruiting staff of the Department of Peacekeeping Operations and to report thereon to the General Assembly for its consideration at its resumed fifty-eighth session.

# Enhancing the internal oversight mechanisms in operational funds and programmes

The General Assembly,

*Recalling* paragraph 11 of its resolution 48/218 B of 29 July 1994 and paragraph 15 of its resolution 54/244 of 23 December 1999,

Recalling also its resolution 55/259 of 14 June 2001,

*Having considered* the updated report of the Secretary-General on enhancing the internal oversight mechanisms in operational funds and programmes,<sup>11</sup>

*Having also considered* the report of the Secretary-General containing updated views on enhancing the internal oversight mechanisms in operational funds and programmes,<sup>12</sup> submitted pursuant to paragraph 2 of resolution 55/259,

1. *Takes note* of the recommendations contained in the report of the Secretary-General,<sup>11</sup> and reaffirms the prerogatives of the funds and programmes to decide their own oversight mechanisms and their relationship with the Office of Internal Oversight Services;

2. *Requests* the Secretary-General to submit to the General Assembly recommendations of the Office of Internal Oversight Services that require its approval prior to their implementation.
