Updated financial position of closed peacekeeping missions as at 30 June 2002

Report of the Secretary-General*

Summary

The present report provides information on the updated financial position as at 30 June 2002 for 10 closed peacekeeping missions.

The 10 missions concerned are the Military Observer Group of the United Nations Verification Mission in Guatemala (MINUGUA); the United Nations Mission in Haiti (UNMIH); the United Nations Observer Group in Central America (ONUCA) and the United Nations Observer Mission in El Salvador (ONUSAL); the United Nations Operation in Mozambique (ONUMOZ); the United Nations Operation in Somalia (UNOSOM); the United Nations Preventive Deployment Force (UNPREDEP); the United Nations Protection Force, the United Nations Confidence Restoration Operation in Croatia, the United Nations Preventive Deployment Force and the United Nations Peace Forces headquarters (UNPF); the United Nations Support Mission in Haiti (UNSMIH), the United Nations Transition Mission in Haiti (UNTMIH) and the United Nations Civilian Police Mission in Haiti (MIPONUH); the United Nations Transitional Administration for Eastern Slavonia, Baranja and Western Sirmium (UNTAES) and the Civilian Police Support Group; and the United Nations Transitional Authority in Cambodia (UNTAC).

The actions to be taken by the General Assembly are set out in paragraph 22 of the present report.

I. Introduction

1. The present report provides updated information on the financial position of the following closed peacekeeping missions for which final performance reports have already been issued: the Military Observer Group of the United Nations Verification Mission in Guatemala (MINUGUA); the United Nations Mission in Haiti (UNMIH); the United Nations Observer Group in Central America (ONUCA) and the United Nations Observer Mission in El Salvador (ONUSAL); the United Nations Operation in Mozambique (ONUMOZ); the United Nations Operation in Somalia (UNOSOM); the United Nations Preventive Deployment Force (UNPREDEP); the United Nations Protection Force, the United Nations Confidence Restoration Operation in Croatia, the United Nations Preventive Deployment Force and the United Nations Peace Forces headquarters (UNPF); the United Nations Support Mission in Haiti (UNSMIH), the United Nations Transition Mission in Haiti (UNTMIH) and the United Nations Civilian Police Mission in Haiti (MIPONUH); the United Nations Transitional Administration for Eastern Slavonia, Baranja and Western Sirmium (UNTAES) and the Civilian Police Support Group; and the United Nations Transitional Authority in Cambodia (UNTAC).

II. Military Observer Group of the United Nations Verification Mission in Guatemala

2. The final performance report for the Military Observer Group of MINUGUA was contained in document A/53/775 dated 29 December 1998. The actions taken by the General Assembly in respect of that report were set out in its resolution 53/235 of 8 June 1999.

3. The updated position of the Military Observer Group as at 30 June 2002 is shown in table 1.

VIII. United Nations Protection Force, United Nations Confidence Restoration Operation in Croatia, United Nations Preventive Deployment Force and United Nations Peace Forces headquarters

14. The final performance report for UNPF was contained in document A/54/803 dated 17 March 2000. Updates of the financial position of UNPF were presented in documents A/55/840 dated 19 March 2001 and A/56/852 dated 4 March 2002. The most recent actions taken by the General Assembly in respect of UNPF were set out in its resolution 56/500 of 27 June 2002.

15. The updated position of UNPF as at 30 June 2002 is shown in table 7. It should also be noted that no reimbursement of expenditures amounting to \$127,379,954 incurred by the United Nations Peace Forces for goods and services that should have been provided without cost under the terms of the agreements with the host Governments has been received.

22. **In light of the overall financial situation of the Organization and the fact that assessed contributions to peacekeeping in the amount of \$1.5 billion remain unpaid as at 15 March 2003, the Secretary-General proposes that the return of cash available for credit to Member States be suspended until the financial situation improves in respect of the fund balances of the Military Observer Group of MINUGUA, UNMIH, ONUCA/ONUSAL, ONUMOZ, UNOSOM, UNPREDEP, UNPF, UNSMIH/UNTMIH/MIPONUH, UNTAES/Civilian Police Support Group and UNTAC.**
