Scale of assessments for the apportionment of the expenses of United Nations peacekeeping operations

Implementation of General Assembly resolutions 55/235 and 55/236

Report of the Secretary-General

Summary

In its resolution 55/235, the General Assembly reaffirmed the principles underlying the financing of United Nations peacekeeping operations and adopted a new system of adjustments of the scale of assessments for the regular budget to be used in fixing rates of assessment applicable to peacekeeping operations. This system was based on assigning each Member State to one of 10 levels, using its average per capita gross national product during the period 1993-1998 and other criteria. Also in its resolution 55/235, the Assembly decided on assessment percentages for the Republic of Korea until 2005, as an ad hoc arrangement. In resolution 55/236, it welcomed voluntary movements by a number of Member States to levels higher than would result from the application of the new system.

In its resolution 55/235, the General Assembly also requested the Secretary-General to update the composition of the levels on a triennial basis, in conjunction with the reviews of the scale of assessments for the regular budget, in accordance with the criteria established in the resolution, and to report thereon to the General Assembly. The present report responds to that request and provides information on changes in the peacekeeping levels of Member States based on average per capita gross national income (GNI) during the period 1996-2001. These are based on the same data used by the Committee on Contributions in preparing the scale of assessments that it has recommended to the General Assembly for the period 2004-2006. In preparing this report, the Secretary-General has drawn on his earlier report on the implementation of resolutions 55/235 and 55/236 (A/C.5/55/38), and has also reflected a request from the Republic of Korea.

I. Introduction

1. In its resolution 1874 (S-IV) of 27 June 1963, the General Assembly established certain principles to be applied to the financing of peacekeeping operations. Subsequently, in its resolution 3101 (XXVIII) of 11 December 1973, the Assembly made ad hoc arrangements for the financing of the United Nations Emergency Force (UNEF) based on those principles. These ad hoc arrangements involved basing each Member State's rate of assessment for UNEF on its rate of assessment for the regular budget, as adjusted based on its assignment to one of four groups. Member States in groups C and D had their regular budget rates reduced by 80 and 90 per cent respectively, those in group B paid at the same rate and the permanent members of the Security Council, assigned to group A, paid the difference pro rata to their rates of assessment for the regular budget. This ad hoc formula was applied subsequently, subject to a number of changes over the years to the membership of groups B, C and D.

2. In its resolution 55/235 of 23 December 2000, the General Assembly reaffirmed the general principles underlying the financing of United Nations peacekeeping operations and established a new system of adjustments of regular budget scale rates in establishing Member States' rates of assessment for peacekeeping operations. This system was based on a number of criteria, including a comparison of the average per capita gross national product (GNP) of each Member State during the six-year base period used for preparing the scale of assessments with the corresponding average for all Member States. These criteria, which were set out in paragraph 10 of resolution 55/235, were used to place each Member State in one of 10 levels, from A to J.

3. In its resolution 55/236, also of 23 December 2000, the General Assembly welcomed decisions by a number of Member States to move voluntarily to higher levels than required under the criteria set out in paragraph 10 of resolution 55/235.

4. In his subsequent report on the implementation of General Assembly resolutions 55/235 and 55/236 (A/C.5/55/38), the Secretary-General outlined his understanding of the provisions of the resolutions and how he intended to carry out his responsibilities under resolution 55/235. The present report reflects the understandings outlined in that earlier report. It also reflects a request received from the Permanent Representative of the Republic of Korea.

II. Composition of levels for the financing of peacekeeping operations

5. The initial composition of levels used for establishing rates of assessment for peacekeeping operations for the period 1 July 2001 to 31 December 2003 was listed in the annex to General Assembly resolution 55/235. Permanent members of the Security Council were included in level A. Member States on the list of the least developed countries were included in level J. Specified Member States were included in level C. The placement of other Member States was based on their average per capita GNP during the six-year base period (data for 1993-1998) used for the scale of assessments for 2001-2003 in relation to the average for all Member States. The thresholds applied were set out in the table in paragraph 10 of resolution 55/235. The initial placement of Member States in levels B and D to I was based on

their average per capita GNP for the six-year base period 1993-1998 and the average per capita GNP of all Member States for that period, which was \$4,797.

6. In its resolution 55/5 B of 23 December 2000, the General Assembly decided that the elements used in preparing the scale of assessments for the period 2001-2003 should be fixed until 2006. On this basis, the scale of assessments recommended by the Committee on Contributions for the period 2004-2006¹ also has two base periods, of six (1996-2001) and three (1999-2001) years. Based on the practice adopted by the General Assembly for the current composition of levels, the Secretary-General has used the average data on gross national income (GNI) for the six-year base period, used by the Committee on Contributions in considering the next scale of assessments, when updating the composition of levels for the triennium 2004-2006. As outlined in the report of the Committee on Contributions,² the concept of GNP in the System of National Accounts, 1968 has been renamed GNI in the System of National Accounts, 1993 but this is just a refinement of product and income concepts and does not entail a change in the actual coverage of the concept.

7. The average per capita GNI of the Member States of the United Nations for the six-year base period 1996-2001 was \$5,094. The corresponding thresholds for levels B and D to I are reflected in the table in annex I to the present report. Based on these thresholds, and prior to the application of any phasing or voluntary movements, Argentina would move down from level F to level G, the Bahamas would move up from D to B, Bahrain from E to B, Barbados from F to E, the Czech Republic from I to H, the Libyan Arab Jamahiriya from I to G, Palau from G to E, Saint Kitts and Nevis from H to G, Saudi Arabia from G to F and Slovenia from E to D. In addition, having been added to the list of least developed countries since the adoption of General Assembly resolution 55/235, Senegal would move from I to J and Switzerland and Timor-Leste, which were admitted to the United Nations after the adoption of resolution 55/235, would be added to the list at levels B and I respectively. The table in annex II reflects the initial levels and voluntary and ad hoc movements for the period 2001-2003 (columns 1 and 2), the initial composition of levels for 2004-2006 (column 3), assumed voluntary and ad hoc movements for 2004-2006 (column 4) and the transitional periods (column 5), where appropriate. Based on this information, it also shows the respective percentage of rates of assessment for the regular budget payable by each Member State for peacekeeping operations during 2004-2006 (columns 6 to 10).

8. Based on the provisions of General Assembly resolution 55/235, the movement upwards of the Bahamas, Bahrain, the Libyan Arab Jamahiriya and Palau are subject to the appropriate transitional periods. These have been applied in the manner outlined in the Secretary-General's earlier report (A/C.5/55/38) and are reflected in annex II. In addition, Hungary moved voluntarily to level B, with a five-year transitional period ending on 1 July 2005. As indicated in annex II, Hungary would otherwise come under level I. The continuing application of its transitional period is reflected in annex II.

9. In its resolution 55/235, the General Assembly also decided, as an ad hoc arrangement, to assess the share of the Republic of Korea in the costs of peacekeeping operations at 36 per cent of the regular budget assessment rate from 1 July 2001, 52 per cent in 2002, 68 per cent in 2003, 84 per cent in 2004 and 100 per cent in 2005. In a letter dated 10 July 2003 to the Secretary-General (attached as annex III), the Permanent Representative of the Republic of Korea to the United

Nations conveyed his Government's request that the Republic of Korea be assigned to the lowest level of contribution, with the highest level of discount for which it is eligible on the basis of its per capita GNP for 2004-2006 in the context of the triennial updating of the composition of the peacekeeping levels, pursuant to the general provisions of General Assembly resolution 55/235, paragraphs 9 and 11. That is level D.

10. In view of the position of the Republic of Korea, and since the General Assembly has taken no decision with regard to its placement after 2005, the Secretariat's assumption is that the Republic of Korea should be placed in level D in 2006. As regards its placement in 2004-2005, the General Assembly may wish to consider whether to revisit its earlier decision in paragraph 22 of its resolution 55/235. The two possible approaches are both reflected in annex II.

11. As indicated in General Assembly resolution 55/236, a number of Member States voluntarily moved to levels higher than required by the criteria set out in paragraph 10 of resolution 55/235. As indicated in the Secretary-General's earlier report (A/C.5/55/38), it is the understanding of the Secretariat that the voluntary movement by Turkey to level F was limited to the period until 2003. For the other Member States affected, it is the Secretariat's understanding that for 2004-2006 they should be included at their voluntarily established levels for 2001-2003, unless their revised levels would otherwise be higher or unless they indicate a decision to revert to a lower level for which they are eligible. No such indications have been received from the Member States concerned.

12. In the case of the Czech Republic, its voluntary movement from I to H in 2001-2003 involved its paying at 30 per cent, rather than 20 per cent, of its regular budget rates of assessment. This was due to the provision in resolution 55/235 that those Member States that volunteered to move up to level H would pay at 30 per cent (indicated in annex II as H*), rather than the 20 per cent rate applicable to those initially falling under level H. For the purposes of updating the composition of levels, the Secretariat has assumed that the Czech Republic should continue to be assessed at 30 per cent of its rate of assessment for the regular budget.

III. Rates of assessment for the financing of peacekeeping operations

13. In accordance with the provisions of General Assembly resolution 55/235, the updated composition of levels, reflected in annex II and subject to the Assembly's decision with regard to the placement of the Republic of Korea in 2004-2005, will be used, together with the scale of assessments for 2004-2006, to establish each Member State's peacekeeping rate/s of assessment. The General Assembly will consider the scale of assessments for the period 2004-2006, as well as the request from the Republic of Korea, during its fifty-eighth session. Until it has adopted a new scale, and subject to its decision concerning the request from the Republic of Korea, it will not be possible to determine the corresponding rates of assessment for peacekeeping for the period 2004-2006.

14. For illustrative purposes, however, the tables in annexes IV and V show the peacekeeping rates of assessment (correct to four decimal places) corresponding to the scale of assessments for the period 2004-2006 recommended by the Committee

on Contributions.² In annex IV, the rates for the Republic of Korea are based on paragraph 22 of General Assembly resolution 55/235 and its placement in level D in 2006. Annex V reflects the same parameters, except that the Republic of Korea is placed in level D for the full period 2004-2006.

IV. Conclusions

15. The General Assembly may wish to take note of this report and to consider the request from the Republic of Korea concerning its placement among the 10 peacekeeping levels.

Annex III

Letter dated 10 July 2003 from the Permanent Representative of the Republic of Korea addressed to the Secretary-General

It is my honour to draw your attention to the peacekeeping assessment rates of the Republic of Korea for the period 2004-2006, which will be decided at the fifty-eighth session of the General Assembly.

In its resolutions 55/235 and 55/236, the General Assembly made a number of decisions with regard to the financing of peacekeeping operations in 2001 and beyond. As for the Republic of Korea, it was decided in paragraph 22 of resolution 55/235 to assess, as an ad hoc arrangement, its share in the costs of peacekeeping operations in the following manner: 36 per cent of the regular budget assessment beginning on 1 July 2001, 52 per cent in 2002, 68 per cent in 2003, 84 per cent in 2004 and 100 per cent in 2005.

My Government's agreement to the provision to move the Republic of Korea to level B in five years was based on the expectation that the average per capita gross national product (GNP) of the Republic of Korea for the six-year period 1996-2001 would exceed the threshold for level B. However, the national accounts data compiled on the basis of recent economic statistics show that the average per capita GNP of the Republic of Korea remains below level B.

The General Assembly, in its resolution 55/235, paragraph 15, requested the Secretary-General to update the composition of the 10 levels set out in the resolution on a triennial basis, in conjunction with the reviews of the regular budget scale of assessments, in accordance with the criteria established in the resolution, and to report thereon to the General Assembly.

In this regard, my Government wishes to request that the Republic of Korea be assigned to the lowest level of contribution with the highest level of discount for which it is eligible on the basis of its per capita GNP for 2004-2006 in the context of the triennial updating of the composition of the levels, pursuant to the general provisions of General Assembly resolution 55/235, paragraphs 9 and 11.

My Government's request is fully in accord with the letter and spirit of the provisions of General Assembly resolution 55/235, as well as the fundamental principle of scale of assessments, that is, "capacity to pay".

I should be grateful if you would arrange to have my Government's request duly reflected in your report on updating the composition of the peacekeeping scale levels on a triennial basis, to be submitted to the General Assembly at its fifty-eighth session.
