

Report of the Second Committee*

1. At its 2nd plenary meeting, on 19 September 2003, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-eighth session the item entitled

"Sustainable development and international economic cooperation:

- "(a) Women in development;
- "(b) Human resources development;
- "(c) International migration and development;
- "(d) Implementation of the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and implementation of the International Development Strategy for the Fourth United Nations Development Decade"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on sub-items (a), (b) and (c) at its 9th and 10th meetings, on 14 October 2003, and on sub-item (d) at its 11th meeting, on 15 October. An account of the Committee's discussion of the item is contained in the relevant summary records (A/C.2/58/SR.9-11). Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, from 6 to 9 October (see A/C.2/58/SR.2-6).
