

Section 21 Economic and social development in Latin America and the Caribbean

(Programme 17 of the medium-term plan for the period 2002-2005)

Overview

- 21.1 The Economic Commission for Latin America and the Caribbean (ECLAC) is responsible for the implementation of programme 17 of the revised medium-term plan for the period 2002-2005.
- 21.2 The terms of reference of ECLAC were adopted by the Economic and Social Council in its resolution 106 (VI) and subsequent amendments.
- 21.3 Since the mid-1990s, ECLAC has implemented a programme of institutional development which has included updating the Commission's mission statement, improving priority-setting and strategic planning, streamlining both its organizational structure and the functioning of subsidiary intergovernmental forums and improving collaboration and coordination with global United Nations bodies, the Bretton Woods institutions and regional organizations.
- 21.4 The formulation of this proposed programme budget reflects a broad review process of the Commission's work programme in line with the Secretary-General's call to present to the General Assembly a thoroughly revised programme budget that will better reflect the priorities of the Millennium Summit. This process started in ECLAC with a self-assessment exercise carried out by its top management to take stock of the provisions of the Millennium Declaration and adjust the current activities of the Commission accordingly.
- 21.5 ECLAC is currently participating, and will continue to actively take part in the work of the coordinating mechanism of the Executive Committee on Economic and Social Affairs, entrusted by the Secretary-General to provide strategic direction to participating entities, to identify complementarities in their respective work programmes and promote synergies in common undertakings, including the formulation of the medium-term plan and the programme budget. In this context, the current budget submission has benefited from mutual consultation among entities of the Executive Committee to enhance the orientation of their work programmes while avoiding duplications and overlapping.
- 21.6 The biennial programme of work of ECLAC for 2004-2005 was discussed in detail and adopted by member States during the twenty-ninth session of the Commission, convened in Brasilia in May 2002. The work programme was reviewed again in the light of General Assembly resolution 57/300 of 20 December 2002 on Strengthening of the United Nations: an agenda for further change, and the related report of the Secretary-General (A/57/387 and Corr.1). The review focused on identifying the provisions of the Millennium Development Goals and targets that had a more concrete bearing on the work programme of ECLAC. As a result, 37 outputs of marginal utility, consisting mainly of servicing of meetings and non-recurrent publications which had been previously approved as part of the programme of work of the Commission for the biennium 2004-2005 pursuant to ECLAC resolution 589 (XXIX), are proposed to be deleted (see annex).
- 21.7 The streamlining of the work programme, which is an ongoing process at ECLAC, and the fuller application of the logical framework in the context of results-based budgeting have resulted in a sustained trend towards a reduction in the number of outputs, excluding technical cooperation activities, which has decreased from 655 in the 2000-2001 biennium to 567 in the biennium 2002-2003 to 521 in the biennium 2004-2005.

- 21.8 In line with the general orientation and thrust of the revised medium-term plan for the period 2002-2005 and the contents of the Millennium Declaration, ECLAC intends to emphasize three priority areas during the biennium 2004-2005:
 - (a) Equity and poverty reduction policies in the region, including ways to maximize the social effects of economic development patterns. ECLAC understands this objective as referring not only to extreme poverty (for which a specific target is included in the Millennium Declaration) but also to alternative definitions of absolute and relative poverty, as well as improved income distribution and gender equity;
 - (b) National policies, as well as regional and international cooperation mechanisms, aimed at improving the links between economic and social development in the region and the current globalization process. This will include support for international negotiations in which countries of the region are involved;
 - (c) Links between economic and environmental strategies aimed at mainstreaming sustainable development concerns into economic development policies and patterns.
- As an integral part of these efforts and in collaboration with other agencies in the relevant fields, ECLAC follows up directly the regional dimensions of the outcomes of the World Summit on Sustainable Development, the World Summit for Social Development, the Fourth World Conference on Women, the International Conference on Population and Development, the World Assembly on Ageing, the United Nations Conference on Human Settlements, the Global Conference on the Sustainable Development of Small Island Developing States and the International Conference on Financing for Development, and it is involved in organizing the regional conference in preparation for the World Summit on the Information Society. As part of this process, it will concentrate its activities during the biennium 2004-2005 on developing a common system and a database for the regional follow-up to all United Nations conferences, including those related to the Millennium Development Goals.
- 21.10 In the upcoming biennium, ECLAC will consolidate and reinforce its outreach activities. Special emphasis will be placed on the dissemination of its outputs through the institutional web site, a consolidated publications strategy and improved press coverage.
- 21.11 The programme's main expected accomplishments and indicators of achievement for the biennium 2004-2005 are detailed, together with required resources, under the programme of work and under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 21.1.

- 21.12 The overall resources budgeted under this section amount to \$76,099,100, including a resource growth of \$2,888,600 or 3.9 per cent. The growth reflected in table 21.4 can be summarized as follows:
 - (a) The decrease of \$11,500 under policy-making organs relates to reduced requirements for travel of staff to service meetings of ECLAC intergovernmental bodies.
 - (b) The increase of \$100,400 under executive direction and management relates to: (i) the inward redeployment of one Local level post to strengthen the clerical support services in the Office of the Deputy Executive Secretary (\$74,800); and (ii) non-post resource requirements of \$25,600 relating to additional resources for general temporary assistance to replace staff members on sick or maternity leave or during periods of increased workload and for travel of staff, offset in part by reduced requirements for consultants, experts and contractual services.
 - (c) The net increase of \$989,900 under programme of work includes: (i) an increase of \$808,800 for posts as follows: full funding for two P-3 and two P-2 posts established in the 2002-2003 biennium; establishment of one new P-4 post to be deployed at ECLAC subregional headquarters in Mexico City (see subprogramme 11) for a focal point for the evaluation and vulnerability reduction of natural disasters, in response to mandates that emanated from the twenty-ninth session of the Commission and recommendations of the Office of Internal Oversight Services; establishment of one new P-2 post, the functions of which will include, inter alia, conducting studies and preparing research papers on sustainable development issues, for subprogramme 8; reclassification of one Local level post to the P-3 level for subprogramme 2, resulting from appeal actions to the initial reclassification exercise of local level posts in Santiago carried out by the Office of Human Resources Management in 1995; and (ii) a net increase of \$181,100 for non-post requirements relating to additional resources for general temporary assistance to replace staff members on sick or maternity leave or

- during periods of increased workload, offset in part by reduced requirements for consultants and experts and travel of staff.
- (d) A net increase of \$1,809,800 under programme support which includes: (i) an increase of \$472,600 for posts as follows: full funding for nine Local level posts established in the 2002-2003 biennium for the Security and Safety Unit; establishment of one new P-4 post to provide for a computer systems officer in the Electronic Information Section at ECLAC headquarters to strengthen the technical capabilities of that Section in response to the additional requirements imposed by legislative mandates; reclassification of three Local level posts to the P-2 level for the Electronic Information Section resulting from appeal actions to the initial reclassification exercise of local level posts in Santiago carried out by the Office of Human Resources Management in 1995; reclassification of one Field Service post to the P-4 level to strengthen the ability of the Financial Services Section to provide professional support deriving from the implementation of the Integrated Management Information System; and (ii) a net increase of \$1,337,200 for non-post requirements relating mainly to additional resources for contractual services, general operating expenses, supplies and materials, and furniture and equipment, offset partially by reduced requirements for general temporary assistance.
- 21.13 The creation of a 100-series D-1 post financed from available extrabudgetary resources is proposed for a Director for the Latin American and Caribbean Institute for Economic and Social Planning, in response to the latest resolution emanating from the twelfth session of the Regional Council for Planning, the Institute's policy-making body.
- 21.14 During the biennium 2004-2005, projected extrabudgetary resources amounting to \$17,154,800 will supplement resources from the regular budget to finance outputs consisting mostly of comparative case studies, technical advice, sharing of experiences and lessons learned among member countries, and the convening of technical seminars and training courses. These estimates are based on the following factors: (a) the level of preparedness of ECLAC member countries to actively collaborate with the individual ongoing and future projects; (b) a careful account of the likelihood of yearly donor contributions for each individual ongoing or future project; and (c) the actual capacity of the Commission's staff to carry out these projects substantively and operationally, keeping in mind the desired balance of activities to be undertaken with regular and extrabudgetary financing.
- 21.15 Recent macroeconomic disequilibria and currency devaluations affecting Latin American and Caribbean countries, some of which are net contributors of extrabudgetary funding for the Commission, are likely to result in a reduction of the extrabudgetary technical cooperation programme in the biennium 2004-2005 as compared with the bienniums 2000-2001 and 2002-2003. However, the Commission estimates that traditional donors mainly European Governments and Canada may maintain or eventually increase their share of contributions. In addition, ECLAC has initiated actions to broaden the range of bilateral donors beyond its traditional sources. Regarding multilateral sources, some of these donors have shown signals of increasing interest in collaborating in common undertakings involving substantive areas of the work programme to which ECLAC member countries have granted high priority. In this connection, some are already financing projects of relevance for the region or are actively taking part in conversations with officials of the Commission in order to enhance this type of collaboration in the near future.
- 21.16 ECLAC has undertaken an in-depth review of its publications programme, resulting in an overall reduction in the number of recurrent and non-recurrent publications, as summarized below.

A. Policy-making organs

Resource requirements (before recosting): \$1,126,100

Economic Commission for Latin America and the Caribbean

21.18 The Commission is composed of 41 members and 7 associate members and meets biennially to provide overall direction to the work of the secretariat. Its biennial meeting scheduled for the first half of 2004 in Santiago is estimated to last five days. Pursuant to ECLAC resolution 553 (XXVI), an ad hoc Advisory Committee composed of member State representatives meets periodically to provide the Commission with guidance in defining its priorities regarding the substantive outputs of its approved programme of work.

Committee of the Whole

21.19 The Committee of the Whole will meet in plenary session in New York for a three-day period in 2005 to hold discussions on issues of concern to the Commission. The Committee meets during the years when the Commission is not in session.

Presiding Officers of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean and Ninth Regional Conference on Women

21.20 The Presiding Officers provide overall direction to the work of the secretariat on issues related to the integration of women into development in the region, in accordance with paragraph 88.2 of the Plan of Action for the Integration of Women into the Economic and Social Development of Latin America and the Caribbean. The Presiding Officers will meet on three occasions in the coming biennium: its 37th and 39th meetings are proposed to be held in Santiago in 2004 and 2005 and its 38th meeting is proposed to be held in Quito in 2005. A meeting of the Ninth Regional Conference on Women is proposed to be held in Mexico in 2004.

Committee of High-level Governmental Experts

21.21 The Committee of High-level Governmental Experts is a subsidiary organ of the Commission that acts as a forum devoted to the analysis of various aspects of the implementation and appraisal of development strategies in Latin America and the Caribbean. The Committee meets annually. One meeting is scheduled to be held in New York in 2004 and one in Santiago in 2005.

Caribbean Development and Cooperation Committee

21.22 The Caribbean Development and Cooperation Committee coordinates all activities related to subregional development and cooperation. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues concerning the Caribbean. The Committee will meet annually in the biennium 2004-2005.

Committee on Central American Economic Cooperation

21.23 The Committee on Central American Economic Cooperation provides overall coordination and direction to the secretariat in relation to activities to promote the integration of national economies in Central America. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues related to the Central American region and as a subsidiary organ of the Commission. The Committee will meet annually during the biennium 2004-2005: one meeting is scheduled to be held in Mexico City in 2004 and the other in Panama in 2005.

Presiding Officers of the Regional Council for Planning, Latin American and the Caribbean Institute for Economic and Social Planning

21.24 The meetings of the Presiding Officers of the Regional Council for Planning are scheduled to be held in Mexico City in 2004 and in Brasilia in 2005. The meeting constitutes an intergovernmental forum of the Ministers of Planning to develop the work programme of the Latin American and Caribbean Institute for Economic and Social Planning and provides a venue for the secretariat of ECLAC to discuss development strategies.

Executive Committee of the Statistical Conference of the Americas

- 21.25 The Executive Committee of the Statistical Conference of the Americas was established at the same time as the Statistical Conference of the Americas during the twenty-eighth session of the Commission (see resolution 580 (XXVIII)). It meets annually to provide support for the Statistical Conference of the Americas. The main responsibilities of the Executive Committee are: to prepare a biennial programme of regional and international cooperation concerning statistical matters to be presented to the regular conference; to follow up on the implementation of the agreements and the tasks assigned by the Conference; and to decide on the substantive documentation to be presented to the Conference.
- 21.26 The next meetings of the Executive Committee as mandated by ECLAC resolution 580 (XXVIII) will be held in Santiago in 2004 and in Madrid in 2005.

Statistical Conference of the Americas

- 21.27 The Statistical Conference of the Americas was approved as a subsidiary organ of ECLAC at the twenty-eighth session of the Commission (see resolution 580 (XXVIII)).
- 21.28 The Conference meets on a biennial basis with the objectives of promoting the development and improvement of national statistics and their international comparability, strengthening cooperation among national statistical offices and international and regional agencies, and preparing a biennial programme of regional and international cooperation to meet the demands of the countries of the region in the field of statistics.
- 21.29 The next meeting of the Conference will be held in Santiago in 2005.

21.30 The amount of \$1,126,100, for policy-making organs, reflecting a decrease of \$11,500, provides for the servicing of the meetings of ECLAC intergovernmental bodies. The decrease relates to reduced requirements for travel of staff to service such meetings.

B. Executive direction and management

Resource requirements (before recosting): \$4,383,700

21.31 The Office of the Executive Secretary provides overall direction, supervision and management to the ECLAC secretariat with a view to implementing the legislative mandates and the approved programme of work. It continues to be responsible for the preparation of a biennial institutional substantive report on the main topics to be discussed at the session of the Commission, as well as for the publication of the CEPAL Review.

- 21.32 In addition, the Office will provide direction and policy orientation and will establish the criteria to coordinate the implementation of and follow-up to the Millennium Development Goals and other cross-cutting issues, such as gender mainstreaming and sustainable development, in all the substantive subprogrammes.
- 21.33 The Programme Planning and Operations Division, on behalf of the Executive Secretary, will continue to provide advice, overall substantive coordination and guidance to ECLAC subprogramme managers on the formulation of the proposed medium-term plan of ECLAC and its revisions, the preparation of the draft programme of work and the report of the work of the Commission for presentation to and adoption by the biennial session of the Commission, as well as the preparation of the programme budget proposals for the biennium and the subsequent budget performance reports.
- 21.34 The Division will also undertake the substantive monitoring of the implementation of the work programme and the preparation of the biennial programme performance report. Similarly, it will organize, coordinate and report on the programme self-evaluation cycle of ECLAC system and will provide contributions to in-depth evaluation exercises of United Nations programmes. In addition, the Division will continue to provide substantive servicing to and prepare relevant documentation for the meetings of the Ad Hoc Working Group established pursuant to ECLAC resolution 553 (XXVI) with the purpose of carrying out priority-setting exercises for the programme of work and provide strategic guidance to the Commission on institutional and policy issues. The Division will also continue coordination, development, updating and maintenance operations of the ECLAC official web site and subsites; the coordination, guidance and supervision of the ECLAC extrabudgetary technical cooperation programme and its relevant fund-raising activities, and the work of the ECLAC library in Santiago for which resources are provided under programme support.
- 21.35 The Office of the Executive Secretary includes the Information Services Unit. The activities of the Unit are carried out in Santiago, in close coordination with the Department of Public Information at Headquarters and include: organizing press conferences and issuing press releases, producing and disseminating booklets and information kits about the work of ECLAC and the United Nations, placing opinion pieces in the region's media, producing and editing a bimonthly newsletter and attending to journalists and the general public.

- 21.36 During the biennium, the following outputs will be delivered:
 - (a) Servicing of intergovernmental and expert bodies (regular budget/extrabudgetary):
 - (i) Substantive servicing of meetings: secretariat services and substantive support to the sessions of the Commission and its subsidiary bodies (1);
 - (ii) Parliamentary documentation: report on the main topic to be discussed at the thirtieth session of the Commission (1);
 - (b) Other substantive activities (regular budget):
 - (i) Recurrent publications: CEPAL Review (6);
 - (ii) Electronic, audio and video issuances, including films, videotapes, radiobroadcasts, news tapes, documentaries and feature programmes:
 - a. Transmission of news dispatches to Headquarters for inclusion in United Nations radio programmes and to radio stations throughout the region (average of 50 per year);
 - b. Videotapes of interviews and other activities for inclusion in United Nations programmes and for distribution to the media throughout the region (average of 3 per year);
 - c. Photographic coverage of ECLAC meetings and activities (average 35 per year);
 - (iii) Exhibits, guided tours, lectures:
 - a. Exhibits and other visual material on United Nations activities (average 35 per year);
 - b. Organizing guided tours of ECLAC premises in Santiago (average 6 per year);
 - c. Briefings and organization of activities related to United Nations/ECLAC events and special observances (average 20 per year);
 - (iv) Booklets, pamphlets, fact sheets, wall charts, information kits:
 - a. Monthly newsletter "Notas de la CEPAL/ECLAC Notes" (6 issues in Spanish and 6 in English each year);
 - b. Responses to public inquiries about the United Nations in oral and written form (average 8,000 per year);



21.87 The amount of \$3,317,200 provides for 27 posts. The amount of \$237,800 for non-post requirements provides for general temporary assistance (for which additional resources of \$5,700 are proposed to cover replacements during sick or maternity leave and during periods of increased workload), for consultants and experts and for travel of staff.

Subprogramme 11 Subregional activities in Mexico and Central America

Resource requirements (before recosting): \$6,367,600

- 21.88 The work under this subprogramme will be carried out by the ECLAC subregional headquarters in Mexico. The programme of work has been formulated by drawing upon subprogramme 11 of programme 17 of the revised medium-term plan for the period 2002-2005.
- 21.89 A new subject area on natural disasters is formally presented for the first time as an element of the work programme although ECLAC has in the past made well-known methodological contributions and provided technical cooperation in this area for affected countries. The subprogramme will therefore enhance its work to assess the socio-economic and environmental effects of natural disasters in the region with the aim of contributing to the formulation of policies which incorporate those elements and will encourage regional cooperation in the area of risk reduction and vulnerability. In implementing the activities of the subprogramme, special account will be taken of relevant provisions of the Millennium Development Goals, in particular Goal 1: Eradicate extreme poverty and hunger, Goal 3: Promote gender equality and empower women, Goal 7: Ensure environmental sustainability, and Goal 8: Develop a global partnership for development.

21.92 The amount of \$5,949,900 for posts includes an increase of \$212,100 relating to: (a) establishment of one new P-4 post, to serve as the ECLAC focal point for disaster evaluation and vulnerability reduction; the functions will be dedicated to coordinating all work programme activities in the ECLAC system related to the assessment of socio-economic effects of natural disasters on the countries of the region; and (b) inward redeployment of one Local level post from programme support to strengthen the research support capabilities of the subprogramme. The amount of \$417,700 for non-post requirements provides for other staff costs, consultants and experts and for travel of staff. The increase of \$24,100 is the net result of increases under general temporary assistance (\$26,500) and under consultants (\$7,000), offset by a decrease of \$9,400 under travel of staff.

- 21.94 In implementing the activities, special account will be taken of relevant provisions of the Millennium Development Goals, in particular Goal 1: Eradicate extreme poverty and hunger, Goal 3: Promote gender equality and empower women, Goal 7: Ensure environmental sustainability, and Goal 8: Develop a global partnership for development, in particular target 14: address the special needs of landlocked countries and small island developing States (through Programme of Action for the Sustainable Development of Small Island Developing States and the provisions of the General Assembly).

D. Programme support

Resource requirements (before recosting): \$33,337,400

21.98 The activities carried out under programme support comprise conference services, library services, management of technical cooperation activities and administration and common services.

- 21.99 During the biennium 2004-2005, the following outputs will be delivered:
 - (a) Conference services. The activities are carried out by the Documents and Publications Division in Santiago and the Editorial, Documents and Conference Services Unit in Mexico City. The main activities relate to: (i) the provision of conference services for meetings of the policy-making organs of ECLAC and other intergovernmental meetings held under its auspices; (ii) the translation, interpretation, editing, verbatim reporting, publications programme, distribution of ECLAC publications; and (iii) for collaboration with the United Nations Sales Unit in the commercial distribution of United Nations publications;
 - (b) Library services. Library services are provided for ECLAC staff members and external users by the libraries at Santiago and Mexico City. Activities include the publication of bulletins and bibliographies; the provision of services for remote users via the Internet; the United Nations depository library in Chile; the establishment of agreements and cooperation with other libraries in the subregion; dissemination of the substantive documentation of ECLAC; processing of external bibliographic resources and information in support of the substantive activities of the Commission in the subregion; disseminating the Micro-ISIS programme throughout the subregion and advising libraries and information centres on its installation and operation; providing technical assistance and organizing courses on the use of Micro-ISIS; answering reference queries; publication of bulletins and bibliographies on paper and through electronic means; and updating daily the section of ECLAC web page pertaining to the Library;

- Management of technical cooperation activities. The activities are carried out by the Project Management and the Extrabudgetary Resource Mobilization Units of the Programme Planning and Operations Division. The ECLAC technical cooperation programme is formulated to supplement the regular budget resource allocation. It is geared to strengthening and expanding the economic and social research agenda and to the application of research findings to the provision of advisory services and training for the benefit of ECLAC member States. It plays an active role in integrating substantive activities financed from extrabudgetary funds with those financed from the regular budget. It also aims at maintaining a mutually supporting balance between substantive research and operational activities. The anticipated outputs during the biennium are as follows:
 - (i) Publication of reports on the activities carried out by the ECLAC system to support and/ or promote technical cooperation among developing countries at the regional, subregional and national levels; institutional arrangements for technical cooperation activities existing in developing member States of ECLAC; operational activities carried out in the region to promote interregional cooperation;
 - (ii) Advisory services to Governments and/or regional institutions in the identification and/or elaboration of technical cooperation programmes and project proposals, to be implemented at the regional, national or interregional level;
 - (iii) Coordination with the technical cooperation focal points in other regional commissions for the promotion of interregional cooperation activities;
 - (iv) Consultations with other regional organizations that carry out technical cooperation in Latin America and the Caribbean to identify priorities to be included in the regional programme;
 - (v) Collaboration with substantive units in the ECLAC system and subregional offices, for the preparation and implementation of projects to promote and support components related to technical cooperation among developing countries in the ECLAC programme of work;
 - (vi) Assessment of damage caused by natural disasters in the region using ECLAC methodology;
 - (vii) Formulation of projects for rehabilitation and reconstruction following natural disasters, in close consultation with concerned Governments;
 - (viii) Formulation of specific projects for prevention and mitigation of potential damage caused by natural disasters;
 - (ix) Assistance to Governments in the identification of technical and cooperation demands and opportunities and in the preparation of project proposals;
 - (x) Preparation of project agreements and proposals in accordance with the operational and financial rules and procedures established by the contributing organization, institution or Government and by the United Nations;
 - (xi) Preparation of budgets for extrabudgetary activities;
 - (xii) Monitoring project implementation;
 - (xiii) Administration of extrabudgetary funds in close collaboration with the substantive units responsible for the implementation of such projects;

Administration and common services. The main activities of the Division of Administration at ECLAC Santiago are: (a) the overall management and coordination of administrative services, policy formulation and the establishment of managerial and administrative guidelines at ECLAC; (b) human resources management, which encompasses recruitment, placement and career development of staff, staff administration and classification, maintenance of the classification system for General Service posts established under ST/AI/410, the internship programme, medical and employee assistance, general advice and individual counselling; (c) budget formulation and control through preparation of biennial programme budgets and budget performance reports, budgeting and monitoring of approved budgets and staffing table control; (d) financial management and control through the establishment of procedures for the control and maintenance of regular and extrabudgetary funds, implementation of financial regulation and rules and financial reporting and accounting, including treasury services; (e) general support services, including communications and transportation; procurement, facilities management and maintenance, archives and records management; (f) planning and coordinating the implementation and administration of IMIS in the ECLAC system; (g) security and safety through ground surveillance and key control and by operating a security and safety control centre (h) language training at all ECLAC duty stations (excludes training activities funded and directed by the Training Service in New York); and (i) Electronic Information activities carried out by the Electronic Information Section in consultation with the ECLAC Information Management Committee, whose main activities are to advise the Executive Secretary on policy formulation for the automation processes in the ECLAC system, including the allocation of material and financial resources; provide technical advice and support services to substantive areas, ensuring the appropriate functioning of the ECLAC automation platform including the web site, Internet and IMIS services; supervise the maintenance services of ECLAC's computer hardware and ensure the security of ECLAC's information systems.

21.100 The amount of \$22,601,000 provides for 226 posts and reflects a net increase of \$472,600 resulting from: (a) full funding for nine local level posts established in the 2002-2003 biennium for the Security and Safety Unit; (b) the establishment of one new P-4 post in the Electronic Information Section for a computer systems officer; (c) outward redeployment of three Local level posts as follows: (i) one from the Division of Administration to the Office of the Deputy Executive Secretary; (ii) one from the Documents and Publications Division to subprogramme 6; and (iii) one from the Administration Section of the Mexico office to subprogramme 11; (d) the reclassification of one Field Service post to the P-4 level in the Division of Administration, for a finance officer. The post was originally approved to head the Communications Unit, but in the light of changed

requirements which emanated from technological developments, there is a greater need for specialized staff in the Financial Services Section as a result of IMIS implementation, as ECLAC is in the process of extending IMIS operations to its subregional headquarters and national offices, and specialized professional support with a combination of both experienced accounting and technological background is required; (e) the reclassification of three Local level posts to the P-2 level as a result of the initial classification exercise of all General Service posts at ECLAC Santiago conducted by the Office of Human Resources Management during the year 1995. The reclassifications concern one programme technician to develop and maintain computerized management and information systems, install, debug and modify software and other programs and assist in all matters related to systems management; and two computer systems officers to analyse, design and program computer systems, generate, install and maintain operating systems and evaluate, install and maintain software packages; and (f) abolition of one Local level post.

21.101 The amount of \$10,736,400 for non-post requirements reflects a net increase of \$1,337,200 for (a) contractual services for external printing and binding of various official documentation and publication of ECLAC and adoption of standard software licence for e-mail and collaborative applications for ECLAC; (b) general operating expenses to cover rental of premises, rental and maintenance of data-processing equipment and other equipment, maintenance of furniture and equipment, utilities charges, communications costs; (c) supplies and materials to cover expendable office supplies and library books; and (d) furniture and equipment for acquisition of office automation equipment.

In its decision 57/564, the General Assembly took note of the report of the Secretary-General (A/57/364) on trends in extrabudgetary resources at ECLAC and the impact on its capacity to carry out the programme of work. In his report, the Secretary-General informed the General Assembly of the need to keep under review the level of extrabudgetary resources available to ECLAC. As mentioned in the overview to this section recent macroeconomic disequilibria and currency devaluations affecting Latin American and Caribbean countries, some of which are net contributors of extrabudgetary funding for the Commission, are likely to result in a reduction of the Extrabudgetary Technical Cooperation Programme in the biennium 2004-2005 as compared with the bienniums 2000-2001 and 2002-2003. However, the Commission estimates that traditional donors mainly

European Governments and Canada, may maintain or eventually increase their share of contributions.

Advisory Committee on Administrative and Budgetary Questions (A/56/7, Chapter II)

The number and relevance of these expected accomplishments and indicators of achievement should be reviewed in the context of the preparation of the proposed programme budget for the biennium 2004-2005, and efforts should be made to draft them in a clearer, more concise manner (para. V.57).

In July 2002, a total of 142 ECLAC staff members carrying out managerial and substantive tasks were trained in datacollection strategies for results-based budgeting. During the current budget preparation exercise, ECLAC management has provided orientation and worked jointly with all subprogramme managers in further developing the logical framework for each area, particularly fine-tuning expected accomplishments, indicators of achievement and improving the baseline data. As a result, it is expected that both the contents and language of the submission will have been significantly improved.

The estimate for programme support amounts to During the current biennium, ECLAC finalized 47 per cent of the total estimate and IMIS has not been extended to the subregional or national offices. The Committee requests the Secretariat to study the matter and to provide the necessary assistance with a view to extending IMIS, where experienced assistance from the IMIS and appropriate and cost-effective, to the subregional Accounts Division conversion team. an assessment of needs for hardware and software at the two ECLAC subregional headquarters (in Mexico City and Port-of-Spain) and also of the required specialized and issues and a detailed implementation schedule is currently under discussion with Headquarters Accounts Division. IMIS implementation in Mexico City and Port-of-Spain is tentatively scheduled for the first half of 2003.


With regard to videoconferencing facilities, the Committee recommends that ECLAC explore the feasibility of utilizing United Nations information centres, UNDP regional offices and other United Nations system offices as venues for setting up videoconferencing facilities for communication between the Commission and member States or between different United Nations entities (para. V.62).

Progress in this area has been slow mainly due to technical restrictions and also high telephone rates affecting some of the countries of the region. ECLAC will nevertheless continue to monitor developments in this area with a view to implementing the recommendation.

The Advisory Committee recommends that ECLAC undertake an analysis of the impact of its publications in the course of the biennium 2002-2003. The analysis should focus on the
