Section 4

Disarmament

(Programme 2 of the medium-term plan for the period 2002-2005)

Overview

- 4.1 General and complete disarmament under strict and effective international control remains the ultimate goal of all efforts exerted in the field of disarmament. The main responsibilities for disarmament lie with Member States. The United Nations, in accordance with its Charter, has a central role and primary responsibility in supporting Member States in this area. The Department for Disarmament Affairs, headed by an Under-Secretary-General, is responsible for the implementation of the programme.
- 4.2 The activities for which the Department for Disarmament Affairs is responsible fall within the framework of programme 2, Disarmament, of the medium-term plan for the period 2002-2005, as revised. The mandate for the programme derives from priorities established in General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly devoted to disarmament (resolution S-10/2). The programme is also guided by the United Nations Millennium Declaration (resolution 55/2). While, weapons of mass destruction, in particular nuclear weapons, continue to be the primary concern, the Organization will also continue its work in the field of conventional disarmament.
- 4.3 Accordingly, for the biennium 2004-2005, the Department will continue to facilitate the process of multilateral deliberation and negotiation. It will assist Member States in promoting, strengthening and consolidating multilaterally negotiated principles and norms in all areas of disarmament. Attention will also be given to efforts of Member States in the area of disarmament and non-proliferation in order to help maintain international peace and security and to contribute to global efforts against terrorism. The Department will promote and facilitate the implementation of the Programme of Action adopted at the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, as well as practical disarmament measures. It will also promote transparency and confidence-building measures and will expand its outreach activities, including through its web site, to ensure the flow of impartial and factual information to the public. The Department will implement disarmament and non-proliferation and education programmes, and will continue to encourage the exchange of information on and experience in disarmament and security-related matters among organizations of the United Nations system, Member States, other intergovernmental organizations, regional organizations and non-governmental organizations, and to enhance interaction and cooperation on such matters. It will also assist Member States in promoting regional approaches to disarmament and security, including through the regional centres for peace and disarmament. It will continue to contribute to efforts to enhance disarmament expertise in Member States, particularly developing countries.
- 4.4 The Department will seek to achieve the objectives of the programme by providing substantive organizational support to deliberative and negotiating bodies and their subsidiary bodies, as well as review conferences, other meetings of States parties to multilateral agreements on disarmament and related matters and expert groups assisting the Secretary-General in undertaking disarmament studies. This will include monitoring and assessing current and future trends in the field of disarmament and international security.
- 4.5 Training and advisory services will continue to be provided, through the United Nations disarmament fellowship, training and advisory services programme and the United Nations Institute for Disarmament Research, to Member States, in particular developing countries, to

enhance their expertise in disarmament, with a view to participating more effectively in international deliberating and negotiating forums. The Department will also assist Member States in increasing their understanding of the relationship between disarmament and development.

- 4.6 The Department carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including treaty organizations, intergovernmental, interregional, regional and national organizations, non-governmental organizations, academic communities, etc. Such cooperation includes the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.
- 4.7 Gender mainstreaming will continue to be built into the activities of the programme through the implementation of a gender plan of action aimed at raising awareness, commitment and capacity for gender mainstreaming in disarmament affairs. This will include encouraging Member States to nominate more female candidates for expert groups, the disarmament fellowship programme and other meetings and events organized by the Department, as well as focusing on gender perspectives in the area of disarmament.
- 4.8 The programme's main accomplishments and indicators of achievement for the biennium are detailed, together with the required resources, under the programme of work, as well as under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 4.1.

- 4.9 The overall level of resources for the Department for Disarmament Affairs for the biennium 2004-2005 amounts to \$16,658,600, at 2002-2003 rates, reflecting growth for this priority programme of \$837,500 (5.2 per cent). The growth is due primarily to the establishment of three new posts in the Professional category (1 D-1, 1 P-5 and 1 P-3) and two new General Service (Other level) posts which will greatly strengthen web page operations, regional implementation of the programme and contributions to the global effort against terrorism in respect of weapons of mass destruction.
- 4.10 The Secretary-General, in his report entitled "Strengthening the United Nations: an agenda for further change", proposed that publication of the *Repertory of Practice of United Nations Organs* should no longer be done by the United Nations (see A/57/387, para. 83 and action 10 (a)). Accordingly, no provisions are made in the proposed programme budget for 2004-2005 for its coordination and preparation.

- 4.11 The extrabudgetary estimated resources, amounting to \$5,735,400, include an amount of \$2,421,700 for the trust fund for the United Nations Institute for Disarmament Research (UNIDIR), and \$570,000 for the United Nations Fund for International Partnerships (UNFIP). Programme support includes an amount of \$108,200 under UNIDIR and UNFIP for the convening of workshops, seminars and symposiums, information and outreach activities and activities of the three regional disarmament centres.
- 4.12 Resource allocation between the subprogrammes of the Department has been carefully reviewed to ensure that priority needs are met. As a consequence, subprogrammes 2, 4 and 5, Weapons of mass destruction, Monitoring, database and information and Regional disarmament, respectively, are being strengthened relative to the rest of the Department. Growth in Executive direction and management is largely the delayed impact of growth in 2002-2003, while the Programme support area will be slightly diminished.
- 4.13 The issuing of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized below and as distributed in the output information for each subprogramme.

A. Policy-making organs: Conference on Disarmament**Resource requirements (before recosting): \$45,000**

- 4.15 The Conference on Disarmament was set up in accordance with paragraph 120 of the Final Document of the Tenth Special Session of the General Assembly (resolution S-10/2) as the single multilateral disarmament negotiating forum of the international community. Following the

expansion of its membership in 1996 and 1999, the Conference is open to the five nuclear-weapon States and 61 other States, including all militarily significant States. In addition, some 40 non-member States are invited, upon their request, to participate in its work. The Conference on Disarmament conducts its work by consensus, adopts its own rules of procedure, rotates its presidency among all members on a monthly basis, adopts its own agenda taking into account the recommendations made to it by the Assembly and the proposals presented by the members of the Conference and submits a report to the Assembly annually, or more frequently, as appropriate. The Conference divides its 24-week annual session into three parts and, if necessary, continues its negotiations on priority issues between sessions. Meetings thus take place during seven to nine months each year.

- 4.16 Pursuant to paragraph 120 (c) of the Final Document, the Secretary-General, following consultations with the Conference on Disarmament, appoints the Secretary-General of the Conference, who also acts as his or her personal representative, to assist the Conference and its presidents in organizing the Conference. As requested by the General Assembly in its resolution 34/83 L of 11 December 1979, the Secretary-General provides staff, as well as the assistance and services needed by the Conference on Disarmament and any subsidiary bodies that it might establish, in accordance with the arrangements contained in its rules of procedure. The secretariat of the Conference consists of officers of the secretariat of the Conference on Disarmament and the Conference Support Branch (Geneva) of the Department for Disarmament Affairs.
- 4.17 The Conference on Disarmament successfully concluded the negotiations of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (1992), as well as the Comprehensive Nuclear-Test-Ban Treaty (1996), with the participation of all five nuclear-weapon States and other militarily significant States. The Conference is currently conducting a comprehensive review of the priorities in the contemporary international disarmament agenda in order to reach an agreement on a programme of work, which will include deliberations and negotiations on a number of disarmament issues on its agenda.

- 4.18 The non-post resources provide for the travel of the Secretary-General of the Conference of Disarmament and the Personal Representative of the Secretary-General to attend the fifty-ninth and sixtieth sessions of the General Assembly and other consultations and meetings hosted at Headquarters.

B. Executive direction and management

Resource requirements (before recosting): \$2,477,600

- 4.19 Executive direction and management of the programme consists of the Office of the Under-Secretary-General and the Office of the Director.

4.20 The Office of the Under-Secretary-General is responsible for the implementation of the programme of work, as well as for the overall direction, supervision and management of the Department, including its financial and administrative activities. The Under-Secretary-General provides the Secretary-General with advice and support on all disarmament and related security matters, represents him in that respect as required and provides authoritative analysis and assessment of developments in the field of disarmament and international security for policy guidance and decision-making purposes.


4.21 The amount of \$2,385,400 will continue to provide for nine posts, the delayed impact of growth of new posts approved for 2002-2003 and the regularization of a temporary exchange of posts undertaken in the biennium 2002-2003, resulting in the transfer of one P-5 post in exchange for one P-4 post. The non-post resources will continue to cover general temporary assistance and travel of staff.

Subprogramme 1

Multilateral negotiations on arms limitation and disarmament

Resource requirements (before recosting): \$3,691,800

- 4.22 The subprogramme will be implemented by the Conference on Disarmament secretariat and Conference Support Branch in Geneva, which will continue to provide substantive and organizational support to the Conference on Disarmament, and to the conferences and meetings of States parties to multilateral arms limitation and disarmament agreements. The Branch will assume additional responsibilities that include serving as focal point in Geneva for landmine issues and issues related to small arms and light weapons. The Branch will also assist Member States, in particular developing countries, in enhancing expertise in the field of arms limitation and disarmament through the United Nations fellowship, training and advisory services programme. The end-users of this subprogramme are Member States, States parties to multilateral disarmament agreements, intergovernmental organizations and institutions involved in arms limitation and disarmament.

- 4.23 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment will be supportive of disarmament efforts; (b) political developments relating to international peace and security will be conducive to facilitation of negotiations of new arms limitation and disarmament agreements; (c) negotiating parties will exercise a necessary degree of flexibility and accommodation in addressing their respective security concerns; (d) Member States will be willing to implement recommendations; and (e) national institutions will be supportive of gender balance issues.

 - (iii) Development and maintenance of the web page of the Conference on Disarmament;
 - (iv) Maintenance of cooperation with research institutes working in the field of arms limitation and disarmament, in particular, with UNIDIR; maintenance of the web page of the Geneva Branch;
 - (v) Provision of informational materials and substantive input at seminars on arms limitation and disarmament and briefings on issues under negotiation in the Conference on Disarmament; provision of substantive and administrative services to successive presidents of the Conference on Disarmament, in order to ensure continuity in the Conference's work, given the rotating nature of its presidency;
- (c) Technical cooperation (regular budget):
- Training courses, seminars and workshops: implementation of the United Nations Disarmament Fellowship, Training and Advisory Services Programme: maintenance and updating of training material; study visits (International Atomic Energy Agency, the Organization for the Prohibition of Chemical Weapons, the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization, and Member States at their invitation); training sessions for up to 30 fellows (the Conference on Disarmament in Geneva and the First Committee in New York).

4.25 The amount of \$1,963,600 will provide for the continuation of nine posts, including five in the Professional and above category and four General Service posts. The non-post resources will provide for travel of staff and furniture and equipment, as well as for a reduced level of general temporary assistance.

Subprogramme 2 Weapons of mass destruction

Resource requirements (before recosting): \$2,268,200

- 4.26 The Weapons of Mass Destruction Branch is responsible for the implementation of the subprogramme and will carry out activities related to weapons of mass destruction, in particular nuclear weapons, as mandated by Member States. The end-users of this subprogramme are Member States, States parties to multilateral disarmament agreements and intergovernmental organizations and institutions involved in the area of weapons of mass destruction, in particular nuclear weapons. During the biennium 2004-2005, while no significant changes to the nature of work of the subprogramme are anticipated, additional mandates derived from the General Assembly have been included, in particular with regard to providing assistance to efforts in the area of disarmament and non-proliferation, in order to help maintain international peace and security and to contribute to global efforts against terrorism.

- 4.29 The amount of \$1,696,800 will provide for the continuation of seven posts augmented by two additional posts, the establishment of 1 new P-5 post and 1 new General Service post. The posts would strengthen the capacity of the Weapons of Mass Destruction Branch by providing for a Deputy Chief who would also serve as Secretary of Conferences related to agreements concerning weapons of mass destruction. The post would have responsibility for implementation of the recommendations of the Policy Working Group concerning terrorism in the area of weapons of mass destruction. The non-post growth relates largely to the work of the Panel of Governmental Experts on the Issue of Missiles in All Their Aspects, and will provide for consultants and experts and travel of staff.

Subprogramme 3 Conventional arms (including practical disarmament measures)

Resource requirements (before recosting): \$2,322,600

- 4.30 The Conventional Arms Branch is responsible for the implementation of the subprogramme and will carry out all activities related to conventional weapons. The primary areas to be covered are small arms and light weapons, including the operation of the mechanism of the Coordinating Action on Small Arms; practical disarmament measures; transparency in reporting international arms transfers and national military expenditures; and disarmament and development, as well as emerging trends and other conventional disarmament issues. The adoption of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects by the United Nations Conference in July 2001 has generated new responsibilities for the subprogramme.
- 4.31 The end-users include Member States, departments and agencies within the United Nations system dealing with conventional disarmament issues, particularly small arms and light weapons, regional and subregional bodies, civil society, specialized non-governmental organizations and research institutes.

- 4.34 The amount of \$1,924,600 will provide for the continuation of nine posts. The non-post resources, reflecting a reduction of \$261,900, will provide for consultants, travel of staff and maintenance to enable the office to carry out the activities described above. Resources for travel of representatives (\$207,700) are discontinued as a result of the completion of work by the group of governmental experts examining the feasibility of developing an international instrument to identify and trace illicit trade in small arms and light weapons.

Subprogramme 4 Monitoring, database and information

Resource requirements (before recosting): \$2,451,600

- 4.35 The subprogramme is implemented by the Monitoring, Database and Information Branch, which will continue to provide objective, impartial and up-to-date information on multilateral disarmament issues and activities to its end-users: Member States, States parties to multilateral agreements, intergovernmental organizations and institutions, departments and agencies of the United Nations system, research and educational institutions, civil society, especially non-governmental organizations, the media and the general public.
- 4.36 Outreach activities carried out under this subprogramme cover all aspects of multilateral disarmament, with emphasis on the Department's substantive priority areas of weapons of mass destruction and conventional weapons, particularly small arms and light weapons. The Branch will continue to carry out information and education activities in coordination with the other branches and departments, most notably the Department of Public Information, as well as with civil society

organizations, especially non-governmental and academic organizations. In the light of the endorsement by the General Assembly at its fifty-seventh session of the recommendations of the 2002 United Nations study on disarmament and non-proliferation education, special focus will be devoted to disarmament and non-proliferation education activities. Furthermore, the subprogramme is increasingly exploiting the electronic medium for dissemination and exchange of information, especially by developing specialized web pages.

- 4.39 The amount of \$1,867,500 will provide for the continuation of eight posts augmented by the establishment of two additional (1 P-3 and 1 General Service) posts. The resources under non-posts will enable the office to carry out the activities described above. The two new posts are required for handling information technology matters. In particular the P-3 staff member would be

responsible for the Department’s web site design, development, coordination, evaluation and training of staff. The incumbent of the proposed new General Service post would serve as information and systems assistant responsible for electronic hardware and software upgrading, troubleshooting and the monitoring of applications developed by the Branch.

**Subprogramme 5
Regional disarmament**

Resource requirements (before recosting): \$2,328,900

- 4.40 It has been generally recognized that regional disarmament could play a vital role in promoting and enhancing international efforts towards global disarmament. Accordingly, this subprogramme is aimed at promoting and strengthening regional and subregional initiatives, with a view to promoting and strengthening international peace and security.
- 4.41 The subprogramme will be implemented by the Regional Disarmament Branch at Headquarters, the Regional Centre for Peace and Disarmament in Africa (Lomé), the Regional Centre for Peace and Disarmament in Asia and the Pacific (Kathmandu) and the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean (Lima).

- 4.42 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment will be supportive of disarmament efforts; (b) Member States will be willing to implement recommendations; (c) extrabudgetary funding will be pledged and contributed on time (this factor may prove to be critical in the light of apparently falling contributions to the regional centres); and (d) national institutions will be supportive of gender-mainstreaming issues.

- 4.44 The amount of \$1,793,500 will provide for the continuation of eight posts, augmented by the establishment of a new D-1 for the Chief of the Regional Branch, and it would also provide for general temporary assistance. The proposed new post is needed to strengthen the capacity of the Branch in providing the required level of coordination for regional activities, including the work of the regional centres. The D-1 staff member would coordinate and supervise the implementation of mandates on issues related to regional disarmament, would ensure cohesiveness in the implementation of regional activities throughout the Department for Disarmament Affairs, between the Department and other departments and offices and between the Department (United Nations) and outside entities. The non-post resources will enable the office to carry out the activities described above. Growth in these resources relates to two activities of the Standing Advisory Committee on Security Questions in Central Africa.

D. Programme support

Resource requirements (before recosting): \$1,072,900

- 4.45 The Executive Office provides support services to the Department for Disarmament Affairs in connection with personnel, budgetary and financial administration, resource planning and use of common services, together with administrative support to policy-making organs and other meetings, as required.


- 4.46 The amount of \$592,400 provides for the continuation of three posts. The non-post resources, reflecting a reduction of requirements, relates mainly to general operating expenses and furniture and equipment. However, the component of general temporary assistance would be reduced as a result of the discontinuation of the *Repertory of Practice of United Nations Organs*.
