

# Section 20 Economic development in Europe

(Programme 16 of the medium-term plan for the period 2002-2005)

# **Overview**

- 20.1 The programme is under the responsibility of the Economic Commission for Europe (ECE).
- 20.2 The programme of work to be carried out by the Commission in the biennium 2004-2005 is in conformity with the overall objectives of the revised medium-term plan for the period 2002-2005. In line with the role of the regional commissions as set forth in Economic and Social Council resolution 1998/46 of 31 July 1998, as well as with the goals and commitments contained in the United Nations Millennium Declaration, the World Summit on Sustainable Development Plan of Implementation and the Monterrey Consensus, the main objectives of ECE will be: (a) to foster sustainable development in the countries of the region, with a focus on promoting the conditions for sustained growth and trade, improving the environment and increasing the security of the people; and (b) to promote the economic integration of ECE countries in the context of post-European Union enlargement and taking into account the various stages of development of ECE transition economies (acceding countries, emerging market economies and less advanced transition economies).
- 20.3 The overall ECE programme of work is designed around nine interdependent and complementary subprogrammes: Environment, Transport, Statistics, Economic analysis, Sustainable energy, Trade development, Timber, Human settlements and Industrial restructuring and enterprise development. Its implementation is achieved through studies and policy analysis and supporting statistics; the negotiation of conventions, norms and guidelines; the organization of policy debates and exchange of experiences; and the provision of technical assistance.
- 20.4 In the biennium 2004-2005, the analytical work of ECE will aim at producing analyses that are more policy and issue-oriented, so as to offer a good basis for policy debates among member States. In this context, it will be reoriented in two directions, namely to analyse the progress made in achieving sustainable development, the Millennium Development Goals and other internationally agreed development goals relevant to the region, including ageing and the gender perspective; and to analyse the changing economic context of the ECE region, viz. European Union enlargement and the evolving economic cooperation between the European Union and non-acceding countries, as well as cooperation among the latter. This will be reflected in particular in the introduction of workshops on the implications of European Union enlargement and in a new recurrent publication on sustainable development.
- 20.5 These analyses will be supported by statistics on countries of the region. A new area of activities will consist of selecting and gathering data for indicators relating to internationally agreed development goals. This will focus on the indicators for the Millennium Development Goals and sustainable development, as well as for ageing and the gender dimension, which are the most relevant for the region. It will lead to regional monitoring of the achievement by ECE countries of the key objectives set and commitments made at the major global United Nations conferences. Furthermore, work in this area will strengthen the coordination of statistical work in the region and will make available its experience and coordinating approach to other regions and at the global level.
- 20.6 The work in developing conventions, norms and standards will be mainly carried out in three subprogrammes, namely Transport, Environment and Trade development. Its focus will be to

promote the ratification of these instruments throughout the region and their effective implementation in countries with economies in transition in order to improve their integration both in the region and with the rest of the world. A new impulse will be given to globalizing some of these agreements and standards, in particular in the areas of transport, trade facilitation and environmental decision-making. ECE will also focus on the development of interlinkages, both among conventions in a given sector and between conventions relating to complementary sectors.

- 20.7 Policy debates and exchange of experiences will be strengthened in all subprogrammes. A major objective will be to foster policy dialogue among North America and the European Union, the acceding countries, the other emerging economies and the less developed countries of the region, in the context of post-enlargement Europe. A series of seminars on the consequences of European Union enlargement for non-European Union countries are therefore planned in the Sustainable energy, Trade development, Transport and Environment subprogrammes. Furthermore, new activities corresponding to issues emerging from recent global conferences will be undertaken, such as the promotion of renewable energy (Sustainable energy subprogramme), corporate governance and promotion of the e-economy (Industrial restructuring and enterprise development subprogramme) and social housing (Human settlements subprogramme).
- 20.8 Post-European Union enlargement technical assistance will be streamlined and focused on Southeast Europe and the Commonwealth of Independent States (in particular Central Asia). A unifying strategy to identify the needs of these countries and to determine activities responding thereto will be adopted with a two-fold objective of (a) increasing the chances of the least advanced countries of benefiting from the expected further deepening economic integration of Europe; and (b) avoiding new economic disparities and divisions within the region. Technical assistance will be demand-driven, results-oriented, evaluated and, where appropriate, carried out in cooperation with other organizations. It will be provided for both individual countries and groups of countries. An improved mechanism for prioritizing technical assistance will be put in place for the new biennium.
- 20.9 New emphasis will be placed on cross-sectoral issues and intersectoral linkages. In line with the role assigned to the regional commissions at the World Summit on Sustainable Development, a systematic effort will be made to mainstream the three dimensions of sustainable development into the ECE subprogrammes. In addition to this core approach, the annual organization of a sustainable development event that would address specific issues calling for joint consideration of economic, social and environmental aspects, and that would provide the opportunity for a region-wide debate among policy makers and other actors from the three constituencies, is envisaged. Apart from sustainable development, gender and information and communications technologies are two other cross-sectoral concerns that will be further mainstreamed in the various ECE subprogrammes. As for intersectoral linkages, the focus will be placed on transport, environment and health; energy and environment; transport and energy; transport and trade; and trade and environment.
- 20.10 ECE will cooperate with other international organizations active in Europe, in particular regional institutions and subregional groupings. This cooperation will provide a broader framework for exchanging views among organizations on issues of particular concern to the countries of the region and ensure consistency in technical assistance from different organizations. Cooperation among the United Nations organizations active in the ECE region will be strengthened mainly through the regional coordination meetings convened by ECE and by gathering the Heads of the European offices of these organizations. Such meetings will aim at achieving a common understanding of the development needs in the region, agreeing on the corresponding priorities of work, improving the division of labour and considering undertaking joint programmes and activities. Cooperation between the regional and global levels will also be strengthened by ensuring the provision of regional perspectives to issues addressed by global bodies. This will

apply particularly to the area of sustainable development where ECE activities will be closely coordinated with the corresponding activities of the Commission on Sustainable Development.

- 20.11 ECE partnerships with the business community and non-governmental organizations will be further strengthened and extended, particularly in the preparation of regional strategies, plans and programmes, the implementation of norms and standards and other technical assistance activities, all of which contributes to the achievement of the overall objectives of ECE.
- 20.12 In order to introduce changes into the ECE programme of work along the directions mentioned above, a number of activities have been streamlined. This is reflected mainly in the fact that the proposed number of meetings has been cut by 20 per cent, compared to the biennium 2002-2003. Across different subprogrammes, ECE will make more use of small informal expert groups and task forces to prepare the technical inputs and draft decisions for formal intergovernmental bodies, thus allowing the number of formal meeting sessions to decrease. Furthermore, in the area of environment, after the successful conclusion of a cycle of negotiations of a number of protocols to environmental instruments will be reduced. With regard to publications, their number will substantially decrease in the new biennium. Following an internal review, a number of recurrent publications have been dropped and others converted to non-recurrent publications. The reduction, reflected in table 20.1 below, is also owing to a decision to increase the dissemination of information to the public through electronic means both for recurrent and non-recurrent publications.

- 20.13 In addition, a number of initiatives within the ECE secretariat will be developed, such as: (a) improved consultations among member States for regular adjustments of ECE activities to new needs and emerging issues, through better linkages between the Commission, its principal subsidiary bodies, the Group of Experts on the Programme of Work and the Steering Group; (b) regular reviews of the ECE intergovernmental structure, covering the formal subsidiary bodies, as well as the issue-specific and time-bound expert groups established by those bodies; (c) similar reviews of meetings and reports by the concerned bodies, with a view to reducing their length and number; (d) procedures for planning and streamlining ECE publications, setting quality standards and improving their dissemination; (e) better prioritization of technical cooperation; and (f) a comprehensive set of measures for increasing information and communication technology support to ECE activities with a view to improving their cost-effectiveness and visibility.
- 20.14 As required under the Plan of Action adopted by ECE member countries in April 1997, all ECE principal subsidiary bodies have prioritized their respective programme of activities. The Group of Experts on the Programme of Work reviewed the programmes of work of the principal subsidiary bodies and made their recommendations, which were endorsed by the Commission in December 2002. These recommendations were taken into account in finalizing the programme budget proposal.

20.15 The programme's main expected accomplishments and indicators of achievement for the biennium 2004-2005 are detailed, together with required resources, under the programme of work, as well as under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 20.2.

- 20.16 Resource requirements for the biennium 2004-2005 under this section amount to \$44,874,700 reflecting an increase of \$1,075,900 (or 2.4 per cent). The main components of the increase could be summarized as follows:
  - (a) An increase of \$167,800 under executive direction and management as a result of:
    - (i) The delayed impact of the P-5 post established in the biennium 2002-2003 (\$136,300);
    - (ii) Increased requirements for consultants and experts (\$5,200) in order to meet the growing demand on ECE to organize global conferences and events, and travel (\$35,000) in order to enable the Office of the Executive Secretary to carry out more effectively its functions and to meet the continually increasing demands to participate in global, regional and subregional events, particularly in countries with economies in transition;
    - (iii) A reduced requirement for contractual services (\$8,700);
  - (b) An increase of \$570,600 under programme of work as a result of:
    - (i) An increase of \$607,600, under posts, reflecting the establishment of a new P-4 post under the subprogramme on transport, in order to provide the secretariat and expert support to meetings of the World Forum for Harmonization of Vehicle Regulations and to maintain and update the Compendium of Candidate Regulations for Harmonization and Registry for Global Regulations; the establishment of a new P-3 post in the new subprogramme 9, Industrial restructuring and enterprise development; the reclassification from the P-3 to the P-4 level of one post dealing with agricultural standards in subprogramme 6, Trade development, and of one post in subprogramme 8, Human settlements for the Secretary of the Committee on Human Settlements, and servicing the Working Party on Land Administration; and the delayed impact of the two P-2 posts established in the biennium 2002-2003 under subprogramme 3, Statistics, and the P-4 post under subprogramme 2, Transport;

- (ii) An increase of \$22,400, under travel of staff, in order to meet the increased demand for participation in meetings in Eastern Europe, the Caucasus and Central Asian member countries, and in order to provide sufficient resources to the newly established subprogramme 9, the United Nations Office at Geneva;
- (iii) A decrease of \$38,500 under other staff costs and contractual services, due to the redeployment to programme support of general temporary assistance (\$16,700) under subprogramme 2, Transport, and to the reduced requirement for external printing under various subprogrammes (\$21,800), as the Commission expects to make greater use of the printing facilities of the United Nations Office at Geneva;
- (iv) A decrease of \$10,500, under consultants and experts, which is the net result of minor increases and decreases under various subprogrammes;
- (v) A decrease of \$10,400, under supplies and materials, owing to the redeployment to programme support of the provision for subscriptions through the Dag Hammarskjöld Library Consortium that are shared with other subprogrammes and centrally managed by the Executive Office;
- (c) An increase of \$337,500 under programme support, largely for information and communication technology-related items, is the net result of:
  - (i) An increase of \$149,200, under posts, reflecting the establishment of a new General Service (Other level) post in lieu of outsourced services for a help desk assistant for the whole Commission previously provided by the International Computing Centre and funded under "grants and contributions"; and the reclassification from the P-3 to the P-4 level of a post in the Coordinating Unit for Operational Activities of the ECE secretariat, as the responsibilities of the Unit have been extended;
  - (ii) An increase of \$16,500, under other staff costs, as resources are being redeployed from subprogramme 2, Transport, in order to centralize the requirements for general temporary assistance for the entire Commission;
  - (iii) An increase of \$5,200, under consultants to provide specialized expertise on regional or subregional cross-sectional issues in the Technical Cooperation and Management Unit;
  - (iv) An increase of \$36,400, under supplies and materials, representing the redeployment of resources from subprogramme 4 for database subscriptions, as well as additional resources requested to meet increased charges from the United Nations Office at Geneva, which changed its practice from charging for only non-stock items to charging ECE fully for supplies;
  - (v) An increase of \$314,200, under furniture and equipment, is required for acquisition replacement for electronic data-processing equipment. The increase is requested to replace approximately 75 per cent of the personal computers of the Commission, which will become obsolete in the biennium 2004-2005, 50 per cent of its monitors and regular replacement programmes for other office automation equipment and for acquisition and replacement costs for software;
  - (vi) A decrease of \$2,800 under travel of staff;
  - (vii) A decrease of \$25,100, under general operating expenses, as a result of joining an umbrella maintenance contract for office automation equipment managed by the United Nations Office at Geneva;

- (viii) A decrease of \$156,100, under grants and contributions due to the establishment of a new General Service (Other level) post for help desk services, which was previously budgeted under contributions to the International Computing Centre, and reduced reimbursement for services provided by the International Computing Centre.
- 20.17 The amount of extrabudgetary resources at \$15,696,300 for the biennium 2004-2005 represents 26 per cent of the total resources available to this programme. These resources will be utilized to supplement resources from the regular budget, primarily to finance the organization of workshops, seminars and symposiums for the countries in the region, particularly in countries with economies in transition; to support the implementation of the conventions on the environment adopted within the framework of ECE; to support cooperative agreements signed by various ECE member States on transport; and to share best practices and stimulate contacts in various other areas of the programme of work.
- 20.18 The percentage distribution of resources under this section would be as shown in table 20.3.

- 20.19 Unlike for other regional commissions, resources for administration and conference and general services for ECE are not included under its own programme budget. They are included in a consolidated fashion under section 27E, Administration, Geneva, in respect of administration and general services, and under section 2, General Assembly affairs and conference services, in respect of conference-servicing costs. They are thus administered by the United Nations Office at Geneva in an integrated fashion.
- 20.20 In order to permit a comparison among regional commissions while, at the same time, maintaining the advantages of integrated management and avoiding duplication of effort, the estimated resources (at current rates) to be provided by the United Nations Office at Geneva to ECE for administrative, conference and general services during the biennium 2004-2005 are summarized below:

# A. Policy-making organs

- 20.21 The Commission, which reports to the Economic and Social Council, provides the work of the secretariat with overall direction. It meets annually for three or four working days, supplemented by ad hoc informal half-day sessions every three months. It has seven principal subsidiary bodies: the Committee on Environmental Policy (subprogramme 1, Environment); the Inland Transport Committee (subprogramme 2, Transport); the Conference of European Statisticians (subprogramme 3, Statistics); the Committee on Sustainable Energy (subprogramme 5, Sustainable energy); the Committee for Trade, Industry and Enterprise Development (subprogramme 6, Trade development and subprogramme 9, Industrial restructuring and enterprise development); the Timber Committee (subprogramme 7, Timber); and the Committee on Human Settlements (subprogramme 8, Human settlements). These bodies meet from two to three days annually to provide guidance to ECE on work relating to their respective sectors.
- 20.22 The Group of Experts on the Programme of Work meets every two years in the third quarter of the year prior to the preparation of the programme budget submission to provide the Commission with recommendations on possible adjustments and shifts in the ECE programme of work. In the course of the biennium, it also meets to take up specific issues as requested by the Commission and to review various aspects of the ECE programme of work.
- 20.23 The Steering Group, established in 2001 and consisting of the ECE Bureau, chairpersons of all the principal subsidiary bodies, the Executive Secretary and the ECE directors, meets at least once a year during the annual session of the Commission. It provides views and advice on priorities and strategic directions of ECE work, especially on cross-sectoral and intersectoral issues.

## **B.** Executive direction and management

#### Resource requirements (before recosting): \$3,527,900

20.24 In order to fulfil its responsibilities in terms of executive direction and overall management of ECE, functions of the Office of the Executive Secretary include: feeding the policy debate on the strategic directions of ECE and developing a forward-looking strategy for adjusting ECE activities to respond to emerging and foreseeable needs and priorities of its member States; coordinating the ECE programme of work and prepare the medium-term plan and the programme budget; and providing guidance and leadership for the implementation of all ECE subprogrammes; ensuring efficient and inclusive processes for the planning, monitoring and evaluation of the subprogrammes in accordance with the objectives of the medium-term plan and the programme budget; developing intersectoral activities; providing the governing bodies of ECE with support: servicing meetings of the Commission and its Bureau, including submission of reports to the Commission; providing an interface between the Bureau of the Commission and the bureaux of the principal subsidiary bodies; and ensuring follow-up to decisions of the Commission; providing support to the

Group of Experts on the Programme of Work and the Steering Group; ensuring the implementation of the directives of the Secretary-General; ensuring and reporting on the implementation of the resolutions and decisions of the General Assembly and the Economic and Social Council that are relevant to the work of ECE; organizing regional events and/or providing regional contributions related to the preparation of and follow-up to United Nations global conferences and events, in accordance with the ECE role as a regional outpost of the United Nations, pursuant to Economic and Social Council resolution 1998/46; cooperating and coordinating with other international organizations and institutions active in the region, both within and external to the United Nations; this includes the United Nations inter-agency coordination meetings and their follow-up; involving the business community, academic institutions, local authorities and non-governmental organizations in ECE activities, as appropriate, and obtaining their support for implementation of those activities; fostering relationships with member Governments, with a view to making ECE activities and achievements more widely known and used; fostering gender mainstreaming in ECE subprogrammes and responding to requests from Headquarters in this area, including contributing to activities at the global level where a regional perspective and input are needed; providing guidance and directions for the work of the secretariat: adjustment to new demands, increased transparency, improved interdivisional cooperation, improved process for budget preparation and human resource management greater consistency in applying the Performance Appraisal System (PAS), issuance of guidelines and directives for the substantive divisions of the secretariat; and clearance of the documentation prepared for the principal subsidiary bodies of ECE.

20.25 The Office of the Executive Secretary includes an Information Unit which comprises one P-4 post and one General Service (Other level) post and, inter alia, works to increase the visibility of ECE through the dissemination of information about the products and activities of the Commission to the public at large, the ECE membership and other potential users. Such dissemination is carried out through various channels, such as contact with the media and the Internet.



The increase under non-post resources is the net result of an increased requirement for consultants and experts and travel, and is partially offset by a reduced requirement for contractual services.

  - (vi) Seminars for outside users: workshops on topics to be selected in the following areas: the contribution of transport to trade and development in the ECE region; and trade and infrastructure-related transport issues in post-enlargement Europe (2);

  - (iii) Field projects: within the framework of this project, ECE, in close cooperation with the Economic and Social Commission for Asia and the Pacific, will focus on assisting Eastern and South-East European, Caucasus and Central Asian member countries in the promotion and development of Euro-Asian transport links; ECE is the executing agency for the trans-European motorway project, which will continue to assist its member countries in accelerating the construction of the trans-European motorway network through: (a) the identification of investment needs and priorities, investigation of the financial resources needed for its construction and determination of appropriate payback systems; (b) assistance in the designing, building, maintaining, operating and administering the trans-European motorway network on the territories of participating countries as part of an integrated European transport infrastructure; (c) paying special attention, in view of present economic constraints, to the upgrading of existing roads and to the staged construction of motorways; (d) promoting and improving cooperation in all matters concerning road transport between trans-European motorway countries with different levels of development; and (e) disseminating the knowledge, expertise and know-how developed so far in the trans-European motorway region to other regions of the world. The project is financed through a Trust Fund Agreement; the trans-European railway project will continue to examine infrastructural and organizational problems in the rail sector, as well as possibilities for the improvement of the current situation in rail transport in the countries of Central and Eastern Europe through investment and organizational measures. This will include consideration of combined transport, border crossing and train path allocation. ECE serves as the executing agency for the project, which is financed through a Trust Fund Agreement.

20.34 The increase under posts is the net result of the establishment in 2004-2005 of one new P-4 post to provide secretariat and expert support to meetings of the World Forum for Harmonization of Vehicle Regulations and also to maintain and update the Compendium of Candidate Regulations for Harmonization and Registry for Global Regulations, and of the delayed impact of the P-4 post established in the biennium 2002-2003.     - (iv) Operation and coordination of the Integrated Management Information System-related functions within ECE;
  - (c) Conference services:
    - (i) Establishment and management of the ECE programme of meetings, related documentation, facilities and services required in close coordination with Conference Services at Geneva; arrangements for ECE meetings hosted outside Geneva by member Governments; and informal meetings held outside Geneva within the context of the ECE programme of workshops for countries with economies in transition;
    - (ii) Preparation and organization of the annual session of the Economic Commission for Europe, its quarterly ad hoc informal meetings and required documentation and meetings services;

- (iii) Preparation and administration of the programme of publications;
- (d) Programme budget and accounts:
  - (i) Preparation of the biennial programme budgets and financial performance reports in liaison with the Office of Programme Planning, Budget and Accounts;
  - (ii) Financial control and certification of all accounts in cooperation with the Financial Resources Management Service at the United Nations Office at Geneva;
  - (iii) Administration of technical cooperation activities and extrabudgetary resources;
- (e) Human resources management:
  - (i) Administration of staff, including recruitment, placement and career development, in coordination with the Human Resources Management Service of the United Nations Office at Geneva and the Office of Human Resources Management at Headquarters;
  - (ii) Identification of staff training needs, including the provision of training to upgrade professional skills and in-house training in computer applications and arrangements for appropriate courses in cooperation with the Staff Development and Learning Service at the United Nations Office at Geneva;
  - (iii) Staff-management relations in the context of the ECE Sectoral Assembly and elected staff representatives;
- (f) Technical cooperation management:
  - Provision of support for priority setting of technical cooperation, taking into account the needs and requests for technical assistance in transition economies, particularly South-East Europe, the Caucasus and Central Asia;
  - (ii) Coordination of and support to operational activities undertaken by ECE divisions, including by the regional advisers, based on the above priority setting process;
  - (iii) Carrying out of regular consultations with subregional country groupings and initiatives in order to respond efficiently to the needs of countries with similar problems and concerns;
  - (iv) Supporting multisectoral technical assistance programmes in subregions and providing servicing and advice to their governing bodies, such as the Regional Advisory Committee of the Special Programme for the Economies of Central Asia;
  - Monitoring of the implementation of technical cooperation activities undertaken within the cooperative agreements of ECE and the subregional country groupings and initiatives;
  - (vi) Evaluation of technical assistance activities in a results-based perspective and ensuring of the exchange of experiences among subprogrammes in this respect;
  - (vii) Fund-raising in cooperation with ECE divisions and regional advisers;
  - (viii) Reporting on ECE operational activities to the Commission at its annual sessions.

20.65 The overall increase in programme support reflects in very large part net additional resources for information and communications technologies-related items. The increase under posts reflects the establishment of a new General Service (Other level) post in lieu of outsourced services for a help desk assistant for the whole Commission previously provided by the International Computing Centre and funded under grants and contributions; and the reclassification from the P-3 to the P-4 level of a post in the Coordinating Unit for Operational Activities, as the responsibilities of the Unit have been extended. The increase in non-post resources is the net result of a number of increases and decreases under various objects of expenditure, the main increase relating to acquisition and replacement of electronic data-processing equipment (\$314,200) and the main decrease relating to reduced requirement under grants and contribution (\$156,100).



## **Advisory Committee on Administrative and Budgetary Questions** (A/56/7, chap. II)

The Advisory Committee requested the Commissions, in close consultation with the Director of the Budget Division, to examine how the current presentation of expected accomplishments and indicators of achievement of section 18 could be modified in the light of the logical framework for the results-based budgeting techniques for the biennium (V.48). Workshops on results-based budgeting implementation were conducted by the Programme Planning and Budget Division for ECE in June and July 2002. The presentation of expected accomplishments and indicators of achievement has consequentially been developed beyond those presented in the medium-term plan for the period 2002-2005 and the proposed programme budget for the biennium 2002-2003 to provide more concrete and specific material which is more susceptible to measurement, as shown by the new performance measures provided.

Regional commissions should exchange information on best practices regarding the preparation, promotion and sales of publications (V.49).	The Executive Secretaries of the Regional Commissions discussed the matter of publications at their meeting held on 18 July 2002 and exchanged information on how publications are handled in each commission. The total number of ECE publications is being reduced from 284 to 154.
With regard to dissemination of information and communication, the Committee requested the Commission to discuss, in the context of the semi-annual meetings of the Executive Secretaries of the commissions, the feasibility of initiating a project whereby regional United Nations information centres, United Nations Development Programme regional offices and other United Nations system offices could be used as venues to set up videoconferencing facilities for communication between the commissions and member States, or between different United Nations entities (V.50).	The Executive Secretaries discussed the use of videoconferencing at their meeting held on 26 September 2002 for regular consultations among themselves. At the meeting, doubts were expressed about the feasibility of organizing such exchanges through videoconferencing owing to local technical problems which did not yet allow for simultaneous connections among the commissions. They did not discuss the feasibility of initiating the referenced project.
