

Status of the signature and ratification of the Arab Convention for the Suppression of Terrorism

- A. The Convention was adopted within the framework of the League of Arab States by a decision of the Council of Arab Ministers of Justice and the Interior at their joint meeting held on 22 April 1998 at the headquarters of the General Secretariat of the League in Cairo.
- B. The Convention has been signed by the Arab Ministers of Justice and the Interior of all the Arab Member States.

The Convention has been deposited with the Secretariat of the United Nations and listed in General Assembly documents A/54/301 of 3 September 1999, A/55/179 of 26 July 2000 and A/56/160 of 9 March 2001 in the section on the status of international legal instruments on the prevention and suppression of international terrorism.
