**Annex to the letter of 28 May 2004 from the Permanent Representative of Cuba to the United Nations addressed to the Secretary-General**

On 27 May 2004 the Republic of Cuba ratified the Comprehensive Safeguards Agreement with the International Atomic Energy Agency.

With the ratification of this Agreement, which was signed on 18 September 2003, Cuba has once more demonstrated its determination to fulfil all its obligations as a State party to the Nuclear Non-Proliferation Treaty (NPT) and the Treaty for the Prohibition of Nuclear Weapons in Latin America (Tlatelolco Treaty).

On the same date, 27 May 2004, Cuba ratified the Additional Protocol to the Comprehensive Safeguards Agreement, thereby providing a clear demonstration of its firm commitment to multilateralism and its political will to help achieve general and complete disarmament, including nuclear disarmament, under strict international control.

Cuba hereby reaffirms its unwavering commitment to nuclear disarmament and its determination to continue to do all in its power to achieve the total eradication of nuclear weapons from the face of the earth.
