## I. INTRODUCTION

1. The Conference on Disarmament submits to the fifty-ninth session of the United Nations General Assembly its annual report on its 2004 session, together with the pertinent documents and records.

## II. ORGANIZATION OF WORK OF THE CONFERENCE

### A. 2004 Session of the Conference

2. The Conference was in session from 19 January to 26 March, 10 May to 25 June and 26 July to 8 September 2004. During this period, the Conference held 28 formal plenary meetings, at which Member States as well as non-Member States invited to participate in the discussions outlined their views and recommendations on the various questions before the Conference.

3. The following dignitaries addressed the Conference on Disarmament during its 2004 session: Mr. Kamal Kharrazi, Minister for Foreign Affairs of the Islamic Republic of Iran (CD/PV. 944), Mr. Bill Graham, Minister for Foreign Affairs of Canada (CD/PV.951), Mr. Brian Cowen, Minister for Foreign Affairs of Ireland (CD/PV.951), Mr. Reaz Rahman, Minister of State for Foreign Affairs of Bangladesh (CD/PV.951), Ms. Laila Freivalds, Minister for Foreign Affairs of Sweden (CD/PV.951), Mr. Bernard Bot, Minister for Foreign Affairs of the Netherlands (CD/PV.952) and Mr. Tyrone Fernando, Minister for Foreign Affairs of Sri Lanka (CD/PV.953). The Conference welcomed their addresses as expressions of support for the endeavours of the Conference on Disarmament and to its role as the single multilateral negotiating forum in the field of disarmament.

4. The Conference also held 16 informal plenary meetings on its agenda, programme of work, organization and procedures, as well as on specific items of its agenda and other matters.

5. In accordance with Rule 9 of the Rules of Procedure, the following Member States assumed successively the Presidency of the Conference: Kenya, Malaysia, Mexico, Mongolia, Morocco and Myanmar.

6. The substantive Secretariat of the Conference on Disarmament was composed as follows: Mr. Sergei Ordzhonikidze, Secretary-General of the Conference on Disarmament and Personal Representative of the Secretary-General of the United Nations; Mr. Enrique Román-Morey, Deputy Secretary-General of the Conference on Disarmament; and Mr. Jerzy Zaleski, Political Affairs Officer, Secretary of the Conference on Disarmament.

### B. Participants in the Work of the Conference

7. The representatives of the following 65 Member States participated in the work of the Conference: Algeria, Argentina, Australia, Austria, Bangladesh, Belarus, Belgium, Brazil, Bulgaria, Cameroon, Canada, Chile, China, Colombia, Cuba, the Democratic People's Republic of Korea, the Democratic Republic of the Congo, Ecuador, Egypt, Ethiopia, Finland, France, Germany, Hungary, India, Indonesia, the Islamic Republic of Iran, Iraq, Ireland, Israel, Italy, Japan, Kazakhstan, Kenya, Malaysia, Mexico, Mongolia, Morocco, Myanmar, the Netherlands, New Zealand, Nigeria, Norway, Pakistan, Peru, Poland, the Republic of Korea, Romania, the Russian Federation, Senegal, Slovakia, South Africa, Spain, Sri Lanka, Sweden, Switzerland, the Syrian Arab Republic, Tunisia, Turkey, Ukraine, the United Kingdom of Great Britain and Northern Ireland, the United States of America, Venezuela, Viet Nam and Zimbabwe.

### C. Attendance and Participation of States not Members of the Conference

8. In conformity with Rule 32 of the Rules of Procedure, the States not Members of the Conference listed in the following paragraph attended its plenary meetings.

9. The Conference received and considered requests for participation in its work from 38 States not Members of the Conference. In accordance with the Rules of Procedure and its decision taken at its 1990 session on its improved and effective functioning (CD/1036), the Conference invited the following non-Member States to participate in its work: Albania, Azerbaijan, Bosnia and Herzegovina, Costa Rica, Croatia, Cyprus, the Czech Republic, Denmark, Estonia, Georgia, Ghana, Greece, Guatemala, the Holy See, Iceland, Jordan, Kuwait, Latvia, Lebanon, the Libyan Arab Jamahiriya, Lithuania, Luxembourg, Madagascar, Malta, Oman, the Philippines, Portugal, Qatar, San Marino, Saudi Arabia, Serbia and Montenegro, Singapore, Slovenia, Sudan, Thailand, The Former Yugoslav Republic of Macedonia, Uruguay and Yemen.

### D. Agenda and Programme of Work for the 2004 Session

10. Following discussions at the informal plenary meeting on 22 January 2004, the Conference adopted, at its 943<sup>rd</sup> plenary meeting on 27 January 2004, its agenda for the 2004 session in conformity with the Rules of Procedure. The agenda (CD/1725) reads as follows:

“Taking into account, inter alia, the relevant provisions of the Final Document of the First Special Session of the General Assembly devoted to disarmament, and deciding to resume its consultations on the review of its agenda, and without prejudice to their outcome, the Conference adopts the following agenda for its 2004 session:

1. Cessation of the nuclear arms race and nuclear disarmament.
2. Prevention of nuclear war, including all related matters.
3. Prevention of an arms race in outer space.

4. Effective international arrangements to assure non-nuclear-weapon States against the use or threat of use of nuclear weapons.
5. New types of weapons of mass destruction and new systems of such weapons; radiological weapons.
6. Comprehensive programme of disarmament.
7. Transparency in armaments.
8. Consideration and adoption of the annual report and any other report, as appropriate, to the General Assembly of the United Nations.”

11. Subsequently, the President made the following statement: “In connection with the adoption of the agenda, I, as the President of the Conference, should like to state that it is my understanding that if there is a consensus in the Conference to deal with any issues, they could be dealt with within this agenda. The Conference will also take into consideration rules 27 and 30 of the rules of procedure of the Conference, as well as paragraph 23 of the report of the Conference on Disarmament to the General Assembly, contained in document CD/1718 of 10 September 2003.”

12. During the annual session, successive Presidents of the Conference conducted intensive consultations with a view to reaching consensus on a programme of work. In the course of these consultations, a number of informal proposals related to a programme of work were put forward. The Conference did not, however, agree on a programme of work and did not re-establish or establish any mechanism on any of its specific agenda items during the 2004 session.

13. During plenary meetings of the Conference, delegations and groups of delegations expressed their views on the issue of a programme of work, taking into account all relevant proposals, including those submitted as the documents of the Conference on Disarmament since 2000. Statements were made by some delegations emphasizing that linkage should not be established between elements of a programme of work while other delegations stressed the need for a comprehensive approach. Support for proposals and ideas on a programme of work is duly reflected in the plenary records.

14. The following document dealing with this item was submitted to the Conference:

CD/1733, entitled “Letter dated 23 March 2004 from the Permanent Representative of Japan to the Conference on Disarmament addressed to the Secretary-General of the Conference transmitting the text of the statement given as President of the Conference on the programme of work on 19 December 2003 in Geneva.”

E. Expansion of the Membership of the Conference

15. The important question of the expansion of the membership of the Conference was addressed by delegations in plenary meetings. Their views on the issue are duly reflected in the plenary records.

16. Requests for membership had been received, since 1982, from the following 23 non-Members, in chronological order: Greece, Croatia, Kuwait, Portugal, Slovenia, the Czech Republic, Costa Rica, Denmark, The Former Yugoslav Republic of Macedonia, Cyprus, Lithuania, Ghana, Luxembourg, Uruguay, the Philippines, Azerbaijan, the Libyan Arab Jamahiriya, Armenia, Thailand, Georgia, Jordan, Estonia and Latvia.

F. Review of the Agenda of the Conference

17. The importance of the review of the agenda of the Conference was addressed by delegations in plenary meetings. Their views on the issue are duly reflected in the plenary records.

G. Improved and Effective Functioning of the Conference

18. The importance of the improved and effective functioning of the Conference was addressed by delegations in plenary meetings. Their views on the issue are duly reflected in the plenary records.

19. At its 946<sup>th</sup> plenary meeting on 12 February 2004, under the presidency of Kenya, the Conference adopted the following decision with regard to enhancement of the engagement of civil society in the work of the Conference:

- "1. Non-governmental organizations (NGOs) shall continue to be allowed to attend formal plenary meetings of the Conference and to be seated in the public gallery.
- "2. NGOs shall be entitled, upon request, to receive official documents of the plenary meetings of the Conference.
- "3. NGOs shall be entitled, at their own expense, twice per annual session, to make written material available to the members of the Conference outside the conference hall.
- "4. After the Conference on Disarmament adopts a programme of work, it will allocate one informal plenary meeting per annual session to NGOs to address the Conference.
- "5. Only NGOs whose activities are relevant to the work of the Conference will be able to address the Conference on Disarmament. Therefore, a formal selection process will be put in place to consider requests from NGOs to address the Conference. Requests from NGOs will be made to the President of the Conference on Disarmament through the secretariat of the Conference on Disarmament. These requests will be considered at Presidential consultations and thereafter at a formal plenary meeting of the Conference."

20. After the adoption of the above decision, the President made the following statement: "It is my understanding that with respect to the selection process on requests made by NGOs, the final decision for NGOs to address the Conference on Disarmament would be given by a formal plenary meeting of this Conference in the same way as it gives approval to decisions that are put before it by consensus."

#### H. Communications from Non-Governmental Organizations

21. In accordance with Rule 42 of the Rules of Procedure, a list of all communications from non-governmental organizations and persons was circulated to the Conference (document CD/NGC/38).

### III. SUBSTANTIVE WORK OF THE CONFERENCE DURING ITS 2004 SESSION

22. Significant contributions were made to promote substantive discussions on the issues on the agenda, and furthermore contributions were also made to promote discussions on other issues that could be relevant to the current international security environment. The substantive work of the Conference during its 2004 session was based on its agenda. The list of documents issued by the Conference, as well as the texts of those documents, are included as Appendix I to this report. An index of the verbatim records, by country and subject, listing the statements made by delegations during 2004, and the verbatim records of the meetings of the Conference, are attached as Appendix II to the report.

23. At the 941<sup>st</sup> plenary meeting on 20 January 2004, the Secretary-General of the Conference on Disarmament conveyed to the Conference a message from the Secretary-General of the United Nations at the opening of the 2004 session (CD/PV.941).

24. The Conference had before it a letter dated 23 January 2004 from the Secretary-General of the United Nations (CD/1726 and Add.1) transmitting all the resolutions and decisions dealing with or related to disarmament and international security adopted by the General Assembly at its fifty-eighth session in 2003, including those making specific reference to the Conference on Disarmament:

A. Cessation of the Nuclear Arms Race and Nuclear Disarmament

25. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on this agenda item, including on nuclear disarmament and on the prohibition of the production of fissile material for nuclear weapons or other nuclear explosive devices. These are duly recorded in the plenary records of the session.

26. The following documents dealing with this item were submitted to the Conference:

(a) CD/1719, entitled “Letter dated 1 October 2003 from the Permanent Representative of the Netherlands to the Conference on Disarmament addressed to the Secretary-General of the Conference on Disarmament transmitting a summary of the fifth open-ended informal meeting in the framework of the Netherlands’ FMCT-exercise, on a treaty banning the production of fissile material for nuclear weapons and other nuclear explosive devices, held in Geneva on 26 September 2003”;

(b) CD/1734, entitled “Letter dated 23 April 2004 from the Permanent Representative of the Netherlands to the Conference on Disarmament addressed to the Secretary-General of the Conference on Disarmament transmitting a summary of the sixth open-ended informal meeting in the framework of the Netherlands’ FMCT-Exercise, on a treaty banning the production of fissile material for nuclear weapons and other nuclear explosive devices, held in Geneva on 2 April 2004”.

B. Prevention of Nuclear War, including All Related Matters

27. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item, and these are recorded in plenary records, previous annual reports of the Conference (in particular paragraphs 62-71 of the 1992 report to the General Assembly of the United Nations (CD/1173)), related official documents and working papers.

C. Prevention of an Arms Race in Outer Space

28. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item. These are duly recorded in the plenary records of this session.

29. At the 966<sup>th</sup> plenary meeting, on 26 August 2004, the delegations of China and the Russian Federation distributed two non-papers entitled “Existing International Legal Instruments and Prevention of the Weaponization of Outer Space” and “Verification Aspects of PAROS”.

D. Effective International Arrangements to Assure Non-Nuclear-Weapon States Against the Use or Threat of Use of Nuclear Weapons

30. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item. These are duly recorded in the plenary records of this session.

E. New Types of Weapons of Mass Destruction and New Systems of Such Weapons; Radiological Weapons

31. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item, and these are recorded in plenary records, previous annual reports of the Conference (in particular paragraphs 79-82 of the 1992 report of the Conference to the General Assembly of the United Nations (CD/1173)), related official documents and working papers.

F. Comprehensive Programme of Disarmament

32. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item, and these are recorded in plenary records, previous annual reports of the Conference (in particular paragraphs 83-89 of the 1992 report to the General Assembly of the United Nations (CD/1173)), related official documents and working papers.

33. During plenary meetings of the Conference, a number of delegations reaffirmed or further elaborated their respective positions on the issue of anti-personnel landmines, the detailed descriptions of which are duly recorded in the plenary records of this session.

34. The following document dealing with the issue of landmines was submitted to the Conference:

CD/1730, entitled “United States of America - New United States Policy on Landmines: Reducing Humanitarian Risk and Saving Lives of United States Soldiers”.

### G. Transparency in Armaments

35. During plenary meetings of the Conference, delegations reaffirmed or further elaborated their respective positions on the agenda item. These are duly recorded in the plenary records of this session.

### H. Informal Plenary Meetings

36. The priority of the Conference on Disarmament is to reach agreement on a programme of work and begin substantive work as soon as possible. The Member States, therefore, agreed to hold informal plenary meetings with a view to facilitating efforts to reach such agreement.

37. A total of 12 informal plenary meetings were held.

38. Under the presidency of Kenya, intensive consultations were held on the agenda and on convening a series of informal plenary meetings on the issues on the agenda of the Conference on Disarmament.

39. Under the presidency of Malaysia, one open-ended informal consultation was held on a work programme on 9 March 2004.

40. At the 954<sup>th</sup> plenary meeting of the Conference, under the presidency of Mexico, a timetable was circulated with a schedule of informal plenary meetings to deal with each item of the agenda in a systematic and organized way. Consequently under the presidency of Mexico, the following informal plenary meetings were held:

- on 13 May 2004 on agenda item 1: Cessation of the nuclear arms race and nuclear disarmament;
- on 18 May 2004 on agenda item 2: Prevention of nuclear war, including all related matters.

41. Under the presidency of Mongolia, the following informal plenary meetings were held:

- on 27 May 2004 on agenda item 3: Prevention of an arms race in outer space;
- on 3 June 2004 on agenda item 4: Effective international arrangements to assure non-nuclear weapon States against the use or threat of use of nuclear weapons;
- on 10 June 2004 on agenda items 4 and 5: Effective international arrangements to assure non-nuclear weapon States against the use or threat of use of nuclear weapons (continued); and  
New types of weapons of mass destruction and new systems of such weapons;  
radiological weapons;
- on 17 June 2004 on agenda item 6: Comprehensive programme of disarmament.

42. Under the presidency of Morocco, the following informal plenary meetings were held:

- on 24 June 2004 on agenda item 7: Transparency in armaments;
- on 5 August 2004 on “new and additional issues related to the agenda of the Conference on Disarmament”;
- on 10 August 2004 and 12 August 2004 on “methodology of the programme of work”.

43. Under the presidency of Myanmar, the following informal plenary meetings were held:

- on 24 August 2004 on "How to move forward on substantive issues/programme of work";
- on 31 August 2004 on "Assessment and stock-taking of informal plenary meetings".

44. These informal plenary meetings were considered to be useful and constructive. Appreciation was expressed by all Member States of the Conference on Disarmament for the convening of these informal plenary meetings. There was a general feeling among the Member States of the Conference that efforts should be further intensified in conducting consultations and in exploring possibilities with a view to reaching an agreement on a programme of work.

I. Consideration of Other Areas Dealing with the Cessation of the Arms Race and Disarmament and Other Relevant Measures

45. During its 2004 session, the Conference also had before it the following documents:

J. Consideration and Adoption of the Annual Report of the Conference and Any Other Report as Appropriate to the General Assembly of the United Nations

46. With a view to commencing early substantive work during its 2005 session, the Conference requested the current President and the incoming President to conduct consultations during the intersessional period and, if possible, make recommendations, taking into account all relevant proposals, including those submitted as the documents of the Conference on Disarmament, views presented and discussions held, and to endeavour to keep the membership of the Conference informed, as appropriate, of their consultations.

47. The Conference decided that the dates for its 2005 session would be:

First part: 24 January – 1 April 2005  
Second part: 30 May - 15 July 2005  
Third part: 8 August – 23 September 2005

48. The annual report to the fifty-ninth session of the General Assembly of the United Nations, as adopted by the Conference on 7 September 2004, is transmitted by the President on behalf of the Conference on Disarmament.
