**Standards of accommodation for air travel****Report of the Secretary-General\****Summary*

The present report of the Secretary-General on the standards of accommodation for air travel is submitted in accordance with General Assembly resolutions 42/214 of 21 December 1987, 45/218 A of 21 December 1990 and decisions 44/442 of 21 December 1989 and 46/450 of 20 December 1991, as well as decision 57/589 of 18 June 2003, in which the Secretary-General was requested to submit a report to the General-Assembly on a biennial basis. The present report provides information on standards of accommodation for air travel for the two-year period ended 30 June 2004 and comparative statistics for the two-year period ended 30 June 2002.

## **I. Introduction**

1. The United Nations standards of accommodation for air travel are governed by a series of General Assembly resolutions and decisions, including resolutions 42/214 of 21 December 1987, 45/248 A of 21 December 1990 and 53/214 of 11 February 1999 and decisions 40/555 of 18 December 1985, 44/442 of 21 December 1989, 46/450 of 20 December 1991 and 57/589 of 18 June 2003. Pursuant to the discretionary authority vested in the Secretary-General to authorize exceptions to air travel on a case-by-case basis and business-class travel by air in special circumstances that warrant it, the Secretary-General has promulgated administrative instruction ST/AI/2000/20 dated 22 December 2000 for the purpose of implementing the various staff rules relating to the standards of accommodation for air travel and the exceptions thereto.

2. In the past, certain categories of exceptions to the standards have been established, including, but not limited to, the following: travel of eminent persons; travel of prominent individuals who are donating their services to the Organization free of charge; travel under circumstances that have been deemed to be arduous or under which, for medical reasons, it has been deemed appropriate to upgrade the accommodation of air travel; travel of the personal aides and security officials travelling with the Secretary-General, his wife or his personal representatives; and travel under circumstances when the normal standard of accommodation is not available and it is considered prudent to authorize an upgrade.

3. In April 2002, the Secretary-General issued new guidelines for the designation of goodwill ambassadors and messengers of peace. The guidelines were a result of consultations held with members of the Senior Management Group and were prepared under the guidance of the Department of Management and the Office of Legal Affairs. The guidelines are aimed at the harmonization of practice as regards celebrity advocates designated United Nations goodwill ambassadors and messengers of peace. Accordingly, such persons are currently entitled to the same standard of travel normally accorded to senior officials of the Secretariat. However, a higher standard of travel may be authorized by the Under-Secretary-General, Department of Management.

## **II. Travel of delegations**

4. In accordance with General Assembly resolution 42/214, payment of first-class accommodation by air is limited to the heads of delegations of the least developed countries to the regular and special sessions of the Assembly. During the period from 1 July 2000 to 30 June 2002, 45 first-class trips were approved for the travel of such representatives, at a cost of \$275,062, compared with 53 trips during the two-year period ended 30 June 2004, at a cost of \$369,552. This translates into an increase in the number of trips by 8 at an additional cost of \$94,490: a percentage increase of 17.8 and 34.8, respectively.

## **III. Travel of the President of the General Assembly**

5. To strengthen the ability of the President of the General Assembly effectively and efficiently to discharge the responsibilities of the Office, the Assembly, by

resolution 53/214 decided that its President, consistent with the approved programme budget, should have full authority to use the funds provided in the budget for the Office. During the reporting period, seven trips were authorized under this authority, at an additional cost of \$22,517, representing a slight increase over the number of trips approved in the previous two-year period but a 40 per cent decrease in the additional cost of air travel. Detailed information on travel by the President is provided in annex VII to the present report.

#### **IV. Exceptions authorized by the Secretary-General**

6. By General Assembly resolution 42/214, the Secretary-General was authorized to exercise his discretion in making exceptions to allow first-class air travel on a case-by-case basis. Such discretionary authority is also exercised in accordance with paragraph 4.5 of ST/AI/2000/20 when, in the opinion of the Secretary-General, special circumstances warrant it. In exercising such authority, the Secretary-General takes into consideration, *inter alia*, the following circumstances:

(a) A medical condition that may necessitate a level of comfort not available in the standard of accommodation to which the traveller is entitled. Such cases are referred to the Director of the Medical Services Division for recommendation. The practice of granting exceptions for a traveller of an advanced age has been discontinued;

(b) The normal standard of accommodation is unavailable and, owing to the exigencies of service, the traveller is required to travel on a particular date. Cases also arise when accommodation at the normal standard of entitlement is not available and the cost of a daily subsistence allowance, while the traveller waits for the next available seat, would be greater than the higher standard of travel;

(c) The traveller is considered an eminent person, such as a former Head of State, or a prominent international figure in the political, humanitarian or cultural arenas;

(d) The traveller is a prominent person who is donating his or her services free of charge to the Organization and, in some cases, at a loss in personal income. Such individuals may be accorded the standard of accommodation to which they are accustomed;

(e) The traveller, after completing a full day of work, is required to travel through the night in order to resume work, attend meetings or present a paper at another location on the following morning or immediately upon arrival. Where such cases involve arduous journeys, it has been deemed reasonable that the standard of accommodation accorded the traveller should provide the best rest possible while travelling, or provide the conditions most conducive to work while flying, or both;

(f) The traveller is a personal aide or provides security services to the Secretary-General, his wife or to any other official authorized to travel above the standard accommodation that would normally be provided. There has been an increase in the number of trips taken by such personnel, from 24 in the two-year period ended 30 June 2002 to 26 in the period under review.

7. On 18 March 1998, the Secretary-General decided that, as an exception, all travel of the Deputy Secretary-General should be in first class, in keeping with her

special status. As regards practical arrangements, efforts are first made to obtain upgrades to first class against payment of the full business-class fare. Where this is not feasible, the first-class fare is paid. For the two-year period ended 30 June 2002, 7 such trips were authorized for the Deputy-Secretary-General, 7 at a cost of \$15,623, compared with 11 trips, at an additional cost of \$44,267, for the period under review.

8. A summary of the exceptions authorized during the period under review is contained in table 1 below and a summary of those authorized during the two-year period ended 30 June 2002 appears in table 2. Annexes I to VI to the present report provide detailed information on the number, nature, reason and the additional cost of the exceptions authorized on the basis of the above-mentioned factors, during the period from 1 July 2002 to 30 June 2004.
