Follow-up to and implementation of the outcome of the International Conference on Financing for Development

Proposed organization of work of the High-level Dialogue on Financing for Development

Note by the Secretary-General

I. Introduction

- 1. The General Assembly, in its resolution 59/293 of 27 May 2005, requested the Secretary-General, inter alia, to prepare a note on the organization of work of the High-level Dialogue on Financing for Development. The present note is in response to that request.
- 2. The arrangements set out below have been formulated on the basis of the following:
- (a) General Assembly resolution 59/145 of 17 December 2004, entitled "Modalities, format and organization of the High-level Plenary Meeting of the sixtieth session of the General Assembly";
- (b) General Assembly resolution 59/225 of 22 December 2004, entitled "Follow-up to and implementation of the outcome of the International Conference on Financing for Development";
- (c) General Assembly resolution 59/293 of 27 May 2005, entitled "Modalities for the High-level Dialogue on Financing for Development";
- (d) Letter dated 3 June 2005 from the President of the General Assembly at its fifty-ninth session addressed to the permanent representatives of all States Members of the United Nations on the organization of the High-level Dialogue on Financing for Development.

II. Organizational arrangements

A. Dates and venue

3. The High-level Dialogue on Financing for Development, comprising a series of plenary and informal meetings and interactive multi-stakeholder round tables,

will be held on Monday and Tuesday, 27 and 28 June 2005, at United Nations Headquarters in New York. The plenary meetings will be held in the General Assembly Hall. The informal interactive dialogue will be held in Conference Room 4. The venues of the multi-stakeholder round tables will be announced at a later stage. All scheduled meetings will be announced in the *Journal of the United Nations*.

B. Overall theme

4. The overall theme of the High-level Dialogue will be "The Monterrey Consensus: status of implementation and tasks ahead".

C. Schedule of meetings and organization of work

5. The High-level Dialogue will consist of a series of plenary and informal meetings to constitute a policy dialogue on the overall theme stated above and six interactive multi-stakeholder round tables on the themes based on the structure of the Monterrey Consensus of the International Conference on Financing for Development. The proposed programme of the High-level Dialogue is contained in the annex to the present note.

D. Plenary meetings

- 6. The plenary meetings, chaired by the President of the General Assembly, will be held on Monday, 27 June 2005, from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m. At these meetings, ministers and high-level officials attending the Dialogue will be able to make formal statements, on the understanding that the principle of precedence will be strictly applied, to allow participation at the ministerial level. Each oral statement will be limited to five minutes, on the understanding that this will not preclude the distribution of more extensive texts.
- 7. The plenary meeting on the morning of Monday, 27 June, will begin with the formal opening of the High-level Dialogue by the President of the General Assembly. At the opening the Assembly will be able to take up any remaining organizational matters. In addition, the Secretary-General of the United Nations, the President of the World Bank, the Managing Director of the International Monetary Fund and the Director-General of the World Trade Organization will be invited to make statements.
- 8. The next plenary meeting, which will be held on the afternoon of Monday, 27 June, will begin with the statements by the President of the Economic and Social Council, the Secretary-General of the United Nations Conference on Trade and Development and the Administrator of the United Nations Development Programme, as the Chairman of the United Nations Development Group.
- 9. A plenary meeting will be held on the afternoon of Tuesday, 28 June, immediately following the conclusion of the informal interactive dialogue (in Conference Room 4), in order to enable the President of the General Assembly to make a concluding statement and formally close the High-level Dialogue.

E. Multi-stakeholder round tables

- 10. On the morning of Tuesday, 28 June, six interactive multi-stakeholder round tables, divided into two sessions, each comprising three simultaneous round tables, will be held as outlined below.
- 11. The first set of three simultaneous round tables will be held on Tuesday, 28 June, from 10 a.m. to 11.30 a.m., on the following themes:
 - Round table 1: Mobilizing domestic financial resources for development
 - Round table 2: *Mobilizing international resources for development foreign direct investment and other private flows*
 - Round table 3: *International trade as an engine for development.*
- 12. The second set of three simultaneous round tables will be held on Tuesday, 28 June, from 11.30 a.m. to 1 p.m., on the following themes:
 - Round table 4: Increasing international financial and technical cooperation for development
 - Round table 5: External debt
 - Round table 6: Addressing systemic issues enhancing the coherence and consistency of the international monetary, financial and trading systems in support of development.
- 13. Each round table will be chaired by two chairpersons to be appointed by the President of the General Assembly from among the ministers attending the Highlevel Dialogue, including those nominated by the regional groups. The President of the General Assembly may also invite heads of relevant institutional stakeholders to act as lead discussants in the round tables.
- 14. Each round table will be open to the participation of 35 representatives of Governments; seven representatives of observers, entities of the United Nations system and accredited institutional stakeholders; three representatives of accredited civil society organizations and three representatives of accredited business sector entities.

F. Informal interactive dialogue

15. The informal interactive dialogue, chaired by the President of the General Assembly, will be held on the afternoon of Tuesday, 28 June, in the form of an informal meeting with the participation of all relevant stakeholders. It will focus on the implementation of the results of the International Conference on Financing for Development and the link between financing for development and the achievement of the internationally agreed development goals, including those contained in the United Nations Millennium Declaration.² The heads or representatives of relevant organizations of the United Nations system, regional and international intergovernmental organs that participated in the International Conference on Financing for Development, as well as representatives of regional development banks, civil society and the business sector, will be able to intervene.

16. To provide for a free-flowing, interactive discussion, no list of speakers will be established. The President of the General Assembly will call upon participants, in the order in which they signify their desire to speak, on the understanding that the principle of precedence will be strictly applied, to allow participation at the ministerial level. The Chairpersons of the round tables and other participants may wish to refer to the outcomes of the discussions in the round tables. All participants will be invited to speak from their seats and will be strongly encouraged to avoid reading from written statements.

III. Participants

A. Member States and observers

- 17. The High-level Dialogue on Financing for Development, including the plenary and informal meetings, will be open to participation by Member States, the Holy See, in its capacity as Observer State, and Palestine, in its capacity as observer, as well as intergovernmental organizations having received a standing invitation to participate as observers in the sessions and work of the General Assembly, in accordance with the rules of procedure of the General Assembly.
- 18. The list of participants in the round tables will be established on a first-come, first-served basis. The maximum number of Member States participating in each round table shall not exceed 35. Each delegation may participate in only one round table.
- 19. Member States are encouraged to participate in the High-level Dialogue at the ministerial level. Each minister or head of delegation participating in the round tables may be accompanied by one advisor.

B. Institutional stakeholders

20. Other relevant intergovernmental organizations that were accredited to the International Conference on Financing for Development and its follow-up process, as well as relevant organizations of the United Nations system, may participate in the informal interactive dialogue and the multi-stakeholder round tables. Each round table will include seven representatives of observers, entities of the United Nations system and accredited intergovernmental organizations other than observers. Their distribution in the round tables will follow the practice established at the International Conference on Financing for Development.

C. Civil society and the business sector

21. Non-governmental organizations and business sector entities are invited to participate in the interactive round tables and informal meetings of the High-level Dialogue, in accordance with the rules of procedure of the General Assembly. Accreditation will be open to: (i) all non-governmental organizations that are in consultative status with the Economic and Social Council; and (ii) all non-governmental organizations and business sector entities that have been accredited to

the International Conference on Financing for Development and its follow-up process.

- 22. In addition, interested non-governmental organizations and business sector entities that are not in consultative status with the Economic and Social Council or were not accredited to the International Conference on Financing for Development or its follow-up process may apply to the General Assembly for accreditation following the accreditation procedure established during the International Conference.
- 23. Each round table will include three representatives of civil society and three representatives of the private sector. Their distribution in the round tables will follow the practice established at the International Conference on Financing for Development.

IV. Documentation

A. Pre-session documentation

- 24. The substantive documentation of the High-level Dialogue on Financing for Development will include the following:
- (a) Report of the Secretary-General entitled "The Monterrey Consensus: status of implementation and tasks ahead" (A/59/822);
- (b) Report of the Secretary-General on strengthening the role of the private sector and entrepreneurship in financing for development (A/59/800);
- (c) Summary by the President of the Economic and Social Council of the special high-level meeting of the Council with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development (New York, 18 April 2005) (A/59/823-E/2005/69);
- (d) Note by the Secretary-General entitled "Implementation of the Monterrey Consensus: a regional perspective" (A/59/826);
- (e) Summary of the hearings with representatives of non-governmental organizations, civil society organizations and the private sector related to financing for development (A/59/__).

B. Post-session documentation

25. The President of the General Assembly will prepare a summary of the High-level Dialogue on Financing for Development, which will be issued as a document of the General Assembly and will provide an input on financing for development to the preparatory process of the High-level Plenary Meeting of the General Assembly to be held in September 2005.

C. Inputs from all relevant stakeholders

26. Background information for the High-level Dialogue on Financing for Development, including inputs received from all relevant stakeholders, will be

posted and updated, on a regular basis, on the website of the Financing for Development Office of the Department of Economic and Social Affairs of the United Nations Secretariat at www.un.org/esa/ffd.

V. Hearings with representatives of non-governmental organizations, civil society organizations and the private sector

27. The President of the General Assembly will preside over the informal interactive hearings with representatives of non-governmental organizations, civil society organizations and the private sector, to be held on Thursday and Friday, 23 and 24 June 2005, as an input to the preparatory process of the High-level Plenary Meeting of the General Assembly, to be held in September 2005. Issues related to financing for development will be discussed on the afternoon of Thursday, 23 June. The Secretariat will issue a summary of the hearings related to financing for development as an input to the High-level Dialogue. Background information on the hearings is available at www.un-ngls.org/GA-hearings.htm.

VI. Media coverage

- 28. A special information kit is being prepared by the Department of Public Information for journalists covering the High-level Dialogue on Financing for Development. In addition, the documents counter in the media area will provide all Dialogue documents, as well as press releases on its plenary meetings, round tables and other events. They will also be made available electronically at www.un.org/esa/ffd.
- 29. The plenary and informal meetings of the whole, as well as press conferences, will be broadcast live into the media area. A programme of special media briefings and press conferences will be announced.

VII. Side events

30. A series of special events, including briefings and panel discussions on issues related to financing for development, is being organized by Member States, organizations of the United Nations system and accredited institutional and non-institutional stakeholders for the participants in the High-level Dialogue. The calendar of those events will be made available at the Dialogue site and will also be posted at www.un.org/esa/ffd.
