Report of the Secretary-General

Summary

The present report, which covers the use of consultants and individual contractors during 2004 and 2005, is submitted pursuant to General Assembly resolutions 59/266 and 57/305, in which the Secretary-General was requested to report biennially on the use of consultants and individual contractors in the Secretariat and the factors contributing to that use. The report provides information on their duties, with statistics for the biennium and for each year of the two-year period.

In the biennium 2004-2005 as compared to 2002-2003, fewer consultants and individual contractors were hired and contracts granted, the duration of engagements was reduced and the expenditure decreased.

The General Assembly is invited to take note of the report.

I. Introduction

1. In section XI of its resolution 59/266, the General Assembly requested the Secretary-General to submit a report at its sixty-first session on the use of consultants and individual contractors, including actions taken to improve the monitoring capacity of the Office of Human Resources Management on the issue and including areas where consultants are hired for a period of more than one year. In section V of its resolution 57/305, the Assembly requested the Secretary-General to report biennially, starting at the fifty-ninth session, on the use of consultants and individual contractors within the Secretariat and the regional commissions and the factors contributing to it, including information on their duties, with statistics for each year of the two-year period.

2. The previous report of the Secretary-General on consultants and individual contractors (A/59/217) covered the biennium 2002-2003. The present report covers the biennium 2004-2005, with tables for each year of the biennium as well as for the whole two-year period.

3. The present report records all engagements with a starting date in either 2004 or 2005. The duration of contracts and the fees paid to consultants and individual contractors are presented for their entire contractual period, even in those cases where the work extended beyond the recruitment year. Consequently, contracts that began before 2004 are not included in the present report even if they continued into that year.

4. The following definitions are applicable for purposes of the present report, as provided in administrative instructions ST/AI/1999/7 and ST/AI/327:

(a) A consultant is an individual who is a recognized authority or specialist in a specific field, engaged by the United Nations under temporary contract in an advisory or consultative capacity to the Secretariat. A consultant must have special skills or knowledge not normally possessed by the regular staff of the Organization and for which there is no continuing need in the Secretariat. The functions of a consultant are results-oriented and normally involve analysing problems, directing seminars or training courses, preparing documents for conferences and meetings or writing reports on the matters within their area of expertise on which their advice or assistance is sought;

(b) An individual contractor is an individual engaged by the Organization from time to time under temporary contract to provide expertise, skills or knowledge for the performance of a specific task or piece of work against payment of an all-inclusive fee. An individual contractor need not work on United Nations premises. The work assignment may involve full-time or part-time functions similar to those of staff members, such as provision of translation, editing, language training, public information, secretarial/clerical and part-time maintenance services, or other functions that could be performed by staff members;

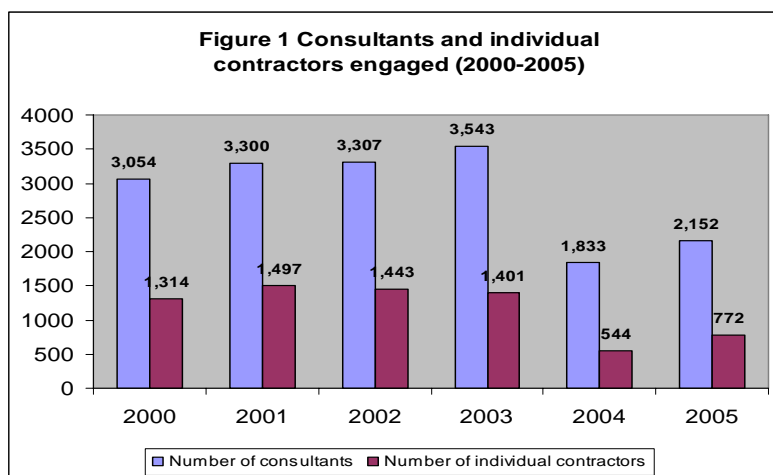
(c) The temporary services of individuals required by the Organization from time to time may be obtained by their engagement as contractors under a contract entered into directly with an institution or a corporation. The functions of contractors may involve the provision of interpretation, translation, editing, library, language training, public information, secretarial, clerical, guidance services, etc. In addition, consultancy services, which normally involve analysing problems,

directing seminars or training courses, preparing documents for conferences and meetings or writing reports on the matters within the area of expertise on which advice or assistance is sought, may be obtained from institutional or corporate contractors.

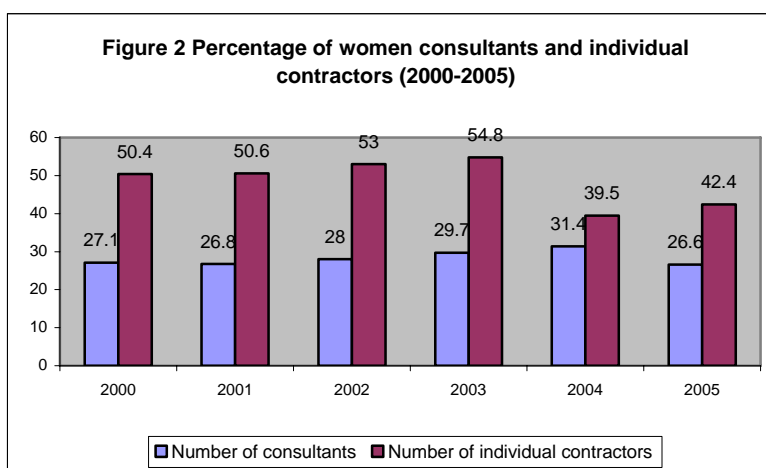
II. Statistical data analysis (2004-2005)

5. In 2004 a total of 1,833 consultants were engaged for a total of 2,061 contracts: 575 (31.4 per cent) were women, 2 (0.1 per cent) were retirees and 64 (3.5 per cent) were non-retired former staff. In 2005 2,152 consultants were engaged for a total of 2,455 contracts: 573 (26.6 per cent) were women, 2 (0.1 per cent) were retirees and 26 (1.2 per cent) were non-retired former staff. In 2004 544 individual contractors were hired for a total of 748 contracts: 215 (39.5 per cent) were women, 3 (0.1 per cent) were retirees and 63 (11.6 per cent) were non-retired former staff. In 2005 772 individual contractors were engaged for a total of 1,122 contracts: 327 (42.4 per cent) were women, 4 (0.5 per cent) were retirees and 64 (8.3 per cent) were non-retired former staff. As shown in table 1 (see annex), the number of persons engaged as consultants and individual contractors significantly decreased from 2003 to 2004 but slightly increased in 2005.

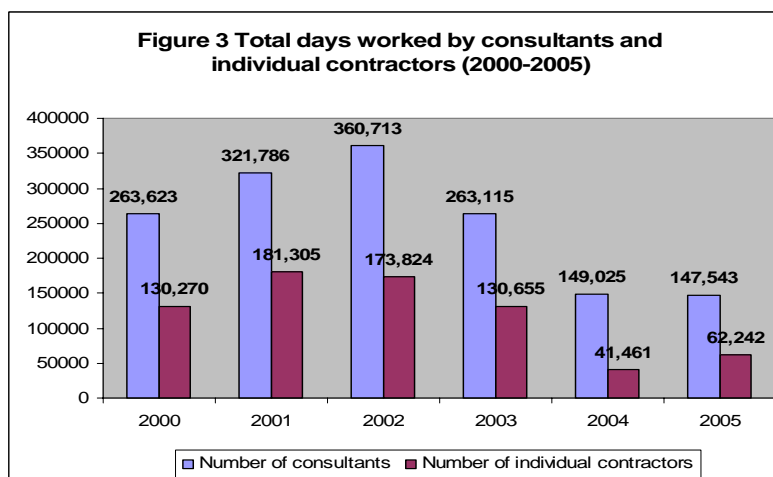
6. Compared to the biennium 2002-2003, the total number of consultants and individual contractors hired in 2004-2005 decreased by 2,852 (35 per cent); there were 1,912 fewer consultants (32.4 per cent) and 940 fewer individual contractors (41.7 per cent). Figure 1 illustrates the evolution of the number of consultants and individual contractors engaged between 2000 and 2005.



7. The percentage of women engaged as consultants grew from 29.7 per cent in 2003 to 31.4 per cent in 2004, but decreased to 26.6 per cent in 2005. The percentage of women engaged as individual contractors decreased from 54.8 per cent in 2003 to 39.5 per cent in 2004 and then increased to 42.4 per cent in 2005. Figure 2 illustrates the evolution of women consultants and individual contractors between 2000 and 2005.

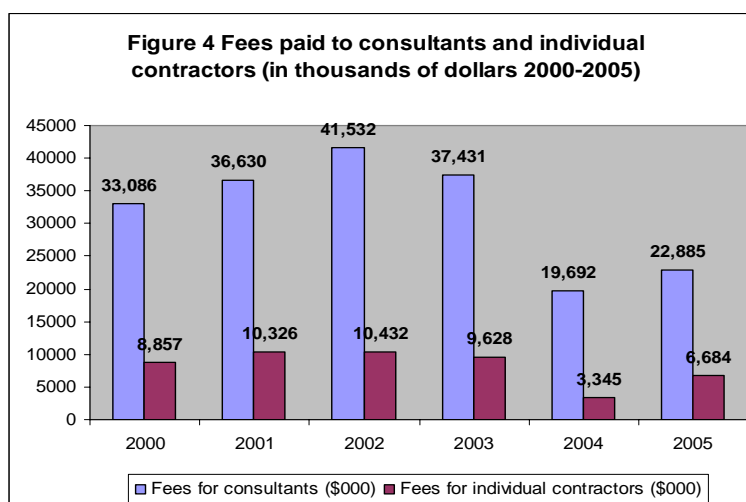


8. Consultants in 2004 worked a total of 149,025 workdays (81.3 per consultant on average); in 2005 the total number of workdays decreased to 147,543 (68.6 per consultant on average). Individual contractors in 2004 worked a total of 41,461 workdays (76.2 per contractor on average), increasing in 2005 to 62,242 workdays (80.6 per contractor on average). As compared with the biennium 2002-2003, the number of days worked in 2004-2005 decreased by 327,291 for consultants (52.5 per cent) and by 200,776 for individual contractors (65.9 per cent). For the same reporting period, the average duration of a contract decreased by 3.1 days for consultants but increased by 0.7 days for individual contractors. Figure 3 illustrates the evolution of workdays of consultants and individual contractors between 2000 and 2005.

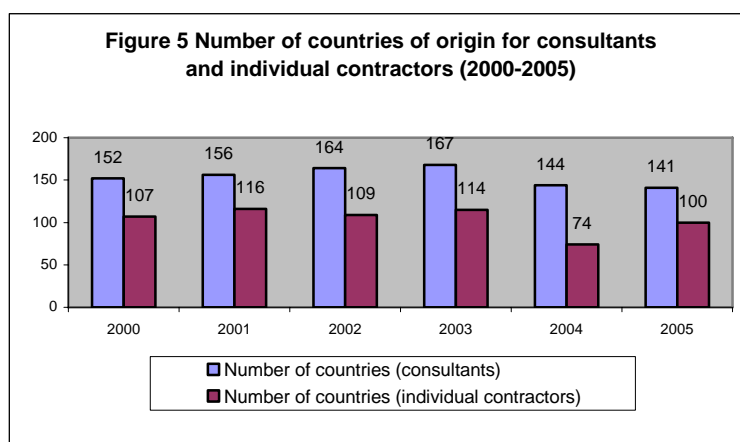


9. Total expenditure for consultants amounted to \$19.7 million in 2004 and \$22.9 million in 2005. For the biennium 2004-2005, this reflects a decrease of \$40.3 million (48.6 per cent) as compared with 2002-2003. For individual contractors total expenditure amounted to \$3.3 million in 2004 and \$6.7 million in

2005. For the biennium 2004-2005 this corresponds to a decrease of \$11.7 million (53.8 per cent) as compared with the previous biennium. The average cost of a consultancy contract in 2004-2005 was \$9,428, \$291 more than in 2002-2003. For an individual contractor the average cost of a contract was \$5,363 in 2004-2005, \$1,454 more than in 2002-2003. The average daily cost of a consultant in 2004-2005 was \$143.60 (\$10.70 more than in 2002-2003), while an individual contractor cost on average \$96.70 per day (\$25.40 more than in 2002-2003). In 2004-2005, the combined expenditure on consultants (\$42.6 million) and individual contractors (\$10.0 million) totalled \$52.6 million. Compared with 2002-2003 (\$104.7 million), that represents a decrease of 49.8 per cent. Figure 4 illustrates the evolution of expenditures on consultants and individual contractors between 2000 and 2005.



10. In 2004, consultants were engaged from 144 countries. Fewer than 50 consultants per country were hired from 137 countries, between 50 and 99 from 5 countries (Argentina, Canada, Chile, France and India) and 100 or more from 2 countries (United Kingdom of Great Britain and Northern Ireland and United States of America). Individual contractors came from 74 countries. Fewer than 15 individual contractors per country were engaged from 66 countries, between 15 and 49 from 5 countries (Ethiopia, Lebanon, Mexico, Switzerland, United Kingdom) and 50 or more from 3 countries (Chile, France, United States). Table 2 provides the details for 2004-2005 and figure 5 illustrates the evolution of the number of countries of origin of consultants and individual contractors over the period 2000-2005.



11. In 2005, consultants were engaged from 141 countries. Fewer than 50 consultants per country were hired from 130 countries, between 50 and 99 from 8 countries (Argentina, Brazil, Canada, Chile, France, Germany, Italy, Netherlands) and 100 or more consultants from 3 countries (India, United Kingdom, United States). Individual contractors were engaged from 100 countries. Fewer than 15 individual contractors per country were hired from 85 countries, between 15 and 49 from 12 countries (Argentina, China, Ethiopia, Germany, India, Kenya, Lebanon, Mexico, Russian Federation, Spain, Switzerland, United Kingdom) and 50 or more from 3 countries (Chile, France, United States).

12. The two main purposes of engagement of consultants, as shown in table 3, related to programme implementation (22.8 per cent in 2004 and 23.9 per cent in 2005) and advisory services (15.6 per cent in 2004 and 16.2 per cent in 2005), which was similar to 2002-2003. Engagements of individual contractors related to programme implementation (5.5 per cent in 2004 and 9.1 per cent in 2005), lectures and training courses (8.7 per cent in 2004 and 7.2 per cent in 2005), preparation of meetings (4.0 per cent in 2004 and 5.9 per cent in 2005) and advisory services (4.1 per cent in 2004 and 5.4 per cent in 2005). These were also the main purposes of engagement in the previous biennium (except for advisory services).

13. The engagement of consultants and individual contractors by occupational group (as established in the Common Classification of Occupational Groups) is presented in table 4. For consultants in 2004, the largest occupational group was technical cooperation related (455 contracts, 22.1 per cent), followed by economists (214 contracts, 10.4 per cent), social scientists (124 contracts, 6.0 per cent), professional, managerial and technical work (92 contracts, 4.5 per cent) and training specialists (65 contracts, 3.2 per cent). Similarly in 2005, the technical cooperation related category constituted the largest occupational group of consultants (543 contracts, 22.2 per cent), followed by economists (217 contracts, 8.9 per cent), social scientists (139 contracts, 5.7 per cent), writers (117 contracts, 4.8 per cent), training specialists (109 contracts, 4.5 per cent) and professional, managerial and technical work (102 contracts, 4.2 per cent). The comparison between the bienniums 2004-2005 and 2002-2003 shows that the occupational groups for which consultants were hired were very similar.

14. For individual contractors in 2004, the largest occupational category was administrative support (74 contracts, 9.9 per cent), followed by writing, translation and interpretation related (66 contracts, 8.8 per cent), writers, translators, interpreters (48 contracts, 6.4 per cent), translators/revisers (34 contracts, 4.5 per cent), technical cooperation related (31 contracts, 4.1 per cent) and teachers (30 contracts, 4.0 per cent). In 2005, the largest occupational group represented was writers, translators, interpreters (90 contracts, 4.8 per cent), followed by translators/revisers (63 contracts, 3.4 per cent), administrative support (61 contracts, 3.3 per cent) and technical cooperation related (45 contracts, 2.4 per cent). A comparison between the bienniums 2004-2005 and 2002-2003 reveals that the major occupational groups for which individual contractors were hired during both periods were also very similar (except for those related to technical cooperation).

15. Areas (departments and occupational groups) where consultants were hired for a period of more than one year are shown in table 5. During the biennium 2004-2005, 106 consultants (2.7 per cent of all consultants engaged during the biennium) were hired for more than one year. The following four entities hired 57.5 per cent of those consultants: the Office for the Coordination of Humanitarian Affairs (professional, managerial and technical work — 37), the Department of Economic and Social Affairs (technical cooperation related — 10), the Office of Human Resources Management (training specialists — 8) and the Economic Commission for Latin America and the Caribbean (economists — 6).

16. In both 2004 and 2005 most contracts given to consultants and individual contractors had a duration of up to three months (less than one month or one to three months). In 2004, as shown in table 6, 32.9 per cent of consultancy contracts were for less than one month and 37.1 per cent were for one to three months. Few contracts had a duration of one year or more (5.1 per cent). This share decreased to 0.7 per cent in 2005. In that year 32.7 per cent of consultancy contracts were for less than one month and 37.2 per cent were for one to three months. In 2004 40.8 per cent of contracts for individual contractors were for less than one month and 37.0 per cent were for one to three months. Very few contracts had a duration of one year or more (1.1 per cent). This share decreased to zero in 2005. In that year 40.1 per cent of contracts of individual contractors were for less than one month and 35.5 per cent were for one to three months. In the 2004-2005 as well as the 2002-2003 biennium, the majority of contracts for both consultants and individual contractors were for up to three months.

17. Analysis of the use of consultants should take into consideration the fact that contracts for consultants and individual contractors are given for specific periods of time, while remuneration is based on the actual number of days worked. The time that consultants and individual contractors actually worked is set out in table 7. In both years, 2004 and 2005, the largest number of consultants and individual contractors reported time actually worked of less than one month, and the second-largest group reported working one to three months. In 2004 45.4 per cent of consultants worked for less than one month and 31.9 per cent worked for one to three months. The percentage of contracts in which consultants actually worked one year or more was 3.6 per cent. In 2005 the figure was only 0.7 per cent. In that year consultants' actual work totalled less than one month in 36.3 per cent of contracts and one to three months in 36.9 per cent of contracts. For individual contractors, in 2004 48.4 per cent of contracts were for actual work of less than one month and 34.2 per cent were for work lasting from one to three months. There was no contract

with time actually worked of one year or more. In 2005 as well, no individual contractor's contract corresponded to time actually worked of one year or more. In 44.8 per cent of contracts actual work was less than one month and in 33.2 per cent of contracts it was one to three months. In 2004-2005 and in the previous biennium the majority of consultants and individual contractors worked for three months or less.

18. The departments and offices that made the most use of consultants and individual contractors in 2004, as shown in table 8, were the Economic Commission for Latin America and the Caribbean (ECLAC) (20.2 per cent), the Department of Economic and Social Affairs (13.7 per cent), the United Nations Conference on Trade and Development (UNCTAD) (13.3 per cent), the United Nations Office at Geneva (8 per cent), the Economic Commission for Africa (ECA) (6.1 per cent), the United Nations Environment Programme (UNEP) (4.7 per cent), the Economic and Social Commission for Asia and the Pacific (ESCAP) (4.2 per cent) and the Office of the United Nations High Commissioner for Human Rights (OHCHR) (3.7 per cent). These eight entities accounted for 73.8 per cent of all consultants and individual contractors engaged. In 2005 the largest users of consultants and individual contractors were ECLAC (14.4 per cent), the Department of Economic and Social Affairs (14.2 per cent), UNCTAD (14.2 per cent), UNEP (6.6 per cent), the United Nations Office at Geneva (6.3 per cent), ECA (5.2 per cent), OHCHR (4.3 per cent) and ESCAP (4.1 per cent). They accounted for 69.5 per cent of all persons engaged. These entities were also among those which had hired most consultants and individual contractors in the previous reporting period (except OHCHR). However, ECA, ESCAP, the Economic and Social Commission for Western Asia (ESCWA) and the United Nations Office at Nairobi reduced the number of consultants and individual contractors hired in 2004-2005.

19. In terms of educational levels of consultants and individual contractors hired, 2004 data show that 63.8 per cent of persons engaged held a university degree (18.6 per cent held a PhD, 23.5 per cent held a master's degree and 21.7 per cent had a bachelor's degree only), while 36.2 per cent had no university degree. The majority of performance evaluations (93 per cent) were satisfactory, and 0.3 per cent reflected unsatisfactory performance. In 2005, 61.2 per cent of persons engaged held a university degree (18.9 per cent held a PhD, 23.8 per cent a master's degree and 18.5 per cent held a bachelor's degree only), while 38.8 per cent had no university degree. Some 89 per cent of performance evaluations were satisfactory, and 0.3 per cent reflected unsatisfactory performance.

20. Table 9 sets out the expenditure on consultants and individual contractors by source of funding. In 2004 a total of \$23 million was paid in fees to consultants and individual contractors from all sources of funds, which was \$26 million less than in 2003 (a decrease of 53.1 per cent). The cost of consultants was \$19.7 million (24 per cent from the regular budget and 76 per cent from extrabudgetary sources) while the cost of individual contractors was \$3.3 million (52.3 per cent from the regular budget and 47.7 per cent from extrabudgetary sources). The Department of Economic and Social Affairs, the Department of Political Affairs, ECLAC, the United Nations Compensation Commission, UNCTAD and UNEP paid more than \$1 million each in fees to consultants. The regional commissions (ECA, the Economic Commission for Europe, ECLAC, ESCWA and ESCAP) paid 18.4 per cent of the total consultancy fees. While the majority of departments spent less than \$250,000 in fees to individual contractors, the Department of Economic and Social

Affairs, the Department of Public Information, ECLAC, UNCTAD, UNEP and the United Nations Office at Geneva paid more than that amount.

21. In 2005 the total expenditure for consultants and individual contractors was \$29.6 million from all sources of funds (\$6.6 million more than in 2004, an increase of 28.4 per cent). Consultants cost \$22.9 million (29.6 per cent from the regular budget and 70.4 per cent from extrabudgetary sources), while individual contractors cost \$6.7 million (44.8 per cent from the regular budget and 55.2 per cent from extrabudgetary sources). The Department of Economic and Social Affairs, the Department of Political Affairs, ECLAC, the Office for the Coordination of Humanitarian Affairs, OHCHR, UNCTAD, UNEP and the United Nations Human Settlements Programme (UN-Habitat) paid more than \$1 million to consultants. The regional commissions paid 18.7 per cent of total consultancy fees. While the majority of departments spent less than \$250,000 in fees to individual contractors, the Department of Economic and Social Affairs, the Department of Public Information, ECLAC, the Office for the Coordination of Humanitarian Affairs, OHCHR, UNCTAD, UNEP, the United Nations Office at Geneva and the United Nations Office at Nairobi paid more than that amount.

22. Total expenditures on consultants and individual contractors during the biennium 2004-2005 amounted to \$52.6 million (\$42.6 million for consultants and \$10.0 million for individual contractors), including \$16.2 million (30.9 per cent) from the regular budget and \$36.4 million (69.1 per cent) from extrabudgetary sources. Compared to the previous biennium, in 2004-2005 the total amount of fees paid decreased by 49.8 per cent.

23. Aggregate data on institutional contractors engaged at each duty station are shown in table 10. The total expenditure on individual contractors decreased from \$5.3 million in 2004 to \$4.6 million in 2005. In 2004 as compared to 2003, there were 52 fewer institutional contractors engaged (26.1 per cent less) and 56 fewer contracts given (21.2 per cent), which resulted in a \$215,000 decrease in expenditure (3.9 per cent). A further decrease of \$672,000 (12.7 per cent) in 2005 as compared to 2004 was due to a decrease in contract duration and a decrease in the number of contracts. The number of institutional contractors was similar in both years (147 in 2004 and 144 in 2005). Comparing 2004-2005 to 2002-2003, there was a reduction in the number of institutional contractors hired, contracts granted and months in which contractors were engaged, which resulted in a net decrease of total expenditure by \$7.7 million (43.9 per cent).

24. The Office of Human Resources Management has improved its monitoring of the use of consultants and individual contractors in departments through the inclusion of additional and specific targets for consultants and individual contractors in the fourth-cycle human resources action plans (2005-2006). These targets relate to the functions performed, the duration of the engagement, geographical distribution and gender representation.

III. Conclusions

25. The present report covers the use of consultants and individual contractors during the biennium 2004-2005.

26. Over the period from 2000 to 2005, the number of consultants and individual contractors first increased and then decreased after 2003, reaching its lowest level in 2004. In the biennium 2004-2005 as compared to 2002-2003, fewer consultants and individual contractors from fewer countries were hired, fewer contracts were granted, the duration of engagements was reduced and overall expenditure was less. However, the average cost of a contract given to a consultant or individual contractor was higher in 2004-2005 compared with 2002-2003. While the percentage of women consultants increased until 2004, it decreased in 2005. For both cycles, consultants were used mainly for programme implementation and advisory services, while individual contractors were used mainly for programme implementation, lectures and training courses and preparation of meetings. ECLAC, the Department of Economic and Social Affairs, UNCTAD, the United Nations Office at Geneva, UNEP, ECA, ESCAP and OHCHR were the main entities hiring consultants and individual contractors. As compared with the previous reporting period, the number of institutional contractors hired and related expenditures were reduced in 2004-2005.

27. The Secretary-General invites the General Assembly to take note of the present report.

Definitions

Professional, managerial and technical work: This group includes occupations concerned with the theoretical or practical aspects of such fields of human endeavour as art, science, engineering, education, medicine, law, business and economics and administrative, managerial and technical work. Most of these are occupations that require substantial academic preparation, usually at the university level.

Support work related to professional, managerial and technical occupations: This group includes occupations concerned with recording, compiling, reviewing and processing data; classifying, filing, retrieving and updating publications, correspondence and other reference materials; providing information; transmitting mail and messages; coordinating meetings and inspections; and carrying out other duties in accordance with established practices and procedures in support of occupations responsible for the management, creation, analysis and presentation of plans and programmes. The occupations included in the support group may also involve the performance of technical work in specific subject area where practical application rather than theoretical knowledge is required.

Production, service and transport work: This group includes occupations concerned with operating equipment; providing transport services; providing protection against crime, fire and accidents; providing food service; storing, distributing and accounting for materials; fabricating, erecting, installing, paving, painting, repairing and similarly working on structures and structural parts; and using manufactured components and assemblies to produce products. Many of these occupations require the application of the knowledge and physical skills of a craft or trade.
