Overview

- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustained economic growth, hunger and poverty eradication and sustainable development for all. The programme also seeks to contribute to a mutually reinforcing relationship between the development work of the United Nations and the other core elements of the United Nations wider work for its Member States and their peoples, on peace and security and human rights.
- 9.2 The programme is under the responsibility of the Department of Economic and Social Affairs. Its key programmatic thrusts are (a) to provide substantive support to the United Nations Charter bodies dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions and expert bodies, and (b) to analyse development prospects globally.
- 9.3 The programme takes an integrated approach, tackling the economic, social and environmental dimensions of development through normative, analytical and operational work. It applies that approach to the intergovernmental process as a whole, through which work on development issues takes place in five consecutive phases: (a) promoting understanding of common challenges; (b) building policy consensus on guiding principles and solutions; (c) forging international commitments and agreements, including specific courses of action; (d) facilitating implementation of commitments/translating agreements into action at the global, regional, national and local levels; and (e) monitoring and evaluating progress and obstacles to progress.
- 9.4 New impetus for the programme has been provided by the 2005 World Summit, creating challenges and opportunities that will continue to shape its operating environment and priorities in the biennium 2008-2009. In this respect, the following three major aspects of the 2005 World Summit Outcome will underline the operating framework for the biennium: (a) an intensified focus on both implementing the internationally agreed development goals, including the Millennium Development Goals, generated by the United Nations conferences and summits, which together make up the United Nations development agenda, and realizing the global partnership for development, which was strongly reaffirmed at the 2005 World Summit and set out in the Millennium Declaration, Monterrey Consensus and Johannesburg Plan of Implementation; (b) a determination to foster a more coherent and effective United Nations, through better integration of economic, social and environmental policies at all levels, stronger links between normative, analytical and operational work, and better management of United Nations entities dealing with development, the environment and humanitarian assistance; and (c) a commitment to pursue greater engagement with other partners and institutional stakeholders, including the multilateral financial, trade and development institutions, as well as non-governmental organizations, civil society and the private sector.
- 9.5 The programme will continue to emphasize the mainstreaming of gender perspectives into all policies and programmes, which the 2005 World Summit recognized as an essential contribution to achieving gender equality and the internationally agreed development goals. The programme has played a leading role in fulfilling the Organization's responsibility to provide advice and support on this front.
- 9.6 The 2005 World Summit decisions on reform of the Economic and Social Council system in particular have put the Council, and thus the programme, at the centre of the effort to monitor and advance unified and coherent implementation of the United Nations development agenda. The Council's new functions include: (a) conducting annual ministerial reviews of progress towards agreed development goals; (b) convening the global Development Cooperation Forum; (c) building the Council's capacity to respond rapidly to trends or emergencies that may threaten development

progress; (d) reconceiving its role in fostering global policy dialogue; and (e) playing a major role in overall coordination of United Nations system funds, programmes and agencies.

- 9.7 Providing effective support to these functions will require strategic integration, as well as strengthened coordination and coherence, both within the programme and within the Executive Committee on Economic and Social Affairs. It will also require strengthening productive interfaces between the programme and the United Nations Development Programme (UNDP) and between the Executive Committee on Economic and Social Affairs and the United Nations Development Group. Efforts will be made to promote and develop new methods and mechanisms of better knowledge through the establishment of new knowledge communities through the Intranet.
- 9.8 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized below in table 9.1 and as described in the output information for each subprogramme.

- 9.9 Responsibility for the implementation of the Convention on the Elimination of All Forms of Discrimination against Women and support for its Committee has been transferred from the Department of Economic and Social Affairs to the Office of the United Nations High Commissioner for Human Rights, and the programmatic aspects under subprogramme 2, Gender issues and advancement of women, have been revised and will be submitted to the Committee for Programme and Coordination at its forty-seventh session for its review, in accordance with General Assembly resolution 58/269.
- 9.10 The overall regular budget resources required for the biennium 2008-2009 for this section amount to \$153,784,100 before recosting, reflecting a net decrease of \$1,145,100 (or 0.7 per cent); the net decreases, as shown in table 9.3, can be summarized as follows:
- A net decrease of \$398,700 under policymaking organs relates to the discontinuation of the one-time provision of \$503,700 for travel of members of the Committee on the Elimination of Discrimination against Women to the additional annual sessions in the biennium 2006-2007, authorized by the General Assembly in its resolution 60/230, partly offset by a new one-time provision of \$105,000 in support of the activities of the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, authorized by the Assembly in its resolution 61/191;
 - A net increase of \$178,700 under executive direction and management represents a net result of inward redeployment of one P-4 post from programme support to strengthen the results-based management and programme coordination capacity of the Office of the Under-Secretary-General over the work of the Department (\$322,300) and outward redeployment of one General Service (Other level) post to strengthen subprogramme 10, financing for development, under programme of work (\$143,600);
 - The net increase of \$350,000 under programme of work relates to:

- (i) An increase of \$225,000 under subprogramme 1 for consultants and experts and travel mainly in support of the annual ministerial review and the Development Cooperation Forum activities;
 - (ii) A decrease of \$233,100 under subprogramme 2, resulting from the discontinuation of the one-time provision under general temporary assistance to support additional annual sessions of the Committee on the Elimination of Discrimination against Women in the biennium 2006-2007, authorized by the General Assembly in resolution 60/230;
 - (iii) An increase of \$87,500 under subprogramme 3, representing a net result of an increase owing to the full funding of one P-3 post established in the biennium 2006-2007 (\$125,800), partly offset by a decrease under non-post resources (\$38,300), mainly under general operating expenses, redeployed to programme support, which provides technical support for the whole Department;
 - (iv) A decrease of \$51,100 under subprogramme 9, resulting from redeployment of the provision for general operating expenses to programme support, which provides technical support for the whole Department;
 - (v) An increase of \$321,700 under subprogramme 10, comprising full funding of one P-5 post established in the biennium 2006-2007 (\$178,100) and inward redeployment of one General Service (Other level) post from the Office of the Under-Secretary-General to assist with research on emerging issues (\$143,600);
- (d) A net decrease of \$232,900 under programme support results from the outward redeployment of one P-4 post to the Office of the Under-Secretary-General (\$322,300) and a net increase of \$89,400 for non-post resources mainly to cover the Department's share of centrally provided data-processing and communications infrastructure services costs;
 - (e) A decrease of \$1,042,200 under advance to International Research and Training Institute for the Advancement of Women (INSTRAW) relates to the one-time provision for the biennium 2006-2007 to provide support to the current efforts to revitalize INSTRAW in accordance with General Assembly resolution 60/229.

9.11 The overall purpose of the technical cooperation activities of the Department of Economic and Social Affairs is to support the efforts of the developing countries and countries with economies in transition, to strengthen national capacities and to promote the sharing of development expertise and best practices. The Department's technical cooperation functions represent an integral component of its overall work programme, intimately linked to the normative and analytical functions it carries out in the specific economic and social areas covered by its programme of work. Across these areas, the mission of the Department's technical cooperation programme is to facilitate and support national efforts to meet in an integrated way the commitments, targets and goals of international conferences, including the Millennium Summit, the International Conference on Financing for Development, the World Summit on Sustainable Development, the World Summit on Social Development and the Fourth World Conference on Women. Based on its experience in carrying out its technical cooperation programme, the Department provides feedback to the intergovernmental processes on the progress and barriers faced in achieving these goals, thereby helping to link international policy deliberations and national policy implementation.

9.12 During the biennium 2008-2009, total projected extrabudgetary resources amounting to \$122,522,200 will supplement resources from the regular budget to finance various substantive and technical cooperation activities, including consultancy, expert groups, travel, technical advisory services, training, workshops, seminars and field projects.

- 9.13 Evaluation is an integral part of the programme cycle and, in this regard, the resources allocated to programme implementation will be used to some extent to evaluate the Department's major outputs and activities. Pursuant to resolution 58/269, it is estimated that \$1,690,000 will be dedicated to such activities, consisting of \$1,651,500 under the regular budget and \$38,500 of extrabudgetary resources. The exact scale of evaluation activities in the biennium 2008-2009 will be determined during the course of the biennium based on the implementation of evaluation plans developed for all substantive subprogrammes. The staff time devoted to self-assessment and self-evaluation under each subprogramme is estimated to be a total of 135.8 work-months.
- 9.14 The estimated percentage distribution of the total resources to be made available to the Department in the biennium 2008-2009 will be as follows:

- 9.15 Provision is made for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the substantive servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions.
- 9.16 The amount of \$2,672,800 includes a net decrease of \$398,700, comprising: (a) a decrease of \$503,700 resulting from discontinuation of the one-time provision for travel of representatives to the additional sessions of the Committee on the Elimination of Discrimination against Women in the biennium 2006-2007 authorized by the General Assembly in resolution 60/230; and (b) an increase of \$105,000 under non-post objects to support the activities of the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, to be held in Doha in 2008 in accordance with resolution 61/191.

1. Standing intergovernmental organs and expert bodies

Statistical Commission

Resource requirements (before recosting): \$99,600

- 9.17 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in: (a) promoting the development of national statistics and the improvement of their comparability; (b) coordinating the statistical work of the specialized agencies; (c) developing the central statistical services of the Secretariat; (d) advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and (e) promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by the Economic and Social Council for a period of four years.
- 9.18 Bearing in mind General Assembly resolution 50/227 and the need to provide for more continuity in the Statistical Commission's decision-making and oversight of the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission should meet annually for a period of four working days in New York, beginning in 2000. The thirty-ninth and fortieth sessions of the Statistical Commission are scheduled to be held in 2008 and 2009, respectively.

Commission on Population and Development***Resource requirements (before recosting): \$114,400***

- 9.19 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution 49/128, the General Assembly decided that the revitalized Population Commission should be renamed the Commission on Population and Development and that it should meet on an annual basis. The Commission consists of 47 representatives of Member States elected by the Economic and Social Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days. The forty-first and forty-second sessions of the Commission are scheduled to be held in 2008 and 2009, respectively.
- 9.20 Under its terms of reference the Commission is to assist the Economic and Social Council by: (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationship between population and development at the national, regional and international levels and advising the Council thereon.

Commission for Social Development***Resource requirements (before recosting): \$190,700***

- 9.21 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development in order to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council for a period of four years, and that it should meet in annual sessions of eight working days. The Council also decided, by its resolution 2005/11, that the Commission would be organized in a series of two-year action-oriented implementation cycles that would include a review segment and a policy segment. The forty-sixth and forty-seventh sessions of the Commission for Social Development are scheduled to be held in 2008 and 2009, respectively.

Commission on the Status of Women***Resource requirements (before recosting): \$222,600***

- 9.22 The Commission on the Status of Women was established as a functional commission of the Economic and Social Council by the Council in its resolution 11 (II). The original membership of 15 representatives of Member States was increased to 18 in 1951, to 21 in 1961 and to 32 in 1966. By its resolution 1989/45, the Council decided to enlarge the membership in 1990 to 45 representatives elected by the Council for a period of four years. The Commission reports to the

Council on matters concerning the promotion of women's rights in the political, economic, social and educational fields and makes recommendations to the Council on problems requiring immediate attention in the field of women's rights. It meets annually in New York for 10 working days. The fifty-second and fifty-third sessions of the Commission on the Status of Women are scheduled to be held in 2008 and 2009, respectively.

- 9.23 The Commission has a central role within the United Nations system in monitoring the implementation of the Beijing Declaration and Platform for Action and in advising the Economic and Social Council thereon in accordance with its strengthened mandate. In its resolution 1996/6, the Council gave the Commission a catalytic role in mainstreaming gender perspectives in policies and programmes and confirmed its existing mandates. In its resolution 2006/9, the Council decided that the Commission would consider one priority theme at each session for the period 2007-2009, based on the Beijing Platform for Action and the outcome of the twenty-third special session of the General Assembly. The Commission would hold an interactive high-level round table in parallel chambers, two interactive expert panels on the priority theme of each session, as well as a panel on emerging issues, a panel on the priority theme of the subsequent session and an interactive dialogue to review a theme from an earlier session. Under Council resolutions 76 (V), 3041 (XI) and 1983/27, the Secretary-General is mandated to prepare lists of confidential and non-confidential communications on the status of women for submission to the Commission on the Status of Women.

Commission on Sustainable Development

Resource requirements (before recosting): \$496,600

- 9.24 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by the Council in its decision 1993/207. Its functions are set out in General Assembly resolution 47/191. The Commission is composed of 53 representatives of Member States elected by the Council for a period of three years, and meets annually for a period of two to three weeks. The Commission reports to the Council and provides recommendations to the Assembly through the Council. As a consequence of the World Summit on Sustainable Development and Council resolution 2003/61 on the future programme of work of the Commission on Sustainable Development, the work of the Commission is organized in a series of two-year action-oriented implementation cycles, which include a review session and a policy session. It will continue to meet annually as in the past; every second year will be reserved for intergovernmental negotiations. The review session will focus on the results of the implementation of the programme of work by Governments, international organizations and major groups at the national and regional levels and will establish the topics to be negotiated in the following year's session of the Commission. The overall workload of the Commission will remain unchanged. The sixteenth and seventeenth sessions of the Commission on Sustainable Development are scheduled to be held in 2008 and 2009, respectively.

Committee for Development Policy

Resource requirements (before recosting): \$333,400

- 9.25 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy, and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts with expertise drawn from the fields of economic development, social development and environmental protection who reflect adequate geographical and gender balance. Its membership includes experts who are able to make a

contribution on emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.

- 9.26 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. The Council decides on the programme of work of the Committee. The Committee meets in annual session for five working days and submits its report to the Council at its substantive session in July. The General Assembly, the Secretary-General and the subsidiary bodies of the Council may propose, through the Council, issues for consideration by the Committee. With respect to the submission of its report to the Council, the Committee has decided that its Chairman or a designated member should attend the session of the Council to introduce the report and respond to any queries raised. The tenth and eleventh sessions of the Committee for Development Policy are scheduled to be held in 2008 and 2009, respectively.

Committee of Experts on Public Administration

Resource requirements (before recosting): \$312,200

- 9.27 The Committee of Experts on Public Administration was established by the Economic and Social Council in its resolution 2001/45 and consists of 24 experts appointed in their personal capacity by the Council upon the nomination of the Secretary-General. It convened its first session at United Nations Headquarters from 22 to 26 July 2002 and holds annual one-week sessions since 2003 in accordance with Council resolution 2003/60. The Committee is the successor of the former Meeting of Experts on the United Nations Programme in Public Administration and Finance. Its role is to support Member States in building capacity to meet the basic needs of their populations through the discussion of themes relating to the role of the public sector in the development process. The seventh and eighth sessions of the Committee of Experts on Public Administration are scheduled to be held in 2008 and 2009, respectively.

Committee of Experts on International Cooperation in Tax Matters

Resource requirements (before recosting): \$330,200

- 9.28 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members nominated by Governments who act in their expert capacity. They are appointed by the Secretary-General, after notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. As from 2005, the Committee meets on a yearly basis for a period of five days in Geneva. The fourth and fifth sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2008 and 2009, respectively.
- 9.29 The Committee of Experts is mandated to: (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the provision of technical assistance to developing countries and countries with economies in transition; and (e) give special attention to developing countries and countries with economies in

transition in dealing with all the above issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.

United Nations Forum on Forests

Resource requirements (before recosting): \$137,900

- 9.30 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests, and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights. As a functional commission of the Council, the Forum meets annually, for a period of up to two weeks. The Forum also holds a high-level ministerial segment of two to three days duration, as required. The high-level segment includes a one-day policy dialogue with the heads of organizations participating in the Collaborative Partnership on Forests, which ensures the opportunity to receive and consider inputs from representatives of major groups, in particular, through the organization of multi-stakeholder dialogues.
- 9.31 The Forum works on the basis of a multi-year programme of work and is mandated to perform a set of principal functions related to: supporting efforts to achieve the shared global objectives on forests; facilitating the implementation of a non-legally binding instrument on all types of forests; policy development; international coordination among organizations, instruments and institutions; international cooperation; monitoring, assessment and reporting; and strengthening political commitment. The Economic and Social Council, in its resolution 2006/49, decided to strengthen the international arrangement on forests and set shared global objectives on forests to achieve progress by 2015. The ninth and tenth sessions of the United Nations Forum on Forests are scheduled to be held in 2008 and 2009, respectively.

Permanent Forum on Indigenous Issues

Resource requirements (before recosting): \$330,200

- 9.32 The Economic and Social Council, in its resolution 2000/22, decided to establish, as a subsidiary organ of the Council, a permanent forum on indigenous issues, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council and 8 members to be appointed by the President of the Council following formal consultation with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency, representative and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.
- 9.33 The Economic and Social Council decided that the Permanent Forum shall hold an annual session of 10 working days at the United Nations Office at Geneva or at United Nations Headquarters or at

such other place as the Permanent Forum may decide in accordance with the existing Financial Regulations and Rules of the United Nations. The seventh and eighth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2008 and 2009, respectively.

2. Special sessions and intergovernmental processes launched by the General Assembly

Follow-up to and implementation of the outcome of the International Conference on Financing for Development

Resource requirements (before recosting): increase of \$105,000

- 9.34 A new, one-time provision of \$105,000, including requirements for general temporary assistance, consultants and experts, travel of staff and contractual services, relates to holding the Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey Consensus, in Doha, in the second half of 2008 in accordance with General Assembly resolution 61/191. The review conference should assess progress made, reaffirm goals and commitments, share best practices and lessons learned, and identify obstacles and constraints encountered, actions and initiatives to overcome them and important measures for further implementation, as well as new challenges and emerging issues.

B. Executive direction and management

Resource requirements (before recosting): \$6,021,600

- 9.35 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and approved programme of work. He or she also serves as the convenor of the Executive Committee on Economic and Social Affairs. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs, the Assistant Secretary-General for Economic Development and the Assistant Secretary-General and Special Adviser to the Secretary-General on Gender Issues and Advancement of Women.
- 9.36 The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs assists the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies and overseeing the overall coordination of technical cooperation activities, and serves as Secretary of the United Nations System Chief Executives Board (CEB). The main focus of the Assistant Secretary-General function is strengthening the interaction between the Council and CEB.
- 9.37 The Assistant Secretary-General for Economic Development assists the Under-Secretary-General by overseeing and coordinating data analysis and information and, in particular, providing senior substantive policy guidance within the Department in the areas of macroeconomic analysis, financing for development, economic and social monitoring, data gathering and dissemination and knowledge management.
- 9.38 The functions of the Special Adviser on Gender Issues and Advancement of Women and the staffing requirements of her office are reflected under subprogramme 2, Gender issues and advancement of women.
- 9.39 The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretary-General for Policy Coordination and Inter-

Agency Affairs and the Assistant Secretary-General for Economic Development on the planning, coordination, management and assessment of the programme of work of the Department. The Office also assists the Under-Secretary-General in his or her capacity as the Programme Manager of the Development Account.

9.40 The amount of \$4,633,800 for posts reflects an increase of \$178,700, representing the net result of: (a) the inward redeployment of one P-4 post from the Communications and Information Management Service of programme support (\$322,300), which would create the central capacity for strengthening and coordinating results-based budgeting and results-based management in the Department and strengthen the programme coordination of the Development Account, which has become a major responsibility of the Office, with 90 projects completed or under implementation;



- 9.44 The amount of \$11,751,200 provides for the continuation of 46 posts, including 27 Professional and above and 19 General Service posts, to service meetings of intergovernmental and other bodies, such as the Second Committee of the General Assembly, the Economic and Social Council, the Committee on Non-Governmental Organizations and ad hoc advisory groups on African countries emerging from conflict; preparation of parliamentary documentation, publications and technical material (website, newsletters, brochures) for these meetings; organization of technical cooperation activities (seminars, workshops, field projects); support for the triennial comprehensive review process; and provision of substantive servicing and support to the Development Cooperation Forum and the annual ministerial review. The amount of \$788,300 for non-post requirements, reflecting an increase of \$225,000, provides mainly for: (a) consultants; (b) experts groups; (c) travel of staff; (d) contractual services; and (e) the contribution by the United Nations to the CEB Subcommittee on Nutrition. The increase of \$225,000 reflects additional requirements for the annual ministerial review and the Development Cooperation Forum.

Subprogramme 2

Gender issues and advancement of women

Resource requirements (before recosting): \$10,370,900

- 9.45 The subprogramme will be implemented by the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women. It has been formulated on the basis of subprogramme 2 of programme 7 of the biennial programme plan for the period 2008-2009. The subprogramme supports the mainstreaming of gender perspectives in the work of the United Nations, the improvement of the gender balance and of gender equality in the United Nations Secretariat and the promotion of a more gender-sensitive work environment.
- 9.46 The Special Adviser reports directly to the Secretary-General on gender equality issues, including the progress made by departments and offices within the United Nations system in mainstreaming a gender perspective in all areas of work. The Special Adviser, assisted by the Focal Point for Women in the Secretariat, supports and advises programme managers in their efforts to meet General Assembly-mandated targets on gender balance. As Chairperson of the Inter-Agency Network on Women and Gender Equality, the Special Adviser provides leadership in the area of gender mainstreaming in both the substantive and operational areas.

- 9.47 The Division for the Advancement of Women reports to the Under-Secretary-General of the Department of Economic and Social Affairs through the Special Adviser on Gender Issues and Advancement of Women. It provides substantive services to the Commission on the Status of Women as well as the Economic and Social Council and General Assembly on items relating to gender equality and women's human rights. It also provides substantive and technical servicing to the Inter-Agency Network on Women and Gender Equality.

- 9.50 The amount of \$9,638,500 provides for the continuation of 37 posts, which include 5 Professional and above and 4 General Service posts in the Office of the Special Adviser to the Secretary-General on Gender Issues and Advancement of Women and 18 Professional and above and 10 General Service posts in the Division for the Advancement of Women. The staff members are required to coordinate inter-agency work on gender mainstreaming, women, peace and security, violence against women and improvement of the status of women throughout the United Nations system; service the Inter-Agency Network on Women and Gender Equality; service gender equality agenda items in intergovernmental meetings; support the Bureau of the Commission on the Status of Women; organize the participation of non-governmental organizations in gender equality activities of the Organization; monitor and report on follow-up and implementation of the Beijing Platform for Action; carry out outreach activities through publications and events; and provide technical assistance to Member States on request. The amount of \$732,400 for non-post requirements, reflecting a decrease of \$233,100, provides primarily for: (a) consultants; (b) expert groups; (c) travel of staff; and (d) other operating expenses. The decrease of \$233,100 results from the discontinuation of the one-time general temporary assistance provision to support additional sessions of the Committee on the Elimination of Discrimination against Women in the biennium 2006-2007.

- 9.55 The amount of \$15,037,600 provides for 60 posts and includes an increase of \$125,800 resulting from the full funding of one P-3 post, established in the biennium 2006-2007. The continuing 60 posts include 39 Professional and above and 21 General Service posts and are required to provide normative, analytical and operational support to Member States and intergovernmental and non-governmental organizations on a broad range of socio-economic issues through monitoring of national and global trends and emerging issues; substantive servicing of intergovernmental meetings; promotion of dialogue with major stakeholders; preparation of reports and publications; organization of expert group meetings, seminars, and panel discussions; and provision of advisory services. The amount of \$1,289,400 for non-post requirements, reflecting a decrease of \$38,300, provides, inter alia, for: (a) general temporary assistance; (b) consultants; (c) experts groups; (d) travel of staff; (e) contractual services; and (f) the contribution to the share of the costs of the Committee for the Promotion and Advancement of Cooperatives. The decrease of \$38,300 results from the transfer of the provision for general operating expenses to programme support, which manages the Department's resources in this regard.

- 9.82 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) policymakers at the national and international levels are fully engaged in the follow-up to the implementation of the Monterrey Consensus and related outcomes; and (b) relevant stakeholders in the financing for development process have sustained resources and capacity for attaining the internationally agreed development goals and objectives.

- 9.86 The amount of \$3,930,600 provides for the continuation of 17 posts, including 7 Professional and above and 10 General Service posts, to assist the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration, together with administrative and programme support for the implementation of the operational programmes of the Department, including the Development Account, technical cooperation activities and extrabudgetary projects. The amount of \$4,395,200 for non-post requirements, reflecting a net increase of \$89,400, provides mainly for: (a) general temporary assistance; (b) contractual services/data-processing services; and (c) general operating expenses and other operating requirements of the Department. The net increase of \$89,400 is largely the result of an increase under contractual services to cover the Department's share of centrally provided data-processing services and maintenance of office automation equipment to cover the cost of a maintenance service-level agreement for centrally provided services, partly offset by a decrease under communications owing to the "right to use" charges policy.

2. Communications and Information and Management Service

Resource requirements (before recosting): \$2,715,200

- 9.87 The Communications and Information Management Service, reporting to the Under-Secretary-General, is responsible for providing information technology and communications services to the Department, including the development and coordination of access to electronic information resources in the economic and social fields. The Service has four main responsibilities: to formulate policies and strategies in the areas of knowledge management, electronic technical cooperation, website communications, publishing and electronic administration; to advance those policies and strategies through concrete information system projects; to acquire, manage and produce electronic information content; and to support operations in the form of network administration, computer help desk, database administration, information technology asset management and videoconferencing.
- 9.88 As the Department develops and maintains the economic and social development section of the United Nations website, the Service provides information content, as well as technical advice and training to content managers and web assistants. It also promotes knowledge-sharing in economic and social development and takes part in departmental strategic planning.
- 9.89 The Service produces a monthly electronic newsletter on the work of the Department called DESA News, a weekly electronic bulletin (DESAalert) and publications alerts, distributed to all staff in the

Department, permanent missions, regional coordinators and country teams. It designs and builds information systems and customizes enterprise applications to support the programmatic objectives of the Department.

- 9.90 The amount of \$2,549,700 provides for 10 posts and reflects a decrease of \$322,300, resulting from the outward redeployment of a P-4 post to the Office of the Under-Secretary-General. The functions of the post, involving, inter alia, database design and construction, and development and customization of new and existing software application components, will be implemented through the efficient use of the existing expertise, supplemented by general temporary assistance and contractual services. The 10 continuing posts include 7 Professional and above and 3 General Service posts to provide communications and information management services to the Department, including knowledge-sharing; knowledge and information policy formulation; web publishing; preparation and dissemination of electronic newsletters and alerts; website development; multilingual web content planning, coordination and preparation; publications support; management of electronic web forums; systems analysis and development; database design, construction and management; network administration; second-tier computer help desk support; information technology asset management and videoconferencing. The amount of \$165,500 for non-post requirements largely provides for: (a) contractual services; (b) supplies and materials; and (c) acquisition and replacement of office automation equipment.

E. Advance to the United Nations International Research and Training Institute for the Advancement of Women

- 9.91 By its resolution 60/229, the General Assembly approved an advance of \$1,042,200 for INSTRAW for 2006, in full support to the current efforts to revitalize the Institute and to provide it with the requisite funds to enable it to carry out its core functions for the biennium 2006-2007. A reduction for the one-time provision, by the same amount, is applied against grants and contributions in the estimates for the biennium 2008-2009.

The Advisory Committee points out that the wide variety of data available through the Department of Economic and Social Affairs can be utilized to obtain the new statistical information required. For example, a combination of regional housing, environment and trade statistics can be tailored to provide useful information for various sections. The Committee has noticed that each organizational entity tends to operate independently instead, creating data and analyses from scratch. The Committee is of the opinion that an integrative data management mechanism/system would maximize use of the Organization's scarce resources and increase the efficiency with which data can be made available for a wide range of purposes. Such an approach would also provide an opportunity for savings on the resources required for publications since it would permit consolidation and rationalization of the publications programme for all entities through collaborative and/or dual-use issues (para. IV.13).

The Advisory Committee recommends that the Department initiate a comprehensive review, preferably using in-house services provided by the Office of Internal Oversight Services, to identify quantitative and qualitative data available, tracing that data to actual client needs with a view to bringing about the streamlining of and savings on the programmes contained in part IV of the proposed programme budget (para. IV.14).

secretariat of the Permanent Forum on Indigenous Issues, provides substantive and technical support to the intergovernmental process, Member States, civil society and other relevant bodies within the United Nations system on matters concerning indigenous issues.

As the users of statistics and data are increasingly demanding customized access to information via the Internet, the Statistics Division in the Department of Economic and Social Affairs has launched a programme to improve data dissemination via the Internet. The project develops further the concept of the common database, which is an Internet-based data depository allowing the user direct access to over 400 key indicator series. These indicator series cover a broad spectrum of statistical fields (inter alia, economic, social and environmental). The information stems from the basic databases of the Statistics Division/Department of Economic and Social Affairs or is collected from United Nations agencies.

The Statistics Division is now developing over a three-year period (2006-2008) a data retrieval system, which will allow the user to access a broader spectrum of databases managed and maintained by various United Nations entities. This system will also enhance the data presentation features (tables, graphs, maps).

At the request of the United Nations Statistical Commission, the Statistics Division conducted an in-depth analysis of data availability in the United Nations system (E/CN.3/2006/14). This study focused on Millennium Development Goal indicators, for which the General Assembly is the main client, in order to conduct its annual assessment of progress. The study was supported by an independent group of country experts (Friends of the Chair Group on Development Indicators) as well as by the Inter-Agency and Expert Group on Millennium Development Goal indicators, which coordinates the collection and flow of data among United Nations agencies. 

Such a capacity would enhance feedback with intergovernmental bodies and determine the efficiency and effectiveness of measures undertaken as part of the above-mentioned information sharing and data management centre project (para. IV.15).
