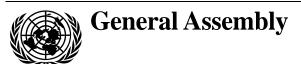

Following a pilot phase in selected missions in 2005/06, the knowledge management system for the collection and sharing of peacekeeping best practices was rolled out to other peace operations. The system is based on the work of field best practices officers, the best practices toolbox, communities of practice and the Department of Peacekeeping Operations Intranet. The toolbox provides guidance and templates for the drafting of handover notes, end of assignment reports, after action reviews and surveys of practice, all knowledge-sharing reports that allow practitioners to document tested good practices in peacekeeping matters, as well as to flag and provide recommendations for areas requiring improvements. Communities of practice connect staff performing similar work in different missions and thus facilitate the lateral exchange of lessons, experience and good practices between practitioners. In parallel, an analytical process to identify trends from knowledgesharing reports was established in the form of the review of trends. The review is presented twice a year to the expanded senior management team, with a view to contributing to the Department's policy agenda. Finally, efforts are being made to further disseminate best practices materials through the publication of a regular newsletter and advertisement of new products on the Department of Peacekeeping Operations Intranet
