## Annex to the identical letters dated 27 July 2015 from the Chargé d'affaires a.i. of the Permanent Mission of Lebanon to the United Nations addressed to the Secretary-General and the President of the Security Council

## Land violations

Date	Time	Nature of violation
1 June 2015	0800-1230	In the area around Ruwaysat al-Alam inside the occupied Shab'a Farms, the Israeli enemy began to build a road from Ruwaysat al-Alam to the area opposite observation point OP3 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL).
	1305	At the Summaqah post in the occupied Shab'a Farms, the Israeli enemy fired several bursts of medium-weapons fire towards the Syrian herder Husam Ukashah while he was herding livestock near Birkat Ba'tha'il on the outskirts of the town of Kafr Shuba inside Lebanese territory.
	1600	On the outskirts of the town of Shab'a at the Shahal locality, an Israeli enemy patrol comprising 15 soldiers violated the line of withdrawal, entering some 50 metres into Lebanese territory. They tried unsuccessfully to abduct the herder Muhammad Zahrah, who fled with his livestock. The enemy patrol then positioned itself at observation point OP2 of the UNIFIL Indian contingent, where there were no personnel present. The enemy patrol left in the direction of the occupied Shab'a Farms at 1715 hours.
2 June 2015	1315	From inside occupied Palestinian territory near the Hanita position opposite the town of Alma al-Sha'b, Israeli enemy personnel blasted rocks on a road that they were renovating. In so doing, they scattered rocks and stones into Lebanese territory near a Lebanese Army patrol, without injury.
	1400-1830	The Israeli enemy continued the road works that were begun on 1 June 2015 in the area around Ruwaysat al-Alam opposite observation points OP3 and OP4 of the UNIFIL Indian contingent.
	1825	While an Israeli Army enemy patrol comprising two vehicles was passing on the dirt road adjacent to the technical fence, near the Bayad position opposite the town of Blida, its soldiers directed obscene hand gestures and offensive and provocative noises at Lebanese Army soldiers inside the Bi'r Shu'ayb observation point. The enemy patrol then continued on its way towards the Bayad position.

Date	Time	Nature of violation
3 June 2015	1000	Inside the occupied Shab'a Farms at the Jabal al-Rus-Saddanah locality, the Israeli enemy continued the building work that was begun on 1 June 2015 at that location opposite observation points OP3 and OP4 of the UNIFIL Indian contingent, using a D9 bulldozer and two trench diggers escorted by a patrol comprising 15 soldiers and two Merkava tanks. They left in the direction of occupied territory at 1800 hours.
4 June 2015	0750	Opposite Sahl al-Khiyam, an Israeli enemy patrol comprising two four-wheel drive vehicles arrived. Five soldiers stepped out and positioned themselves along the technical fence. One of them shouted at a person named Mahmud Sarhan while he was herding livestock in Sahl al-Khiyam inside Lebanese territory, using provocative language in Arabic. When he was unable to get his attention, the enemy soldier directed insults, curses and obscene language towards him.
	0930-1645	The Israeli enemy finished the road works that had begun on 1 June 2015 in the area around Ruwaysat al-Alam opposite observation points OP3 and OP4 of the UNIFIL Indian contingent.
7 June 2015	1930-2000	Inside the occupied Shab'a Farms, the Israeli enemy opened fire with medium and light weapons.
8 June 2015	0800	Inside the occupied Shab'a Farms between the Ruwaysat al-Alam post and observation point OP4 of the UNIFIL Indian contingent, the Israeli enemy installed iron posts and strung them with barbed wire in the area to which Lebanon maintains a claim.
	1550-1635	In the area around the Ruwaysat al-Alam post in the occupied Shab'a Farms, the Israeli enemy fired intermittent bursts of mediumweapons fire. Explosions were also heard in the Shab'a Farms.
9 June 2015	0620	Inside occupied Palestinian territory opposite the Maysat checkpoint, an Israeli enemy patrol comprising 30 soldiers arrived with a dog. They opened the gate, crossed the technical fence and went down along the bank of the Wazzani river without crossing the Blue Line. They then conducted a foot patrol in the direction of pillar No. 40. A Merkava tank also arrived opposite the checkpoint and positioned itself behind the earthen berm inside occupied territory. The patrol left in the direction of occupied territory at 0845 hours.
	1030-1445	Inside the occupied Shab'a Farms, an Israeli enemy patrol comprising five soldiers and two tanks arrived at the Ruwaysat al-Alam locality opposite observation point OP3 of the UNIFIL Indian contingent. They took down the Lebanese flag that had been placed on the barbed wire fence that day by Deputy Qasim Hashim and a group of youths.

	1750-1900	Israeli enemy forces fired several artillery shells and bursts of gunfire from their positions in the occupied Shab'a Farms in the direction of the area adjacent to those positions.
11 June 2015	1300	On the outskirts of Kafr Shuba opposite Birkat Ba'tha'il, Israeli enemy personnel erected two earthen berms and raised the flag of the Zionist entity above them, as well as another yellow flag (the banner of the unit deployed in the occupied Shab'a Farms). They also erected a tent near the earthen berm on the occupied side.
12 June 2015	0800	On the outskirts of the town of Kafr Shuba at the Birkat Ba'tha'il locality, an Israeli enemy patrol comprising eight soldiers crossed the line of withdrawal, entering some 50 metres into liberated Lebanese territory. Two of the patrol's soldiers took up combat positions near an old container adjacent to the line of withdrawal. Four others positioned themselves behind trees. The two remaining soldiers advanced to observation point OP4-14 of the UNIFIL Indian contingent located near the location. The enemy patrol left in the direction of occupied territory at 0816 hours.
	2025-2115	From inside the occupied Shab'a Farms, the Israeli enemy fired two flare bombs accompanied by bursts of medium machine-gun fire in the area around Ruwaysat al-Alam inside the Shab'a Farms.
14 June 2015	0530	In the occupied Shab'a Farms on the outskirts of Ruwaysat al-Alam, the Israeli enemy completed the road works that had begun on 1 June 2015 opposite observation point OP3 of the UNIFIL Indian contingent.
	1147	From inside the occupied Shab'a Farms opposite the Lebanese Army Maysat checkpoint, an Israeli enemy patrol comprising five Land Rover vehicles and two Humvees arrived, and 12 soldiers stepped out. They crossed the iron gate and walked along the technical fence towards observation point OP8. At 1203 hours, two Humvee vehicles and a Land Rover crossed the iron gate in the technical fence by some 50 metres. One of the vehicles pointed a 12.07 mm calibre machine gun at the Lebanese Army Maysat position.
	1400	Inside Shab'a Farms at the Zarqa locality, an Israeli enemy patrol crossed the line of withdrawal, entering some 150 metres into Lebanese territory, and tried to abduct the herders Yusuf Zahrah, Khidr Nab'ah and Muhammad Hashim, who managed to flee towards the town of Shab'a. The enemy patrol subsequently led the livestock towards occupied territory. All of the livestock returned towards the town of Shab'a at 1730 hours.
16 June 2015	0600-0900	Several explosions were heard coming from inside the occupied Shab'a Farms.

17 June 2015	1515-1540	From its position in Jall al-Alam opposite Labbunah, an Israeli enemy soldier aimed a vehicle-mounted MAG machine gun and directed curses in Arabic at Lebanese Army soldiers while conducting a patrol on the border between Lebanon and occupied Palestine.
23 June 2015	0700-0900	Several explosions were heard from inside the occupied Shab'a Farms, interspersed with intermittent combing of the area by the Israeli enemy with medium machine gun fire inside the Farms.
	2150	From inside occupied territory opposite Kafr Killa, an Israeli enemy vehicle directed a searchlight at Lebanese territory.
25 June 2015	0800-0900	Several explosions were heard from inside the occupied Shab'a Farms. The Israeli enemy also fired several bursts of medium weapons fire at the area around its positions.
	1030	While an Israeli enemy patrol was inspecting sensors on the technical fence inside occupied Palestinian territory opposite the Kafr Killa-Udaysah road near crossing B82, one of its soldiers directed an offensive expression at a Lebanese Army patrol located on the Lebanese side. The enemy patrol left in the direction of occupied territory at 1140 hours.

7 June 2015	2130	From inside occupied Palestinian territory opposite Ra's al-Naqurah, Israeli enemy soldiers directed a searchlight at Lebanese territorial waters for 30 seconds.
