Land violations committed in June 2016

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 June	0945	From inside occupied Palestinian territory east of the town of Alma al-Sha'ab, an Israeli enemy patrol consisting of 20 personnel and a dog crossed through the metal gate of the technical fence and headed north along the fence for some 600 metres, conducting an inspection of the surrounding area. When a Lebanese Army patrol inspected the area subsequently, it found a recently opened can of tuna and an empty water bottle holder with Hebrew writing on it, approximately 15 metres north of the Blue Line opposite point B15. The stump of a recently cut tree was also observed at the same location.
2 June	1420	At the Hasan Gate on the outskirts of the town of Kafr Shuba, an Israeli enemy soldier crossed the line of withdrawal some 30 metres into Lebanese territory for 10 minutes. He fired seven shots from his firearm at a herd of goats in an unsuccessful effort to herd them into occupied territory.
	1939	In the Bastra area, eight Israeli enemy soldiers crossed the Blue Line for a one minute.
4 June	2135 2140	From inside occupied Palestinian territory opposite the town of Mays al-Jabal near point B64, an Israeli enemy patrol comprising two Hummer vehicle directed a searchlight at Lebanese territory.
5 June	1400	Between the towns of occupied Ghajar and Abbasiyah in what is called the B14 area, the Israeli enemy set fire to some dry brush, causing a fire to break out in an area of 12 dunums inside Lebanese territory. The fire was put out by the Civil Defence at 1730 hours.
	2130	In the Bastra area, an Israeli enemy soldier crossed the Blue Line for a one-minute period.
7 June	0900	Opposite the town of Sarda, near the Ibl al-Qamh firing range, an Israeli enemy patrol comprising a bulldozer, a trench digger, a truck, a Merkava tank and a military vehicle approached and performed some work on a trench. One of the soldiers pointed the tank's cannon at Lebanese territory. The work concluded at 1715 hours and the vehicles left towards occupied Palestinian territory.
	1115	Opposite the town of Labbunah, near point <i>ghayn-9</i> , an Israeli enemy patrol pointed a 12.7 mm military weapon mounted on a Hummer vehicle at members of a Lebanese Army patrol and made obscene gestures.
	1150	Inside the occupied Shab'a Farms, an Israeli enemy crane pulled up the metal gate on the Radar post road, opposite observation point OP2 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL), and replaced it with cement blocks. It left at 1230 hours.

	1200 1800	Inside the occupied Shab'a Farms, enemy Israeli forces pitched three camouflage tents in the woods west of the Fashkul post.
	2000	On the outskirts of town of Shab'a, in the Shahl area, the Israeli enemy herded some 50 goats belonging to Isma'il Zahrah to one of its positions in the occupied Shab'a Farms.
11 June	1724 1751	From inside occupied Palestinian territory opposite observation point 28-4 of the Spanish UNIFIL contingent, an Israeli enemy patrol comprising two Hummer vehicles approached, and one of its members aimed a rifle at the observation point.
	2140 2240	The Israeli enemy fired several flares over its Radar post in the occupied Shab'a Farms.
12-13 June	2330 0030	Inside the occupied Shab'a Farms, the Israeli enemy fired five flares over the area around its Radar post.
14 June	2215 2315	Inside the occupied Shab'a Farms, the Israeli enemy fired three flares over the area around its Radar post.
15 June	1615	Near the Shaykh Abbad position opposite the town of Hula, Israeli enemy soldiers pointed a Merkava tank cannon at Lebanese territory.
	1900 1945	From its Radar position inside the occupied Shab'a Farms, the Israeli enemy fired several bursts of medium machine gun fire at the surrounding area.
17 June	1530	From inside occupied Palestinian territory opposite Ra's al-Naqurah, a member of an Israeli enemy patrol directed obscene gestures at a member of a Lebanese Army patrol.
20 June	1645	In the Jard area on the outskirts of the town of Shab'a, while the civilian Yusuf Zahrah was herding livestock, personnel at the Israeli enemy Radar post fired machine guns into the air towards Lebanese territory to frighten the herder and his flock, without hitting anyone.
21 June	0600 0830	From inside the occupied Shab'a Farms, explosions interspersed with medium machine gun fire were heard in the area around the Ruwaysat al-Alam post and Jabal al-Rus.
24 June	1745 1900	Inside the occupied Shab'a Farms, the Israeli enemy sprayed the area around the Radar post with medium machine gun fire.
28 June	0910	From inside occupied territory near the Israeli enemy Labbunah-Jall al-Alam position, hostile personnel aimed weapons mounted on an armoured vehicle at a Lebanese Army patrol.
30 June	1745	From inside occupied Palestinian territory, opposite point BP2, members of an Israeli enemy patrol pointed their firearms and directed obscene gestures at members of a Lebanese Army patrol.

1 June	0418	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a three-minute period, and proceeded on its way for some 221 metres. The launch then left in the direction of occupied Palestinian territorial waters.
2 June	0548	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a seven-minute period, and proceeded on its way for some 300 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1830	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a three-minute period, and proceeded on its way for some 314 metres. The launch then left in the direction of occupied Palestinian territorial waters.
3 June	0310	From inside occupied Palestinian territorial waters, off Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a period of 10 minutes, and broadcast over a loudspeaker in Arabic.
	0325	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a two-minute period, and proceeded on its way for some 175 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0335	From inside occupied Palestinian territorial waters, off Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a period of five minutes, and spoke over a loudspeaker in Arabic.
	0415	From inside occupied Palestinian territorial waters at its position opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territorial waters for a period of five minutes.
	0734	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of one minute, and proceeded on its way for some 240 metres. The launch then left in the direction of occupied Palestinian territorial waters.
4 June	0017	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a five-minute period, and proceeded on its way for some 370 metres. The launch then left in the direction of occupied Palestinian territorial waters.
5 June	2135	From inside occupied Palestinian territorial waters at its position opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territorial waters for a period of 15 seconds, and at Lebanese Army point B3 for a period of 15 seconds.

6 June	0215	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a five-minute period, and proceeded on its way for some 445 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0245	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a four-minute period, and proceeded on its way for some 352 metres. The launch then left in the direction of occupied Palestinian territorial waters. It also twice directed a searchlight towards a Lebanese fishing boat inside Lebanese waters. The first time was at 0215 hours for a period of 15 seconds and the second was at 0243 hours for a period of one minute. It broadcast over a loudspeaker in Arabic towards the fishing boat when shining the searchlight.
	0316	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a 23-minute period, and proceeded on its way for some 369 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0355	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a five-minute period, and proceeded on its way for some 174 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0404	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a nine-minute period, and proceeded on its way for some 300 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0800	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a 35-minute period, and proceeded on its way for some 445 metres. The launch then left in the direction of occupied Palestinian territorial waters.
7 June	1857	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) of 1 October 2011, for a six-minute period, and proceeded on its way for some 296 metres. The launch then left in the direction of occupied Palestinian territorial waters.
8 June	1832	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a two-minute period, and proceeded on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters.
