Identical letters dated 24 August 2016 from the Chargé d'affaires a.i. of the Permanent Mission of Lebanon to the United Nations addressed to the Secretary-General and the President of the Security Council

On instructions from my Government, I transmit to you herewith a statistical summary of Israeli violations of Security Council resolution 1701 (2006) committed during the month of July 2016 (see annex).

I should be grateful if you would have the present letter and its annex issued as a document of the seventieth session of the General Assembly, under agenda item 37, and of the Security Council.

Land violations committed in July 2016

Date	Time	Nature of violation
6 July	1400	In Mahallat al-Zalqa on the outskirts of the town of Shab'a, while Muhammad Hashim was grazing a herd of goats, an Israeli enemy patrol comprising seven soldiers crossed the line of withdrawal (the Blue Line in the area to which Lebanon maintains a claim) into Lebanese territory, where they tried and failed to kidnap him. The patrol then led the herd of approximately 450 head of goats inside the occupied Shab'a Farms. At 1800 hours the entire herd returned to Lebanese territory.
11 July	1950	Opposite Ra's al-Naqurah, Israeli enemy soldiers aimed a machine gun mounted on a vehicle towards Lebanese territory and brandished it in a provocative manner at Lebanese Army soldiers.
12 July	1000	Opposite the town of Rumaysh, near the Khallat al-Budiyah position, the Israeli enemy crossed the technical fence using three D9 bulldozers and a Poclain excavator and worked on the construction of a dirt access road between points B39 and B38-1 (a length of approximately 300 metres) without crossing the Blue Line. The work ended at 1900 hours, and all vehicles withdrew into occupied territory.
	1020	Opposite the town of Ayta al-Sha'b and the Lebanese Army position of Ruwaysat al-Hadab, five Israeli enemy soldiers trained their weapons for two minutes on the aforementioned position from within the position of west Ayta al-Sha'b 2. They then departed into occupied territory.
13 July	0930	From inside occupied territory opposite the town of Rumaysh, near the Khallat al-Budiyah position, the Israeli enemy crossed the technical fence using four D9 bulldozers and an excavator, accompanied by a Merkava tank that directed its cannon towards Lebanese territory. After working on the construction of a dirt road between points B39 and B38-1, without crossing the Blue Line, the vehicles departed into occupied territory.
	1800	A fire broke out inside occupied Palestinian territory opposite point B33, south-west of Rumaysh, spreading approximately 2 km into Lebanese territory. During that time, seven mines exploded.

Date	Time	Nature of violation
14 July	0800 1430	Opposite the towns of Bustan and Marwahin, near point AP263, while a number of Israeli enemy soldiers in civilian and military dress were performing maintenance on the technical fence, one of those soldiers, in civilian dress, made an obscene and provocative finger gesture in the direction of a Lebanese Army patrol inside Lebanese territory.
	2330	From inside occupied Palestinian territory, opposite the town of Udaysah, an Israeli enemy patrol comprising seven Defender vehicles and 25 soldiers approached, patrolling the technical fence and shining searchlights and flashlights towards Lebanese territory opposite the town of Sarda. They left at 0100 hours on 15 July 2016 in the direction of occupied territory.
15 July	1615	Near the Israeli enemy position at Shaykh Abbad opposite the town of Hula, members of a hostile Israeli patrol aimed a Merkava tank cannon in the direction of Lebanese territory.
17 July	1700	From inside occupied Palestinian territory the Israeli enemy caused several explosions over the towns of Blida and Mays al-Jabal.
