Annex to the identical letters dated 21 December 2015 from the Permanent Representative of Lebanon to the United Nations addressed to the Secretary-General and the President of the Security Council

Land violations

Date	Time	Nature of violation
2 November 2015	1300	Inside occupied Palestinian territory, at point B90 opposite Sahl al-Khiyam, an Israeli enemy patrol comprising a white Toyota vehicle, a winch and a construction vehicle arrived. Some 10 personnel disembarked and installed a three-metre pole on which a camera was mounted. The patrol pointed the camera towards Lebanese territory and then left in the direction of occupied territory.
5 November 2015	1040	On the outskirts of the town of Marun al-Ra's near point B51, an Israeli enemy patrol abducted the civilian Ali al-Asi when he approached the technical fence and took him into occupied territory. He was released that same day at 1855 hours.
7 November 2015	1500	Seven Israeli enemy soldiers climbed over the fence opposite the Lebanese Army Kafr Killa position and photographed that position before leaving in the direction of occupied territory at 1525 hours.
	1810	In the occupied town of Ghajar, an Israeli enemy patrol comprising two Hummer vehicles and a Land Rover vehicle arrived at the emplacement opposite the Wazzani spring and directed a searchlight towards Lebanese territory around the spring.
	2120	From inside occupied Palestinian territory opposite Labbunah, the Israeli enemy directed a searchlight at its Jall al-Alam position some 200 metres into Lebanese territory. The Israeli enemy turned off the searchlight on 8 November at 1130 hours.
11 November 2015	1045	From inside occupied Palestinian territory, opposite the Lebanese Army Udaysah checkpoint, an Israeli enemy patrol comprising two Hummer vehicles and a Defender vehicle arrived. Some 10 soldiers disembarked, one of whom pointed a 12.7 mm machine gun mounted on one of the vehicles at the checkpoint. The hostile patrol left in the direction of occupied territory at 1115 hours.
17 November 2015	1900	From inside occupied Palestinian territory, the Israeli enemy directed a searchlight at its Labbunah-Jall al-Alam position towards Lebanese territory.
21 November 2015	1830 2130	From inside occupied Palestinian territory, the Israeli enemy directed a searchlight at its Labbunah-Jall al-Alam position towards Lebanese territory.

Date	Time	Nature of violation
25 November 2015	1700	From inside occupied Palestinian territory, the Israeli enemy directed a searchlight at its Tall al-Rahib position towards Lebanese territory opposite the town of Ayta al-Sha'b.
27 November 2015	1300	On the outskirts of the town of Shab'a, opposite observation point OP3 manned by the Indian contingent of the United Nations Interim Force in Lebanon, an Israeli enemy foot patrol attempted to abduct the livestock herder Yusuf Zahra. The attempt was unsuccessful, and the herder returned in the direction of the town of Shab'a with his livestock.

Date	Time	Nature of violation
4 November 2015	1715	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) of 1 October 2011, proceeding some 330 metres into Lebanese territorial waters over a three-minute period before leaving in the direction of occupied Palestinian territorial waters.
	1724	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 240 metres into Lebanese territorial waters over a one-minute period before leaving in the direction of occupied Palestinian territorial waters.
	1725 1840	From inside occupied Palestinian waters, an Israeli military launch directed a searchlight towards Lebanese territorial waters for two periods of 30 seconds and one minute, respectively.
	1800	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 370 metres into Lebanese territorial waters over a four-minute period before leaving in the direction of occupied Palestinian territorial waters.
8 November 2015	0250 0325	From inside occupied Palestinian waters, an Israeli military launch directed a searchlight towards Lebanese territorial waters for two periods of 15 seconds each.
9 November 2015	0800	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 260 metres into Lebanese territorial waters over a two-minute period before leaving in the direction of occupied Palestinian territorial waters.

12 November 2015	0410	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 90 metres into Lebanese territorial waters over a 50-minute period, during which it released an explosive charge and used a megaphone and a siren to warn off a Lebanese fishing vessel that was within Lebanese territorial waters, before leaving in the direction of occupied Palestinian territorial waters.
15 November 2015	1515	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 40 metres into Lebanese territorial waters over a one-minute period before leaving in the direction of occupied Palestinian territorial waters.
	2040	From occupied Palestinian territory at its position opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territorial waters for a period of 30 seconds.
19 November 2015	1335	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 185 metres into Lebanese territorial waters over a five-minute period, during which it released a diver at the location of what is known as the "third buoy", before leaving in the direction of occupied Palestinian territorial waters.
24 November 2015	0001	From inside occupied Palestinian territorial waters opposite Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a period of 30 seconds.
	0001 0015	From inside occupied Palestinian territory at its position opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territorial waters for three periods of 30 seconds each.
25 November 2015	0735	Opposite Ra's al-Naqurah 500 metres from the Lebanese coast, two Israeli enemy military launches violated the southern maritime boundary established by Decree No. 6433 (2011) as follows: The first launch proceeded some 165 metres into Lebanese territorial waters, where it released two divers who installed a small red buoy in place of the original second buoy, which was moved approximately 15 metres to the south. The second launch proceeded some 95 metres into Lebanese territorial waters. The two hostile launches left Lebanese territorial waters in the direction of occupied Palestinian territorial waters at 0920 hours.
27 November 2015	1509	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), proceeding some 110 metres into Lebanese territorial waters over a two-minute period before leaving in the direction of occupied Palestinian territorial waters.

2 November 2015	0730	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Killa and flying north. It circled over the Western Bekaa, the South and Beirut and its suburbs before leaving at 2150 hours over Rumaysh.

9 November 2015	1000	Two Israeli enemy warplanes violated Lebanese airspace, entering over Kafr Killa. They circled over all regions of Lebanon before leaving at 1150 hours over Aytarun.
10 November 2015	1025	Two Israeli enemy warplanes violated Lebanese airspace, entering over the sea off Tyre. They circled over the South before leaving at 1050 hours over Aytarun.
11 November 2015	1730	Two Israeli enemy warplanes violated Lebanese airspace, entering over Kafr Killa. They circled over all regions of Lebanon before leaving at 1845 hours over the sea west of Naqurah.
12 November 2015	0805	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Alma al-Sha'b. It circled over Riyaq, Baalbek, Hirmil, Beirut, Ba'abda and Matn before leaving at 1730 hours over Kafr Killa.
	1020	Two Israeli enemy warplanes violated Lebanese airspace, entering over Kafr Killa. They circled over all regions of Lebanon before leaving at 1150 hours over the sea west of Naqurah.
13 November 2015	0800	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Killa. It circled over Riyaq, Baalbek and Hirmil before leaving at 1700 hours over Rumaysh.
