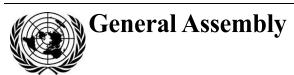

# Note by the Secretary-General

#### Addendum

- 1. The Secretary-General has received notification of the resignation of Catherine Vendat (France) from the Advisory Committee on Administrative and Budgetary Questions, effective 29 April 2017. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Ms. Vendat, which expires on 31 December 2019.
- 2. The Government of France has nominated Olivier Myard to fill the vacancy arising from the resignation of Ms. Vendat.
- 3. In a communication dated 28 April 2017, the Secretary-General was informed by the Chair of the Group of Western European and other States that the candidature of Mr. Myard had been endorsed by the Group.

introduced an audit rating in each audit report; set up a new evaluation unit and an investigative activity; introduced a web-based tracking system for the recommendations follow-up; together with quarterly meetings with all Directors to follow-up on the implementation of recommendations, contributing to a significant drop in the number of overdue recommendations (now in Directors' annual objectives, following my proposal); introduced and developed dashboards for the follow-up of all activities of the Office; introduced a new internal audit reports disclosure policy, started a Plan of Actions (2013-2017) aiming to position the Office at a higher level in the Institute of Internal Auditors (IIA) maturity matrix.

• Reason for leaving: End of fixed term mandate (after two extensions beyond the mandatory age of separation).
