Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Advisory Committee on Administrative and Budgetary Questions

Report of the Fifth Committee

1. At its 2nd plenary meeting, on 16 September 2016, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-first session the item entitled “Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Advisory Committee on Administrative and Budgetary Questions” and to allocate it to the Fifth Committee.
2. At its 12th meeting, on 4 November 2016, the Fifth Committee had before it the following documents:
 - (a) Note by the Secretary-General concerning the vacancies in the membership of the Advisory Committee on Administrative and Budgetary Questions that would occur as a result of the expiration of the term of office of six of its members on 31 December 2016 ([A/71/101/Rev.1](#));
 - (b) Note by the Secretary-General containing the names of eight persons nominated by their respective Governments for appointment or reappointment to the Advisory Committee on Administrative and Budgetary Questions for a three-year term of office beginning on 1 January 2017 ([A/C.5/71/4](#)).
3. At the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint Takeshi Akamatsu (Japan), Mahesh Kumar (India) and Ye Xuenong (China) as members of the Advisory Committee on Administrative and Budgetary Questions for a three-year term of office beginning on 1 January 2017 (see para. 8).
4. Also at the same meeting, the Committee proceeded to select, by secret ballot, one person from the two candidates nominated by the Latin American and Caribbean States. The result of the voting was as follows:

5. Having obtained the required majority, Carlos Ruiz Massieu (Mexico) was recommended for reappointment as a member of the Advisory Committee on Administrative and Budgetary Questions for a three-year term of office beginning on 1 January 2017 (see para. 8).

6. At the same meeting, the Committee proceeded to select, by secret ballot, two persons from the three candidates nominated by the Western European and other States. The result of the voting was as follows:
