## ***Repertory of Practice of United Nations Organs and Repertoire of the Practice of the Security Council***

### **Report of the Secretary-General**

#### *Summary*

In conformity with General Assembly resolution [75/140](#), the present report provides an outline of the progress made by the Secretariat between 1 July 2020 and 30 June 2021 in updating the *Repertory of Practice of United Nations Organs* and the *Repertoire of the Practice of the Security Council*. The Assembly is invited to take action in the light of the conclusions drawn in paragraphs 17 and 31.

## I. Introduction

1. The present report has been prepared pursuant to General Assembly resolution [75/140](#). It provides information on the progress made by the Secretariat between 1 July 2020 and 30 June 2021<sup>1</sup> in updating the *Repertory of Practice of United Nations Organs* and the *Repertoire of the Practice of the Security Council*. It examines the respective mandates and workflow in the preparation of these publications, in printed and electronic forms, and gives an overview of the available resources and existing modalities of cooperation with academic institutions, associate experts, temporary staff and consultants, as appropriate. The Assembly is invited to take action in the light of the conclusions drawn in paragraphs 17 and 31.

## II. *Repertory of Practice of United Nations Organs*

### A. Mandate and preparation of supplements to the *Repertory*

2. The *Repertory of Practice of United Nations Organs* was originally mandated by the General Assembly in its resolution [796 \(VIII\)](#) of 27 November 1953. Its purpose is to document the Organization's application and interpretation of each individual Article of the Charter of the United Nations, to form a legislative history contributing to the knowledge and understanding of the Charter as applied in the practice of the organs of the United Nations.

3. Bearing in mind the call made upon the Secretary-General, in paragraph 16 of General Assembly resolution [75/140](#), to address, effectively and on a priority basis, the backlog in the preparation of volume III of the *Repertory*, the Codification Division of the Office of Legal Affairs, acting as coordinator for the preparation of the *Repertory*, maintained regular contact with the Faculty of Law at the University of Ottawa, Peking University and Korea University. Korea University undertook research and drafting of studies on Articles 43 to 47 of the Charter for volume III of Supplement No. 10 (2000–2009). In addition, a study on Articles 104 and 105 of the Charter, to be included in volume IV of Supplement No. 10, was completed by the Faculty of Law at the University of Ottawa.

4. Progress has also been made in relation to Supplement No. 11 (2010–2015). With the assistance of the Faculty of Law at the University of Ottawa, research and drafting were completed in relation to a study on Article 11 for volume II, which is currently under review by its author department, the Office for Disarmament Affairs. A study on Articles 104 and 105 is still under review by the Office of the Legal Counsel in the Office of Legal Affairs. In addition, following the selection of a consultant by the Department of Economic and Social Affairs in April 2020, to be financed from the trust fund for the elimination of the backlog in the *Repertory*, a study on Article 58 for volume IV was completed and is being finalized by the author department.

5. With regard to Supplement No. 12 (2016–2020), owing to the continued assistance of the Faculty of Law at the University of Ottawa, research and drafting were also completed in relation to three studies, as follows: a study on Article 8 for volume I and two studies for volume III, one on Article 33 and one on Article 51.

6. As is customary, the Department of Global Communications and the Dag Hammarskjöld Library played an important role in supporting the research phase for the *Repertory* studies.

7. Furthermore, during the period under review, the Department for General Assembly and Conference Management published two volumes in electronic format, as follows: volume II in French for Supplement No. 7 (1985–1988) and volume VI in English and French for Supplement No. 8 (1989–1994). All studies included in these volumes were accordingly posted on the *Repertory* website. The current status of the publication is thus as follows: 37 volumes have been published<sup>2</sup> and 7 have been finalized and submitted for translation and editing.<sup>3</sup> Consequently, from among the 63 volumes of which the publication as a whole (original *Repertory* and Supplements Nos. 1 to 12 thereto) should consist, as at 30 June 2021, work remains to be completed on 19 volumes, 4 of which pertain to Supplement No. 10, 6 to Supplement No. 11 and 6 to Supplement 12, which are all at different stages of preparation (see paras. 3–5 above). The other three volumes on which work remains to be completed correspond to volume III of Supplements Nos. 7 and 8 and Supplement No. 9 (1995–1999).

8. Annex I to the present report contains a list of which Secretariat units are responsible for preparing *Repertory* studies on each of the individual Articles of the Charter. Annex II provides information on the status of the *Repertory*.

## **B. Availability of *Repertory* studies on the *Repertory* website**

9. Studies from 44 complete volumes, including the 7 volumes at the translation and editing stages, are available on the United Nations website for the *Repertory* (<http://legal.un.org/repertory>). Advance versions of several studies on individual Articles for volume III of Supplements Nos. 7 to 9, as well as a considerable number of studies for Supplement No. 10 that have been finalized and are awaiting completion of the respective volumes, continue to be made accessible on the website. This is also done for newly completed studies for Supplement No. 11. The electronic version of the *Repertory* includes a full-text search feature, providing users with the opportunity to search all the studies instantaneously for any word or combination of words in the three languages of the publication (English, French and Spanish).

10. Currently, all studies available in English are on the *Repertory* website, and most of them are also available in French and Spanish, while a few are available in only one of these languages. Finalized studies awaiting translation and editing are placed on the *Repertory* website in the language in which they have been prepared (English for most of them and French for some of them). The Secretariat will continue to make available electronically all three language versions of the finalized *Repertory* studies.

## **C. Cooperation with academic institutions and sponsoring of associate experts**

11. The well-established cooperation with the Faculty of Law at the University of Ottawa continued for the eleventh consecutive year. During the period under review, the Faculty of Law contributed to the preparation of five studies (see paras. 3–5 above). Cooperation was also initiated with Korea University, starting in March 2021, thanks to support extended by a member of the International Law Commission and

by the Permanent Mission of the Republic of Korea to the United Nations (see para. 3 above).

12. With a view to revitalizing cooperation with academic institutions and pursuing a diverse geographical spread, the Codification Division, acting as coordinator for the preparation of the *Repertory*, continued to call upon permanent missions to the United Nations to identify academic institutions that may be interested in contributing to the preparation of studies. In the past four years, the Codification Division has had preliminary contact with four universities: two in the South Pacific region, one in the Latin American and Caribbean region and one in the Western European and other States region. The Codification Division continued to invite academic institutions to which members of the International Law Commission are affiliated to consider contributing to the preparation of studies.

13. Furthermore, consistent with paragraph 14 of resolution 75/140, in which the General Assembly reiterated its call for the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the *Repertory*, the Codification Division made an appeal to all permanent missions to the United Nations by a note verbale dated 19 January 2021. As at 30 June 2021, the appeal had led to preliminary contacts with representatives of the Asia-Pacific region and the Latin American and Caribbean region.

#### **D. Trust fund**

14. In its resolution 75/140, the General Assembly reiterated its call for voluntary contributions to the trust fund established pursuant to its resolution 59/44, in order to eliminate the backlog in the *Repertory*. Accordingly, a note verbale was sent on 19 January 2021 to all permanent missions to the United Nations, reminding them of the possibility of making voluntary contributions to the trust fund and inviting them to bring the question of funding for the *Repertory* to the attention of private institutions and individuals that might wish to assist in that regard. The Secretary-General welcomes with appreciation the contribution to the trust fund received during the period under review (1 July 2020 to 30 June 2021) from Qatar, in the amount of \$10,000. The fund balance as at 30 June 2021 was \$89,910.

15. As mentioned above (see para. 4), during the period under review, a consultant, to be financed through the trust fund, completed the research and drafting of a study on Article 58 for volume IV of Supplement No. 11. The further use of consultants for the preparation of studies pertaining to volumes that are nearing completion is envisaged. Additional contributions to the trust fund are therefore strongly encouraged, so as to allow the Secretariat to continue to eliminate the backlog in the *Repertory*.

#### **E. Recommendations of the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization**

16. The Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization considered the question of the *Repertory* and the *Repertoire* at its session held from 16 to 24 February 2021. In paragraph 83 of its report (A/76/33), the Special Committee recommended, with regard to the *Repertory*, that the General Assembly should commend the Secretary-General for the progress made in the preparation of studies, including the use of the internship programme of the United Nations and cooperation with academic institutions for that purpose; further encourage Member States to identify academic

institutions that have the capacity to contribute to the preparation of studies for the *Repertory* and to provide the contact details of such institutions, and in this regard welcome the initiative of the Secretariat to invite members of the International Law Commission to recommend academic institutions that the Secretariat could contact for this purpose; note with appreciation the contributions made by Member States to the trust fund for the elimination of the backlog in the *Repertory*; reiterate its call for voluntary contributions to the trust fund for the elimination of the backlog in the *Repertory*, as well as the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication; call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions, and encourage the continued updating of the website for the *Repertory*; note with concern that the backlog in the preparation of all volumes of the *Repertory*, in particular volume III, although slightly reduced, had not been eliminated, and call upon the Secretary-General to address that issue effectively and on a priority basis, while commending the Secretary-General for progress made in reducing the backlog; and reiterate the responsibility of the Secretary-General for the quality of the *Repertory*.

## **F. Conclusions**

**17. With regard to the *Repertory*, in the light of the foregoing, the General Assembly may wish:**

**(a) To note the current status of the publication, including the progress made in the preparation of *Repertory* studies and in their posting on the Internet in three languages (English, French and Spanish);**

**(b) To consider the recommendations of the Special Committee (see para. 16 above) concerning the use of the internship programme of the United Nations and the cooperation with academic institutions for the preparation of studies; the identification of academic institutions having the capacity to contribute to the preparation of studies for the *Repertory*; the initiative of the Secretariat to invite members of the International Law Commission to recommend academic institutions that the Secretariat could contact for this purpose; the voluntary contributions to the trust fund for the elimination of the backlog in the *Repertory* so as to further support the Secretariat in carrying out the effective elimination of that backlog; the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication; the call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions, the continued updating of the website for the *Repertory* and the call to continue to address effectively and on a priority basis the elimination of the backlog in all volumes of the *Repertory*, in particular volume III; and the reiteration of the responsibility of the Secretary-General for the quality of the *Repertory*;**

**(c) To note the progress made towards the elimination of the backlog through the utilization of the trust fund, and to strongly encourage States to make additional contributions to the trust fund.**

### III. *Repertoire of the Practice of the Security Council*

#### A. Mandate and preparation

18. The *Repertoire of the Practice of the Security Council*, originally mandated by the General Assembly in its resolution 686 (VII) of 5 December 1952, provides a record of the evolving practice and procedure of the Council in the framework of the Charter of the United Nations and the provisional rules of procedure of the Security Council. Most recently, in its resolution 75/140, the General Assembly called upon the Secretary-General to continue to follow the modalities outlined in paragraphs 102 to 106 of his report dated 18 September 1952 (A/2170).

19. In paragraph 11 of resolution 75/140, the General Assembly commended the Secretary-General for the progress made towards updating the *Repertoire*. In paragraph 15, the Assembly called upon the Secretary-General to continue his efforts towards updating the *Repertoire* and making it available electronically in all its language versions.

20. During the reporting period, pursuant to the mandate provided by the General Assembly, the Secretariat continued to make significant progress in the preparation of the Supplements to the *Repertoire*. The focus of the work of the Secretariat over the past year was the preparation of the twenty-second and twenty-third Supplements to the *Repertoire*, covering the years 2019 and 2020, respectively.

21. The Secretariat completed the twenty-second Supplement to the *Repertoire* in October 2020. The advance version of the Supplement has been posted on the website of the Security Council, while the published version is expected to be made available online and in hard copy in the last quarter of 2021. The individual parts of the twenty-third Supplement will be posted online in their advance form as they are completed. The entire twenty-third Supplement is on schedule to be made available online by October 2021, as newly elected members of the Council commence observing proceedings. In line with the methodology for contemporary coverage of the practice of the Council, the Secretariat has commenced research and drafting work for the twenty-fourth Supplement covering the year 2021.

22. The aim of this ambitious schedule for the preparation of the *Repertoire* is to ensure that the invaluable information on the practice of the Security Council is made available to States Members of the United Nations and the public as soon as possible. In order to ensure the sustainability of the contemporary approach to the coverage of the practice of the Council, the Secretariat continued to optimize the limited resources available through efficiency-enhancing initiatives, such as the development of new technologies. During the period under review, using extrabudgetary resources, the Secretariat advanced the development of a new web-enabled database, which would significantly expedite and facilitate the research and drafting of the *Repertoire*. Those efforts have also been aided by the recruitment and training of additional personnel and the increased use of the internship programme, while maintaining the highest standards of accuracy and quality control. The various offices within the Secretariat that are responsible for the complex tasks of editing, translating, indexing and publishing the *Repertoire* made progress on further enhancing coordination and ensuring the most efficient division of labour.

23. In the light of the continued impact of the coronavirus disease (COVID-19) pandemic, the Secretariat has had to maintain a business continuity plan to ensure uninterrupted work on the *Repertoire*. This plan notwithstanding, the impact of the pandemic on the documentation of the Security Council has posed significant challenges to the Secretariat's ability to follow the methodology established for the contemporaneous coverage of the practice of the Council.

## **B. Availability of *Repertoire* studies on the Security Council website**

24. The Secretariat continued to make available advance and published versions of the Supplements to the *Repertoire* on the website ([www.un.org/securitycouncil/content/repertoire/structure](http://www.un.org/securitycouncil/content/repertoire/structure)) of the Security Council immediately upon their completion. The Supplements are searchable and systematized both chronologically and by topic.

25. In the past year, the Secretariat made considerable advances in the use of modern technologies to present various aspects of the practice of the Security Council on the website, in an engaging and accessible manner. New visual and interactive datasets were released on the history of Council membership, on the participation of women in the work of the Council and on the history of the Chairs of subsidiary bodies of the Council. The Secretariat also enhanced the datasets on women and peace and security, on the protection of civilians and on children and armed conflict, with new visual and analytical content.

26. In line with established practice, the *Highlights of Security Council Practice* covering 2020 was published in early January 2021. The publication provides a comprehensive overview of trends in Council meetings and informal engagements, the agenda, decision-making and voting, as well as of the work of its subsidiary organs. The 2020 edition features more engaging and interactive data visualization, including maps and graphs, gender-disaggregated data on representation in the Council's subsidiary bodies and additional information on trends with respect to the virtual working methods adopted by the Council during the COVID-19 pandemic. Most recently, the Secretariat initiated a project for the revamping of the *Repertoire* search engine featured on the Council website, with the objective of improving the accessibility of information for users and the accuracy of search results. Given the value of the information tools on the practice of the Council for Member States and the public at large, the Secretariat actively promoted the *Repertoire* and related information tools on social media, in order to increase awareness and improve the knowledge and quality of the data available on the work and practice of the Council.

27. The Secretariat continued to fulfil and enhance its advisory role through the provision of information in response to questions relating to the procedural and constitutional practice of the Security Council and its subsidiary organs. During the reporting period, the Secretariat received a substantial number of such queries from Member States, officials of the United Nations system and representatives of other international organizations, non-governmental organizations, academic institutions, scholars, researchers and the private sector. In addition, the Secretariat provided complex and in-depth research and analysis for internal policy development and engaged in several outreach programmes aimed at familiarizing new Council members with the evolving procedure, practice and working methods of the Council, including the latest developments with respect to its working methods during the COVID-19 pandemic.

## **C. Publication in language versions (print and electronic)**

28. Pursuant to General Assembly resolution [55/222](#), the published versions of the eleventh to the twenty-first Supplements to the *Repertoire*, covering the period from 1989 to 2018, have been made available online in all six official languages. The Secretariat has implemented an ambitious schedule that provides for the publication of the final version of each Supplement in English within 22 months of the closing of the reporting period, thereby also expediting publication in the other five official languages. The twenty-first Supplement, covering the year 2018, was published in

English in October 2020 and in the other five languages in April 2021. The twenty-second Supplement, covering the year 2019, is expected to be published in English by October 2021 and in the other five official languages by the spring of 2022.

#### **D. Resources**

29. The progress made in the preparation and publication of the *Repertoire* and the maintenance of its website in all official languages would not have been possible without the continuing support of Member States. Voluntary contributions to the trust fund for the updating of the *Repertoire* remained a critical element for sustaining the progress made thus far and improving accessibility to the practice of the Security Council. During the reporting period, the Secretariat launched an appeal for funding to replenish the trust fund, in order to secure sufficient funds to allow for the modernization and enhancement of access to the wealth of data contained in the *Repertoire* and to expedite the editing and quality assurance of all information generated in its preparation.

30. Extrabudgetary resources have enabled the Secretariat to retain the services of temporary staff and personnel assisting in the preparation of the *Repertoire*. Since the previous report, contributions to the trust fund have been received from Estonia, France, Ireland, Saint Vincent and the Grenadines, Switzerland and the United Kingdom of Great Britain and Northern Ireland. In addition, Denmark, Japan, the Republic of Korea and Sweden have sponsored associate experts in the Security Council Practices and Charter Research Branch, who have made substantial contributions to advancing work on the *Repertoire*. In order to sustain the progress achieved to date, the Secretary-General calls upon Member States to further support the work of the Secretariat in updating the *Repertoire* through voluntary contributions to the trust fund and the sponsoring of associate experts.

#### **E. Conclusions**

31. **With respect to the *Repertoire of the Practice of the Security Council*, in the light of the foregoing, and the recommendations made by the Special Committee at its session held from 16 to 24 February 2021 (A/76/33), the General Assembly may wish:**

- (a) **To note the progress made towards updating the *Repertoire*;**
- (b) **To note with appreciation the contributions made by Member States to the trust fund for the updating of the *Repertoire*;**
- (c) **To reiterate its call for voluntary contributions to the trust fund for the updating of the *Repertoire* and the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication;**
- (d) **To call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions;**
- (e) **To reiterate the responsibility of the Secretary-General for the quality of the *Repertoire*, and to call upon the Secretary-General to continue to follow the modalities outlined in paragraphs 102 to 106 of his report dated 18 September 1952 (A/2170).**

## Annex III
