### Memorandum by the Secretary-General

adequately addressed in the statements of the groups in question, bearing in mind the sovereign right of each Member State to express its national position.

The General committee may furthermore wish to draw the attention of the General Assembly to resolution 59/313, in which the Assembly requested the Secretary-General to ensure that documentation and reports are issued well in advance, in keeping with the six-week rule for the issuance of official documentation simultaneously in all official languages.
