Working experience

Over the years of serving in the Ministry of Finance of China, Mr. Wu has been responsible for the budgetary expenditure and assessed contributions to international organizations, subsequently covering international meetings and forums, in which the Ministry of Finance of China has been participating. In the past two years, he has been supervising World Bank and Asian Development Bank (ADB) loan operations for Chinese investment projects and all related business and relations between these international financial institutions and China. At present, he is responsible for budgetary management for administrative, law enforcement and foreign expenditures.

International experience

During the years from 1988 to 1993, Mr. Wu worked for the Permanent Mission of China to the United Nations, covering Fifth Committee affairs, including budget and contribution issues. He attended the forty-third to forty-ninth sessions of the General Assembly and the twenty-ninth to thirty-second sessions of the Committee for Programme and Coordination. After that, he mostly covered the Finance Minister's meetings of a regional and global nature, such as the meetings of the Finance Ministers of the Asia-Pacific Economic Cooperation (APEC) forum, the meetings of the finance ministers of the Asia-Europe Meeting (ASEM), the Manila framework meetings, and meetings of the World Bank and ADB meetings etc.
