

# Andreas J. Jacovides (Cyprus)

[Original: English]

Andreas (Andrew) J. Jacovides was born in Nicosia, Cyprus, on 19 December 1936. His curriculum vitae to September 1996 is presented below (followed by an update).

### **Educational background**

Mr. Jacovides graduated with distinction from the Pancyprian Gymnasium in Nicosia in 1954 and received his higher education in law, specializing in international law, at the University of Cambridge, the Inns of Court (Middle Temple) in London and the Harvard Law School (BA, LL.B, MA, LL.M, Barrister-at-Law). At Cambridge, he received a double first class in the Law Tripos and graduated top of his class with a "starred first" (1958). He received several prizes and awards for academic distinction (Wright Prize, Winfield Prize, Hughes Prize, MacMahon studentship). At the Bar Final Examination (1959), he was awarded the International Law Prize. He was a Henry Fellow at the Harvard Law School, where he did graduate work in public international law (1959-1960). While at Cambridge, he was President of the St. John's College Law Society and a College Supervisor in International Law.

### Diplomatic career

Mr. Jacovides has been Cyprus' most senior career ambassador. He is a Foreign Service Officer with an extensive legal background, training and experience in international lawmaking and bilateral and multilateral diplomacy.

He was most recently in his second term as Ambassador to the United States (since September 1993), with concurrent accreditation to Canada, Brazil, Jamaica, Barbados, Bahamas and Guyana, the Work Bank and the International Monetary Fund and as Permanent Observer at the Organization of American States and Permanent Representative to the International Civil Aviation Organization (ICAO).

He previously served as Cyprus' Permanent Representative at the United Nations (1992-1993); Ambassador to the Federal Republic of Germany and non-resident Ambassador to Austria and Denmark and Permanent Representative to the International Atomic Energy Agency (IAEA) and the United Nations Office and Agencies in Vienna (1990-1992); and Permanent Secretary of the Ministry of Foreign Affairs in Nicosia (1989-1990).

He first served as Ambassador to the United States (and was briefly the Dean of the Washington Diplomatic Corps) between 1979 and 1989 with concurrent accreditation as Ambassador to Brazil and Ecuador, High Commissioner to Canada, Jamaica and the Bahamas. Permanent Observer at the Organization of American States and representative of Cyprus at the World Bank and the International Monetary Fund. He had earlier served as non-resident High Commissioner to Barbados, Guyana and Trinidad and Tobago (1972-1979). His first diplomatic posting was as First Secretary and then Counsellor of the Permanent Mission of Cyprus to the United Nations (1960-1965), to which he returned as Minister Plenipotentiary and Ambassador (1969-1979). Between 1965 and 1969, he served as

Director of the Minister's Office at the Ministry of Foreign Affairs in Nicosia and Director of the First Political Division.

In September 1960, Mr. Jacovides became a member of the first diplomatic delegation sent out of Cyprus after independence and served in the Cyprus delegation to every regular session of the United Nations General Assembly since the admission of Cyprus to the United Nations in September 1960

Ambassador Jacovides has been actively associated with the whole range of international law activities of the United Nations and other international organizations for the past 36 years, having served as representative of Cyprus to the Sixth (Legal) Committee from the fifteenth to the fifty-first sessions of the General Assembly (he was Vice-Chairman of the Sixth Committee in 1972).

He also served on the following United Nations Committees:

Special Committee on the Definition of Aggression;

Advisory Committee on the Teaching, Study, Dissemination and Wider Appreciation of International Law;

United Nations Committee on International Trade Law (UNCITRAL);

Special Committee on the Charter of the United Nations and on the Strengthening of the Organization;

Special Committee on the Enhancement of the Principle of the Non-Use of Force in International Relations (and Vice-Chairman of the Committee);

Committee on Relations with the Host Country (Chairman of the Committee in 1992-1993);

Preparatory Committee for the United Nations Conference on Environment and Development;

United Nations Committee on the Peaceful Uses of the Seabed and the Ocean Floor beyond the Limits of National Jurisdiction.

Ambassador Jacovides was Deputy Head (and Acting Chairman) of the Cyprus delegation to the United Nations Conference on the Law of Treaties (Vienna 1968 and 1969) and was a *signatory of the Vienna Convention on the Law of Treaties*.

Following his service on the United Nations Committee on the Peaceful Uses of the Seabed and the Ocean Floor beyond the Limits of National Jurisdiction (1971-1973), he served as Head of the Cyprus delegation to the Third United Nations Conference on the Law of the Sea and was Vice-Chairman of its Third Committee (New York, 1973; Caracas, 1974; Geneva, 1975; New York, 1976; New York, 1977; Geneva, New York, 1978; Geneva, New York, 1979); the Third Conference of the Mediterranean countries on the Law of the Sea (Athens, 1974); the Meeting of the Group of 77 on the Law of the Sea (Nairobi, 1974); the Asian-African Legal Consultative Committee Meeting on Law of the Sea Matters (New Delhi, 1976); the Commonwealth Meeting on Law of the Sea Matters (New York, 1976). He signed the Law of the Sea Convention in Montego Bay, Jamaica, in December 1982. He also represented Cyprus at the Inaugural Session of the International Sea-Bed Authority (Kingston, November 1994) and at the subsequent Session (Kingston, March 1995) and headed the Cyprus delegation to the meeting of the States Parties

to the Law of the Sea Convention (New York 1995, Kingston 1996, New York 1996).

Mr. Jacovides represented Cyprus at the United Nations Conference on Prescription (Limitation) of the Sale of Goods and was Vice-President of the Conference (New York, 1974). He was Chief Delegate to the Nineteenth (Extraordinary) Session of the International Civil Aviation Organization (New York, 1973) and also represented Cyprus at the twelfth and fourteenth sessions of the Committee on the Elimination of Racial Discrimination (New York, 1975 and 1977).

Mr. Jacovides also represented Cyprus at the Asian-African Legal Consultative Committee (Tokyo, 1974, Beijing, 1990 and Cairo, 1991) and attended the Legal Advisers Meetings in New York (1992-1995).

While serving at the Ministry of Foreign Affairs in Nicosia (1965-1969), Mr. Jacovides' duties included those of Legal Adviser in matters of Public International Law.

He also acted as Legal Adviser to Cyprus Government missions to the World Bank for Reconstruction and Development and was actively involved in the adoption of the MIGA Convention of the World Bank which he signed on behalf of Cyprus (1987). He also signed on behalf of Cyprus several other international agreements with the United States and Canada (Avoidance of Double Taxation, Customs Cooperation, etc.).

Ambassador Jacovides has been a third-term member of the International Law Commission, having been elected in 1981 and re-elected in 1986 and 1991 (in 1991 he was Vice-Chairman and in 1995 was offered but had to decline the chairmanship). ### **Update (as from September 1996)**

Since retiring from the Cyprus Foreign Service at the end of 1996, Mr. Jacovides has been accredited at the United Nations as Ambassador/Special Adviser at the Permanent Mission of Cyprus in New York, dealing primarily with issues of Public International Law. This includes representing Cyprus in the Sixth (Legal) Committee of the General Assembly (1997, 1998, 1999) as he has been doing since 1960, issues of the law of the sea, with which he has been dealing since the early 1970s, and international criminal jurisdiction, of which he was an early proponent. He continues to represent Cyprus at the annual meetings of the Legal Advisers of Foreign Ministries and the annual meetings of the Legal Advisers of the States members of the Asian-African Legal Consultative Committee, as well as the Advisory Committee for the Teaching, Study, Dissemination and Wider Appreciation of International Law.

Additionally, Ambassador Jacovides serves as Arbitrator on the Claims Resolution Tribunal for Dormant Accounts in Switzerland (CRT), in Zurich (since April 1998); as Commissioner on the United Nations Compensation Commission (UNCC), in Geneva (since July 1998); as a member of the Advisory Committee on the Implementation of the Framework Convention for the Protection of Minorities, in Strasbourg; and he is on the panel of Arbitrators and Conciliators of the International Centre for Settlement of Investment Disputes of the World Bank, in Washington, D.C.
