

International Law

Training and expertise

As a career diplomat, Alina Orosan has been involved in the management of important topics for the Romanian foreign policy and in the negotiations of a number of international treaties. She has been Head of the Romanian delegation to the UN 6th Committee and to the Council of Europe Committee of Experts on Public International Law for a number of years.

Her main areas of expertise are human rights (including the protection of the rights of persons belonging to national minorities), international criminal law, treaty law and immunities of states and of state officials.

She was part of the legal teams ensuring the Romanian representation before the International Court of Justice in the case concerning the *Maritime Delimitation in the Black Sea* (Romania v. Ukraine) and in the advisory proceedings concerning the *Accordance with International Law of the Unilateral Declaration of Independence in respect of Kosovo*. At present she is co-agent on behalf of Romania in the incidental proceedings in the case concerning *Allegations of Genocide under the Convention on the Prevention and Punishment of the Crime of Genocide* (Ukraine v. the Russian Federation) and coordinates the legal team entrusted with the preparation of the contribution of Romania in the advisory proceedings concerning *Obligations of States in respect of Climate Change*.

She was part of the legal team in charge with the process that led to the acceptance by Romania of the compulsory jurisdiction of the International Court of Justice and coordinated the preparation of the *Declaration on promoting the jurisdiction of the International Court of Justice*, a Romanian initiative launched in 2021 by the then Romanian Minister of Foreign Affairs, Mr. Bogdan Aurescu.

As a career diplomat, Alina Orosan participated in a number of seminars either as organizer, moderator or speaker on various topics of public international law, including *inter alia*: universal jurisdiction, climate change, sanctions and human rights, immunity of state officials, conflict resolution and conflict settlement within OSCE, International Humanitarian Law, towards an international court against terrorism, national minorities in inter-State relations, non-legally binding documents in international law.

For her activity within the Ministry of Foreign Affairs she has received two national distinctions.
