GENERAL EXCHANGE OF VIEWS ON THE MAIN CONCLUSIONS AND RECOMMENDATIONS OF REGIONAL PREPARATORY CONFERENCES

Results of the regional conferences and other international conferences

Note by the Secretariat

1. In its resolution 36/8 on the preparations for the Fourth World Conference on Women: Action for Equality, Development and Peace, the Commission on the Status of Women decided that the documentation for the Conference would include a report of the Secretary-General on the outcome of regional preparatory meetings for the Conference and relevant sections of final documents emanating from other major United Nations Conferences.

2. The Conference will have before it for its information the following:

(a) Jakarta Declaration and Plan of Action for the Advancement of Women in Asia and the Pacific adopted by the Second Asian and Pacific Ministerial
Conference on Women in Development, held at Jakarta from 7 to 14 June 1994

(b) African Platform of Action adopted by the Fifth Regional Conference on Women, held at Dakar from 16 to 23 November 1994 (E/CN.6/1995/5/Add.2);

(c) Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, emanating from the Sixth Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean, held at Mar del Plata, Argentina from 20 to 25 September 1994 (E/CN.6/1995/5/Add.3). The discussion of the Regional Programme of Action was completed at a meeting held in Santiago, Chile from 16 to 18 November 1994, when it was officially adopted;
