> Financial report on the status of the Assistance Fund under Part VII of the Agreement for the Implementation of the Provisions of the United Nations Convention on the Law of the Sea of 10 December 1982 relating to the Conservation and Management of Straddling Fish Stocks and Highly Migratory Fish Stocks

### Note by the Secretariat

1. By its resolution 58/14, the General Assembly decided to establish an Assistance Fund under Part VII of the Agreement for the Implementation of the Provisions of the United Nations Convention on the Law of the Sea of 10 December 1982 relating to the Conservation and Management of Straddling Fish Stocks and Highly Migratory Fish Stocks to assist developing States parties in the implementation of the Agreement. Pursuant to that resolution, the Fund is administered by the Food and Agriculture Organization of the United Nations (FAO), which acts as the implementing office for the Fund, in collaboration with the United Nations. The terms of reference for the Assistance Fund provide that, in addition to the submission of an annual report on activities of the Fund, a report on the activities of the Fund, to date, including a financial statement of the contributions to and disbursements from the Fund, shall be presented to the Review Conference provided for under article 36 of the Agreement.

2. Pursuant to that requirement, the Secretariat hereby transmits the FAO report on the activities of the Fund, dated February 2010.

## I. Introduction

1. In November 2003, the General Assembly, in its resolution 58/14, established the Assistance Fund under Part VII of the Agreement for the Implementation of the Provisions of the United Nations Convention on the Law of the Sea of 10 December 1982 relating to the Conservation and Management of Straddling Fish Stocks and Highly Migratory Fish Stocks (1995 United Nations Fish Stocks Agreement) to assist developing States parties in the implementation of the Agreement. It also decided that the Fund would be administered by the Food and Agriculture Organization of the United Nations (FAO). The Fund, which was set up on 19 April 2005,<sup>2</sup> is managed in accordance with its terms of reference and the FAO Financial Regulations as well as other applicable rules.

## II. Contributions to the Assistance Fund

2. The United Nations and FAO have continued to make calls for contributions to the Assistance Fund at international forums including sessions of the United Nations General Assembly and the FAO Committee on Fisheries as well as on the website of the Assistance Fund.<sup>3</sup>

3. As at 31 December 2009 the Governments of Canada, Iceland, Lebanon, New Zealand, Norway and the United States of America, all States parties to the 1995 United Nations Fish Stocks Agreement, had made financial contributions to the Assistance Fund totalling \$836,153. Table 1 (see annex) shows contributions to the Fund together with accrued interest. As at 31 December 2009 the Fund's total receipts were \$886,985. In 2009, two contributions totalling \$21,500 were received from the Governments of Lebanon and New Zealand.

4. States, intergovernmental organizations, international financial institutions, national institutions, non-governmental organizations and natural and juridical

## III. Requests for assistance from the Fund

5. Information about the existence and purpose of the Assistance Fund has been disseminated widely by the United Nations and FAO, including through electronic means, international meetings and contacts with relevant regional fisheries bodies. In 2009, 29 travel applications were funded. Three applications were not funded, however, because the one-month advance notice rule was not respected and one person was unable to travel after the application was processed. The number of travel requests in 2009 increased slightly over the level in 2008 (28 applications). In addition, the Panel of Experts was convened five times in 2009.

6. Table 2 (see annex) provides details of expenditure from the Assistance Fund as at 31 December 2009. Expenditure is categorized according to the purposes for which assistance is permitted and by administrative expenses, as reflected, respectively, in paragraphs 14 and 21 of the Fund's terms of reference.

7. In 2009, total expenditure from the Fund was \$332,521. This amount was 128 per cent higher than in 2008 (\$145,695). Of the total expenditure in 2009:

(a) 23.6 per cent supported participation in technical and annual sessions of regional and subregional fisheries management organizations and arrangements (Commission for the Conservation of Antarctic Marine Living Resources, Indian Ocean Tuna Commission, International Commission for the Conservation of Atlantic Tuna, South-East Atlantic Fisheries Organization, the Western and Central Pacific Fisheries Commission and the second joint meeting of tuna regional fisheries management organizations) (para. 14 (a) of the terms of reference);

(b) 22.4 per cent supported participation in meetings of global organizations (2009 FAO Committee on Fisheries and sessions of the FAO Technical consultation to draft port State measures to prevent, deter and eliminate illegal, unreported and unregulated fishing, as well as the eighth round of informal consultations of States parties to the 1995 United Nations Fish Stocks Agreement) (para. 14 (b) of the terms of reference);

(c) 13.0 per cent supported participation in negotiations to establish new regional and subregional fisheries management organizations and arrangements and a Pacific Islands workshop to assist Pacific Island countries to prepare for and participate more fully in the final round of negotiations for the South Pacific Regional Fisheries Management Organization (para. 14 (c) of the terms of reference);

(d) 14.4 per cent supported the finalization of work for the development of a regional shark plan for the Pacific Islands (para. 14 (d) of the terms of reference);

(e) Zero expenditure on facilitating exchange of information and experience on the implementation of the Agreement (para. 14 (e) of the terms of reference);

(f) 22.3 per cent supported capacity-building activities through two South Pacific regional workshops addressing (i) the management of tuna data and (ii) tuna stock assessment, ecosystem and by-catch (para. 14 (f) of the terms of reference);

(g) Zero expenditure on dispute settlement (para. 14 (g) of the terms of reference);

(h) 4.4 per cent was devoted to administration, including mandatory FAO insurance expenses, staff overtime for processing requests and the preparation of FAO letters of agreement and a 6 per cent project servicing cost for certain projects.

## **IV.** Panel of Experts

8. During 2009 the Panel of Experts was convened five times. This was done to consider requests from:

(a) The Pacific Islands Forum Fisheries Agency, on behalf of 12 Pacific Islands Governments, to conduct a regional workshop in October 2009 to address and prepare common positions for the negotiations for the South Pacific Regional Fisheries Management Organization, in accordance with paragraph 14 (c) of the Fund's terms of reference. The request was endorsed unanimously by the Panel;

(b) The Government of Senegal, in accordance with paragraph 14 (d) of the terms of reference, for assistance to enrol an officer in a university programme at a total cost of \$5,830. The Panel of Experts did not approve the request. Furthermore, three Panel members proposed that paragraph 14 (d) of the Fund's terms of reference be clarified to exclude the possibility of the Assistance Fund being used to support individual scholarships;

(c) The South Pacific Commission, on behalf of 12 Pacific Islands Governments to conduct one-week regional tuna data workshop in April 2010 at the Commission's headquarters in Noumea, New Caledonia, in accordance with paragraph 14 (f) of the terms of reference. The request was endorsed unanimously by the Panel;

(d) The South Pacific Commission, on behalf of 12 Pacific Islands Governments, to conduct two one-week regional workshops in June and July 2010 at the Commission's headquarters in Noumea, in accordance with paragraph 14 (f) of the terms of reference. The workshops will address (i) an introduction to tuna biology and assessment; and (ii) advanced tuna stock assessment and ecological risk assessment. The request was endorsed unanimously by the Panel;

(e) The Government of Mozambique, in accordance with paragraphs 14 (d) and (f) of the terms of reference, for the possible establishment of a linked vessel monitoring system subregional network with the Seychelles Fishing Authority; training, implementation and further development of the Integrated Fisheries Statistics System, and technical assistance in the expansion of training and operations for the implementation of the Integrated Fishing and the 2009 FAO Agreement on Port State Measures to Prevent, Deter and Eliminate Illegal, Unreported and Unregulated Fishing and the 2009 FAO Agreement on Port State Measures to Prevent, Deter and Eliminate Illegal, Unreported and Unregulated Fishing. The total cost of the proposals was

\$1,049,800. Pending the submission of a detailed budget, the Panel agreed to fund a part of the Government's second proposal at a maximum amount of \$65,000.

9. The Pacific Islands Forum Fisheries Agency workshop was completed on schedule in 2009 and the projects of the South Pacific Commission will be completed in 2010. These projects will contribute to human resources development in the Pacific Islands and to the implementation of conservation and management measures adopted by the Western and Central Pacific Fisheries Commission. It is anticipated that the project in Mozambique, which will support capacity-building, will also be completed in 2010.

### V. Assistance Fund travel allocations by State party

10. Table 3 (see annex) provides an allocation of travel expenditure by State party and by category of expenditure under paragraph 14 of the terms of reference for the period from 2006 to 2009. The number of States parties securing funding has been relatively stable over the period although there has been a marked upward trend in the amount of funds allocated.

## VI. Assistance Fund allocations under FAO letters of agreement

11. FAO has entered into letters of agreement<sup>4</sup> with the Pacific Islands Forum Fisheries Agency and the South Pacific Commission, and is expected to do the same with the Government of Mozambique in 2010. Table 4 (see annex) provides details of the letters of agreement concluded by FAO. The award of financial assistance under letters of agreement resulted from applications for assistance that were considered and agreed upon by the Panel of Experts.

## VII. Assistance Fund balance

12. As at 31 December 2009, the balance in the Assistance Fund was \$151,241 (see tables 1 and 2). However, taking account of funds already committed for 2010 travel (\$19,000), some administrative expenses (\$6,000) and provision for the Mozambique project (\$65,000), the Fund's current balance stands at approximately \$61,241.

## VIII. Conclusion

13. All applications for assistance for travel until 31 December 2009 are included in table 3. For letters of agreement all expenditures and unliquidated commitments since the inception of the Fund are included in table 4. The proportion of total

expenditure and commitments arising from applications for travel between 2006 and 2009 was 58.6 per cent with 38.9 per cent being devoted to expenditures and commitments under letters of agreement in 2008 and 2009. The balance of 2.6 per cent was due to administrative expenses incurred between 2006 and 2009.

14. The Assistance Fund was established and is being managed in accordance with its terms of reference, the FAO financial regulations and other applicable rules. The revision of the terms of reference at the seventh round of informal consultations of the States parties to the Agreement in 2008 has assisted in streamlining the management of the Fund. However, some further fine-tuning of the terms of reference is desirable to address issues that were not foreseen when they were elaborated and to take into account new situations that have arisen since that time.

15. The United Nations and FAO encourage States, intergovernmental organizations, international financial institutions, national institutions, non-governmental organizations and natural and juridical persons to make voluntary financial contributions to the Fund. The United Nations and FAO seek to ensure that the Assistance Fund maintains a healthy funding level so that support for the implementation of the 1995 United Nations Fish Stocks Agreement can be sustained.
