

Human rights situations that require the Council's attention

Note verbale dated 29 July 2013 from the Permanent Mission of the Syrian Arab Republic to the United Nations Office at Geneva and specialized institutions in Switzerland addressed to the Office of the United Nations High Commissioner for Human Rights

The Permanent Mission of the Syrian Arab Republic to the United Nations Office at Geneva and specialized institutions in Switzerland presents its compliments to the Office of the United Nations High Commissioner for Human Rights and has the honour to submit herewith the text of a letter from the Syrian Government concerning the mass murder committed in Khan Asal by the terrorist group known as Liwa Ansar al-Khilafah (Supporters of the Caliphate Brigade).

After hundreds of armed terrorists had taken control the Khan Asal area, in order to tighten the siege of Aleppo and prevent food and medicine from reaching that city, a terrorist group calling itself Liwa Ansar al-Khilafah (Supporters of the Caliphate Brigade) committed a horrifying mass murder in Khan Asal city. Dozens of civilians and military personnel were killed in the attack, which bears the hallmarks of an Al-Qaida operation. The terrorists mutilated some victims' bodies and tossed them into a large pit and set fire to the bodies of others.

The events that occurred in Khan Asal over the past few days have revealed the involvement of certain neighbouring States in the provision of military, material and logistical support to the armed terrorist groups. The involvement of those States is such that they are giving orders to attack specific sites and perpetrate massacres, with a view to achieving their goal of destabilizing Syria.

The Government of the Syrian Arab Republic stresses that certain States that are permanent members of the Security Council continue to apply double standards with regard to counter-terrorism by preventing the Council from condemning the numerous terrorist crimes that have been committed in Syria by *takfirist* organizations associated with Al-Qaida, the most recent of which was the terrorist bombing that occurred in Jaramana, Rif Dimashq, on 25 July 2013. Those States are also acting as partners to the terrorists through their direct involvement in providing armed terrorist groups with weapons, materiel and political cover, in violation of their responsibility as permanent members of the Council to maintain international peace and security. All of this raises many questions regarding those States' commitment to combating terrorism and their adherence to Security Council resolutions concerning counter-terrorism. The position taken by those States and their allies

in the region is contrary to the international consensus on counter-terrorism and encourages the commission of more terrorist crimes against Syrians. It also impedes all international efforts to find a political solution to the crisis through a dialogue among Syrians that respects their choices and will help stop the violence and combat the terrorism of the extremist, *takfirist* groups.

In view of this horrific massacre, which followed a series of attacks in Jisr al-Shughur in Idlib, the village of Hatlah in Dayr al-Zawr and other locations, the Syrian Arab Republic calls on the international community, in particular the Security Council and the Human Rights Council, to take serious and responsible steps to counter the terrorism being waged against Syria by *takfirist* gangs that are ideologically and organizationally linked to Al-Qaida. It further calls on the international community to uncover the facts behind this appalling mass murder and the motive for it, while eschewing hypocrisy and double standards.

The Permanent Mission of the Syrian Arab Republic requests the Office of the United Nations High Commissioner for Human Rights to circulate the present note verbale in the official languages of the United Nations as a document of the twenty-fourth session of the Human Rights Council.

The Permanent Mission of the Syrian Arab Republic takes this opportunity to convey to the Office of the United Nations High Commissioner for Human Rights the assurances of its highest consideration.
