Совет по правам человека Двадцать девятая сессия Пункт 4 повестки дня Ситуации в области прав человека, требующие внимания со стороны Совета

# Вербальная нота Постоянного представительства Эритреи при Отделении Организации Объединенных Наций в Женеве от 1 июля 2015 года, адресованная Канцелярии Председателя Совета по правам человека

Постоянное представительство Государства Эритрея при Отделении Организации Объединенных Наций и других международных организациях в Женеве свидетельствует свое почтение Канцелярии Председателя Совета по правам человека и имеет честь привлечь внимание Канцелярии к следующему.

Постоянному представительству стало известно, что заявление для прессы Министерства иностранных дел («Доклад "Комиссии по расследованию": циничная политическая издевка, подрывающая права человека»), представленное для распространения в качестве одного из официальных документов Совета по правам человека, было подвергнуто непрофессиональной правке, которую Представительство расценивает в качестве подлога. В результате этого в текст были добавлены два абзаца из документа КНДР, извратившие содержание и дух всего этого заявления для прессы, а именно:

Мы полностью готовы к любой конфронтации с США и намерены дать самый жесткий отпор грубому рэкету со стороны враждебных нам сил, прикрывающихся защитой «прав человека».

Позорные действия враждебных сил, бросающие вызов социалистическому строю КНДР, избранному и твердо поддерживаемому корейским народом, обречены на полный провал.

Стремление создать миф о связи Эритреи и КНДР, являющееся частью целенаправленной кампании шантажа и клеветы на Эритрею – отнюдь не новость. Представительство осуждает этот непрофессиональный акт и с трудом может поверить в то, что вышеупомянутые добавления могут быть результатом простого недосмотра.

Постоянное представительство также хотело бы проинформировать Канцелярию Председателя Совета по правам человека, что подложный документ был процитирован и распространен некоторыми СМИ, организациями и отдельными лицами, которые под предлогом защиты прав человека постоянно пытаются очернить Эритрею исходя из своекорыстных политических амбиций.



Пользуясь случаем, Постоянное представительство любезно просит Канцелярию:

- 1. принять меры по исправлению положения путем замены указанного документа оригинальным заявлением для прессы, направленным Представительством в форматах PDF и Word;
- 2. выступить с публичным заявлением, осуждающим этот непрофессиональный поступок, во избежание повторения подобного впредь и исправления ложного образа Эритреи в средствах массовой информации в целом и социальных медиа в частности;
- 3. провести расследование данного инцидента и привлечь виновных к ответственности, а затем довести до сведения Постоянного представительства Эритреи, членов Совета и широкой общественности информацию о сделанных выводах и принятых мерах;
- 4. любезно распространить данную вербальную ноту и приложения к ней в качестве официального документа Совета по правам человека.
