Письмо Постоянного представителя Азербайджана при Отделении Организации Объединенных Наций в Женеве от 20 апреля 2018 года на имя Председателя Совета по правам человека

Имею честь настоящим препроводить информацию о нарушениях режима прекращения огня вооруженными силами Республика Армения через линию соприкосновения на оккупированных территориях Азербайджанской Республики, а также через государственную границу между Арменией и Азербайджаном в январе и феврале 2018 года (см. приложение).

Хотел бы подчеркнуть, что систематические нарушения режима прекращения огня со стороны Армении участились и стали более ожесточенными, что приводит к гибели и ранениям азербайджанских военнослужащих и гражданских лиц. Эти действия Армении представляют собой серьезное нарушение международного гуманитарного права и права прав человека, в частности Женевских конвенций 1949 года и Дополнительного протокола I к ним, Конвенции о правах ребенка и Конвенции о защите прав человека и основных свобод.

Единственным способом обеспечить полное соблюдение прав гражданского населения является безоговорочный и полный вывод армянских вооруженных сил из Нагорного Карабаха и других оккупированных территорий Азербайджана, как того требуют соответствующие резолюции Совета Безопасности.


В целях предотвращения повторения подобных нарушений важно, чтобы международное сообщество, включая Совет по правам человека, соответствующим образом реагировали на эти ситуации посредством выражения серьезной озабоченности в связи с нарушениями Арменией международного гуманитарного права и права прав человека и осуждения лиц, несущих за них ответственность.
