**Вербальная нота Постоянного представительства Израиля  
при Отделении Организации Объединенных Наций в Женеве  
от 19 марта 2007 года на имя Председателя Совета по правам человека\***

Недавний доклад Специального докладчика по вопросу о положении на Западном берегу и в полосе Газы, опубликованный 29 января 2007 года, является верхом политизированного подхода, уже давно используемого при рассмотрении вопросов, касающихся Израиля. За 14 лет существования этого мандата и порожденных им однообразных и односторонних докладов этот самый последний доклад достигает новых глубин небеспристрастности и предвзятости по отношению к Израилю. Признание в докладе самого Специального докладчика, что он не будет "рассматривать вопрос о нарушении прав человека в результате использования палестинских террористов-смертников" и не будет "также рассматривать вопрос о нарушении прав человека в результате политического конфликта ... между "Фатхом" и "Хамасом" ... [поскольку] мой мандат запрещает мне заниматься их рассмотрением", служит наглядным свидетельством фундаментальных недостатков этого устаревшего мандата. К сожалению, это может только вызвать у меня желание вновь выразить свое глубокое возмущение по поводу несправедливого характера этого мандата Специального докладчика.

Этот предвзятый мандат по существу позволяет Специальному докладчику создавать искаженное представление о реальной ситуации за счет преднамеренного использования избирательности в оценках и не разрешает ему рассматривать фундаментальные аспекты всего контекста данной ситуации, такие, как палестинские нарушения, совершаемые против Израиля. Это резко контрастирует с объявленными принципами объективности, беспристрастности и неизбирательности в работе Совета, как они закреплены в резолюции о создании Совета по правам человека.

С 2000 года Израиль неизменно направлял официальные письма протеста Генеральному секретарю ООН, Совету Безопасности и председателю Генеральной Ассамблеи каждый раз, когда Израиль подвергался террористическим нападениям. Эта документация служит неотъемлемым элементом для любого объективного рассмотрения ситуации, имеющего целью дать справедливый и сбалансированный анализ положения на Западном берегу и в полосе Газы. Я прилагаю для Вашей информации этот исчерпывающий список.

Буду признателен, г-н Председатель, за распространение моего письма и приложенного к нему документа \*\* среди всех членов Совета по правам человека.
