1. Following its Universal Periodic Review on the 26th of January 2022, Zimbabwe herewith communicates its position in writing on the recommendations received, pursuant to Human Rights Council resolution 16/21.
2. During the review, Zimbabwe received 264 recommendations and has already conveyed its position on 166 recommendations, of which 127 were supported and 39 noted. The positions on these recommendations are recorded in the Report of the Working Group on the Universal Periodic Review referenced A/HRC/50/9. Ninety-eight recommendations were deferred for further examination.
3. The Government of Zimbabwe has examined the 98 deferred recommendations and herewith conveys its position on them, as follows:
