

Empowering Women: Advancing Rights, Equality and Equitable Practices

Attaining equality between women and men and eliminating all forms of discrimination against women are fundamental human rights and United Nations values. The United Nations has a long history of addressing women's human rights and much progress has been made in securing women's rights across the world in recent decades. Some groups of women face additional forms of discrimination based on their age, ethnicity, nationality, religion, health status, marital status, education, disability and socioeconomic status, among other grounds. These intersecting forms of discrimination must be taken into account when developing measures and responses to combat discrimination against women.(i) Gender inequality is a major cause and effect of hunger and poverty: it is estimated that 60 percent of chronically hungry people are women and girls. Women make up more than two-thirds of the world's 796 million illiterate people. Every additional year of primary school increases girls' eventual wages by 10-20 percent. It also encourages them to marry later and have fewer children, and leaves them less vulnerable to violence. In most countries, women in rural areas who work for wages are more likely than men to hold seasonal, part-time and low-wage jobs. Women also receive lower wages for the same work.(ii) The United Nations has long been at the forefront of promoting gender equality and women's rights worldwide. Despite progress, gender disparities and discrimination persist, particularly in developing countries. Rajasthan Samgrah Kalyan Sansthan, a non-profit organization based in Rajasthan, India, has been working tirelessly from last 30 years to empower women and advance gender equality in the region. RSKS India has been granted Special Consultative Status (2015) by The Economic and Social Council (ECOSOC) of The United Nation.

Rajasthan Samgrah Kalyan Sansthan is a grassroots non- profit organization established in 1992 with the mission of Alleviate Illiteracy, Poverty, Violence Against Women, Social Evils by Facilitating Empowerment of Women's & Girls From Deprived and Marginalised Communities. Rajasthan Samgrah Kalyan Sansthan operates in the state of Rajasthan, which is known for its deeply entrenched patriarchal norms and gender-based inequalities. Recognizing the urgent need to address these issues, Rajasthan Samgrah Kalyan Sansthan has been implementing a range of programs and initiatives to promote women's rights, gender equality, and women's empowerment.

Legal Literacy and Empowerment:

Rajasthan Samgrah Kalyan Sansthan 's comprehensive support services for survivors of gender-based violence have made a substantial difference in the lives of countless women and girls. Survivors have been provided with the necessary care, protection, and skills to rebuild their lives with dignity and confidence.

Sustainable Livelihood Support and Skill Development:

Rajasthan Samgrah Kalyan Sansthan recognizes that economic empowerment is a crucial aspect of women's empowerment. We provide vocational training programs and skill development initiatives in different trades like beautician, garments making, handicraft making, bag making etc that equips women with marketable & income skills. Rajasthan Samgrah Kalyan Sansthan also facilitates access to credit and microfinance services, enabling women to start their businesses or engage in income-generating activities. By promoting economic independence, Rajasthan Samgrah Kalyan Sansthan empowers women to make decisions, exercise agency, and break free from the cycle of poverty.
