### 19/...Activities of vulture funds and impact on human rights

*The Human Rights Council Advisory Committee,*

*Recalling* Human Rights Council resolution 34/3 of 23 March 2017 in which the Council takes note with appreciation of the progress report of the Advisory Committee on the activities of vulture funds and their impact on human rights, and requests it to present a final report thereon to the Human Rights Council at its thirty-ninth session for its consideration,

1. *Designates* the Advisory Committee members Mr. Alsheddi, Mr. Coriolano, Mr. Diaconu, Mr. Lebedev and Mr. Ziegler as members of the drafting group;
2. *Notes* that the drafting group elected Mr. Coriolano as Chairperson, and Mr. Ziegler as Rapporteur;
3. *Also notes* that the drafting group and the full Advisory Committee held meetings to discuss the topic;
4. *Welcomes* the active participation of external experts in the discussion and the rich exchange of views, and notes that the discussion has provided valuable input that will assist the task of the drafting group;
5. *Recommends* that the Human Rights Council extend the time schedule envisaged to allow for better informed work, and that the Advisory Committee be requested to submit its final report to the Council at its fortieth session;
