**Study on “Discrimination in the context of the Right to Food”**

*The Human Rights Council Advisory Committee,*

*Recalling* the resolutions of the Human Rights Council resolutions on the right to food for all, particularly its resolution 7/14, in which the Council requested the Advisory Committee to consider potential recommendations for approval by the Council on possible further measures to enhance the realization of the right to food, bearing in mind the priority importance of promoting the implementation of existing standards;

*Recalling* also Human Rights Council Resolution 10/12 requesting the Advisory Committee to undertake a study on discrimination in the context of the right to food, including the identification of good practices of anti-discrimination policies and strategies, and to report on it to the Council at its thirteenth session,

*Taking into account* the decision adopted by the Advisory Committee at its first session to establish a drafting group consisting of Mr. José Bengoa Cabello, Ms. Chinsung Chung, Mr. Latif Huseynov, Mr. Jean Ziegler, Ms. Mona Zulficar in relation to the Committee's work on the right to food,

*Taking note* of the preliminary background papers prepared by Mr. Jean Ziegler on "The tragedy of Noma" (A/HRC/AC/3/CRP.3) and "Peasant Farmers and the Right to Food: a History of Discrimination and Exploitation" (A/HRC/AC/3/CRP.5), which are intended as preliminary papers on certain aspects of discrimination to be addressed in the context of Council Resolution 10/12,

*Assigns* the task of the preparation of the study on "Discrimination in the context of the Right to Food", as mandated by the Council in its resolution 10/12, to the existing Drafting Group on the right to food referred to above and requests the Drafting Group to report on its programme of work, conceptual framework of the proposed study and its time plan promptly, and to present a preliminary report to the Advisory Committee at its fourth session.
