

I. Action taken by the Advisory Committee at its seventh session

7/1. Study on promoting human rights and fundamental freedoms through a better understanding of traditional values of humankind

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 16/3 of 24 March 2011, in which the Council requested the Advisory Committee to prepare a study on how a better understanding and appreciation of traditional values of dignity, freedom and responsibility could contribute to the promotion and protection of human rights, and to submit it to the Council at its twenty-first session,

Taking note of the discussions at the workshop on traditional values of humankind held on 4 October 2010, and the report of the United Nations High Commissioner for Human Rights containing a summary of those discussions (A/HRC/16/37),

Having due regard for the statements made at the seventh session of the Advisory Committee,

- 1. *Decides* to establish a drafting group consisting of the following members: Ms. Chung, Mr. Kartashkin, Mr. Okafor, Ms. Reyes Prado, Ms. Zulficar, Mr. Seetulsingh, Ms. Boisson de Chazournes, Mr. Chen, Mr. Soofi and Mr. Karakora;
- 2. *Appoints* Mr. Ahmer Bilal Soofi as Chairperson and Mr. Vladimir Kartashkin as Rapporteur of the group;
- 3. *Requests* the drafting group to prepare the above-mentioned study and to submit it to the Advisory Committee for consideration at its ninth session;
- 4. *Requests* the Office of the United Nations High Commissioner for Human Rights to provide the drafting group with all the assistance necessary to enable it to accomplish the above-mentioned task.

7/2. Human rights and international solidarity

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 9/2 of 24 September 2008, resolution 12/9 of 1 October 2009 and resolution 15/13 of 30 September 2010, in which the Council requested the Advisory Committee to prepare inputs to contribute to the elaboration by the independent expert on human rights and international solidarity of a draft declaration on the right of peoples and individuals to international solidarity, and to the further development of guidelines, standards, norms and principles with a view to promoting and protecting this right,

1. Takes note of the draft outline prepared by Mr. Chen Shiqiu as Chairperson/Rapporteur of the drafting group established by the Advisory Committee to consider this issue, as well as the comments and suggestions made during the discussions on the issue at the seventh session of the Committee;

- 2. Encourages the drafting group to cooperate closely with the independent expert on human rights and international solidarity and to submit the outcome of its work to the Advisory Committee at its eighth session;
- 3. Requests the Office of the United Nations High Commissioner for Human Rights to provide the drafting group with all the assistance necessary to enable it to accomplish its task.

7/3. Drafting group on the promotion of the right of peoples to peace

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 14/3 of 17 June 2010, in which the Council requested the Advisory Committee to prepare a draft declaration on the right of peoples to peace,

Recalling also that, at its fifth session, the Committee designated Chinsung Chung, Miguel d'Escoto Brockmann, Wolfgang Stefan Heinz and Mona Zulficar as members of the drafting group, which subsequently elected Ms. Zulficar as Chairperson and Mr. Heinz as Rapporteur, and that Shigeki Sakamoto and Latif Hüseynov joined the drafting group at the sixth session of the Committee,

Recalling that Human Rights Council resolution 17/16 of 17 June 2011 requests the Advisory Committee, in consultation with Member States, civil society, academia and all relevant stakeholders, to present a draft declaration on the right of peoples to peace and to report on progress thereon to the Council at its twentieth session,

- 1. *Takes note* of the second progress report submitted by the drafting group to the Advisory Committee at its seventh session (A/HRC/AC/7/3);
- 2. *Welcomes* the responses received to the questionnaire sent out in April 2011 and the discussions and statements made during its seventh session;
- 3. *Welcomes* initiatives by civil society to organize discussions on progress reports of the Advisory Committee with Member States and academic experts;
 - 4. Encourages the various stakeholders to contribute to the work under way;
- 5. Requests the drafting group to submit to the eighth session of the Committee a draft declaration on the right of peoples to peace revised in light of comments received and discussions held at the seventh session of the Advisory Committee;
- 6. Requests the Office of the United Nations High Commissioner for Human Rights to provide the drafting group with all the assistance necessary to enable it to accomplish its task.

7/4. Right to food

The Human Rights Council Advisory Committee,

Recalling the series of resolutions of the Human Rights Council on the right to food, specifically resolution 7/14 of 27 March 2008, resolution 10/12 of 26 March 2009, resolution 13/4 of 24 March 2010 and resolution 16/27 of 25 March 2011,

Recalling further the request of the Council in its resolution 16/27 that the Committee undertake comprehensive studies on the urban poor and their enjoyment of the right to food, rural women and their enjoyment of the right to food, and the relationship between severe malnutrition and childhood diseases,

- 1. Welcomes the comments by States and other stakeholders on the preliminary study on the advancement of the rights of peasants and other people working in the rural areas (A/HRC/16/63);
- 2. Assigns the completion of this study to the drafting group on the right to food, to be presented to the Advisory Committee at its eighth session for submission to the Human Rights Council at its nineteenth session;
- 3. *Welcomes* the preliminary study on severe malnutrition and childhood diseases, with children affected by Noma as an example (A/HRC/AC/7/CRP.2);
- 4. *Invites* the Office of the United Nations High Commissioner for Human Rights to collect the views and comments on this preliminary study of all Member States, all relevant United Nations special agencies and programmes and all other relevant stakeholders, as requested by the Council, so that the Advisory Committee may take them into account in the preparation of the final study to be submitted to the Council at its nineteenth session;
- 5. Assigns the completion of the study on severe malnutrition and childhood diseases, with children affected by Noma as an example, to the drafting group on the right to food, to be presented to the Advisory Committee at its eighth session for submission to the Human Rights Council at its nineteenth session;
- 6. *Welcomes* the concept note entitled "Promoting the human rights of the urban poor: Strategies and best practices";
- 7. Assigns the preparation of a preliminary study on this topic to the drafting group on the right to food, to be presented to the Advisory Committee at its eighth session;
- 8. Assigns the preparation of a preliminary study on rural women and their enjoyment of the right to food to the drafting group on the right to food, to be presented to the Advisory Committee at its ninth session.

7/5. Enhancement of international cooperation in the field of human rights

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 13/23 of 26 March 2010, in which the Council requested the Advisory Committee to explore ways and means to enhance cooperation in the field of human rights, taking into account the views contained in the report of the High Commissioner on the enhancement of international cooperation in the

field of human rights (A/HRC/13/19) and further views from States and relevant stakeholders, and to submit proposals thereon to the Council at its nineteenth session,

- 1. Takes note of the progress report presented by Mr. Seetulsingh, Chairperson of the drafting group established by the Advisory Committee to prepare the abovementioned task (A/HRC/AC/7/2), and the questionnaire to be disseminated to seek further views from States and relevant stakeholders for the preparation of the final proposals,
- 2. *Requests* the support of the secretariat in disseminating the questionnaire to States and relevant stakeholders,
- 3. *Requests* the drafting group to submit proposals on the issue for consideration by the Advisory Committee at its eighth session.

II. Officers, adoption of the agenda and organization of work

A. Opening and duration of the session

- 1. The Human Rights Council Advisory Committee, established pursuant to Human Rights Council resolution 5/1, held its seventh session at the United Nations Office at Geneva from 8 to 12 August 2011. The session was opened by the Deputy High Commissioner for Human Rights, Ms. Kyung-wha Kang.
- 2. The President of the Human Rights Council addressed the Advisory Committee at its 1st meeting, on 8 August 2011.
- 3. At the same meeting, the Deputy High Commissioner for Human Rights made a statement.

B. Composition of the Advisory Committee

4. C. Attendance

5. The session was attended by members of the Advisory Committee, observers for States Members of the United Nations, observers for non-Member States and for intergovernmental organizations, United Nations bodies, specialized agencies, other organizations, national human rights institutions and non-governmental organizations. Two members of the Advisory Committee, Ms. Quisumbing and Mr. d'Escoto Brockmann, were not able to attend the session.

D. Meetings and documentation

6. The Advisory Committee held eight plenary meetings, two closed meetings on agenda item 3 and one closed meeting on agenda item 4. The Advisory Committee adopted five texts (see chapter I above). For a list of documents, see annex III. The drafting groups on traditional values, on international solidarity and on the right to food also held private meetings.

E. Officers

7. In accordance with rule 103 of the rules of procedure of the General Assembly and rule 5 of the rules of procedure of the Advisory Committee, at its 1st meeting, on 8 August 2011, the Advisory Committee elected the following officers by acclamation:

8. At the same meeting, the new Chairperson, Mr. Hüseynov, made a statement. At the suggestion of Mr. Bengoa, the Advisory Committee observed a minute of silence for the victims of human rights violations around the world.

F. Adoption of the agenda

- 9. At its 1st meeting, on 8 August, the Advisory Committee had before it a note by the Secretary-General containing the provisional agenda for the seventh session (A/HRC/AC/7/1). The annotations to the provisional agenda are contained in A/HRC/AC/7/1/Add.1 and Corr.1 and Corr.2.
- 10. At the same meeting, the Advisory Committee adopted the agenda (see annex I).

G. Organization of work and conduct of business

- 11. The Advisory Committee considered item 2 of the agenda at its 1st and 2nd meetings, on 8 August.
- 12. At the same meetings, statements were made by members of the Advisory Committee (see annex II).

III. Requests addressed to the Advisory Committee stemming from Human Rights Council resolutions

13. The Advisory Committee considered agenda item 3 at its 2nd meeting, on 8 August, at its 3rd and 4th meetings, on 9 August, at its 5th and 6th meetings, on 10 August, and in the private meetings.

Requests currently under consideration by the Committee

1. Promotion of the right of peoples to peace

14. At its 2nd meeting, on 8 August, the Advisory Committee, pursuant to Council resolutions 11/4, 14/3 and 17/16, held a discussion on the promotion of the right of peoples to peace. Mr. Heinz made a presentation on the progress report on the issue (A/HRC/AC/7/3). Ms. Zulficar also took the floor. During the ensuing discussion, statements were made by members of the Advisory Committee, Government observers and observers for non-governmental organizations (see annex II) as well as by Mr. Del Prado, representative of the Working Group on mercenaries.

Drafting group on the promotion of the right of peoples to peace

- 15. At the Committee's 8th meeting, on 12 August, Mr. Heinz introduced draft text A/HRC/AC/7/L.3, sponsored by Ms. Laurence Boisson de Chazournes, Mr. Shiqiu Chen, Mr. Wolfgang Heinz, Mr. Alfred Ntunduguru Karokora, Mr. Vladimir Kartashkin, Mr. Obiora Chinedu Okafor, Ms. Anantonia Reyes Prado, Mr. Shigeki Sakamoto, Mr. Dheerujlall Seetulsingh, Mr. Ahmer Bilal Soofi, Ms. Halima Embarek Warzazi, Mr. Jean Ziegler and Ms. Mona Zulficar.
- 16. At the same meeting, Mr. Zulficar made a statement with regard to the draft text.
- 17. Also at the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

2. Right to food

- 18. At its 3rd and 4th meetings, on 9 August, the Advisory Committee, pursuant to Council resolutions 7/14, 10/12, 13/4 and 16/27, held a discussion on the promotion of the right to food.
- 19. At its 3rd meeting, Ms. Zulficar outlined the time frame for the various research studies to be undertaken. Mr. Ziegler, chairperson of the drafting group on the right to food, provided an overview of the most recent developments and the way forward to the finalization of the preliminary study on the advancement of the rights of peasants and other people working in rural areas (A/HRC/AC/7/CRP.1). A discussion followed in which Committee members, Government observers and non-governmental organizations took part (see annex II). Also at its third meeting, the Committee agreed on a letter to be addressed to the President of the Human Rights Council on the food crisis in East Africa.
- 20. At the Committee's 4th meeting, Ms. Zulficar made an introductory statement. Mr. Ziegler presented, on behalf of the drafting group on the right to food, the preliminary study on severe malnutrition and childhood diseases, with children affected by noma as an example (A/HRC/AC/7/CRP.2). Ms. Chung presented the concept note for the upcoming research work on the urban poor. A discussion followed in which Committee members, Government observers and an intergovernmental organization took part (see annex II).

Right to food

- 21. At the Committee's 8th meeting, on 12 August, Ms. Zulficar introduced draft text A/HRC/AC/7/L.4, sponsored by Mr. José Antonio Bengoa Cabello, Ms. Laurence Boisson de Chazournes, Mr. Shiqiu Chen, Ms. Chisung Chung, Mr. Wolfgang Heinz, Mr. Alfred Ntunduguru Karokora, Mr. Vladimir Kartashkin, Mr. Obiora Chinedu Okafor, Ms. Anantonia Reyes Prado, Mr. Shigeki Sakamoto, Mr. Dheerujlall Seetulsingh, Mr. Ahmer Bilal Soofi, Ms. Halima Embarek Warzazi and Ms. Mona Zulficar.
- 22. At the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

3. Traditional values of humankind

23. At its 5th and 6th meetings, on 10 August, pursuant to Council resolution 16/3, the Committee held a discussion on promoting human rights and fundamental freedoms through a better understanding of traditional values of humankind. Mr. Kartashkin made an introductory statement with regard to the study requested by the Human Rights Council. A discussion followed in which Committee members, Government observers and observers for non-governmental organizations took part (see annex II).

Study on promoting human rights and fundamental freedoms through a better understanding of traditional values of humankind

- 24. At the Committee's 8th meeting, on 12 August, Mr. Kartashkin introduced draft text A/HRC/AC/7/L.1, sponsored by Ms. Laurence Boisson de Chazournes, Mr. Shiqiu Chen, Ms. Chinsung Chung, Mr. Wolfgang Stefan Heinz, Mr. Latif Hüseynov, Mr. Alfred Ntunduguru Karakora, Mr. Vladimir Kartashkin, Mr.Obiora Chinedu Okafor, Ms. Anantonia Reyes Prado, Mr. Shigeki Sakamoto, Mr. Dheerujlall Seetulsingh, Mr. Ahmer Bilal Soofi, Ms. Halima Embarek Warzazi and Ms. Mona Zulficar.
- 25. At the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

4. Enhancement of international cooperation in the field of human rights

26. At its 6th meeting, on 10 August, pursuant to Council resolution 13/23, the Committee held a discussion on the enhancement of international cooperation in the field of human rights. Mr. Seetulsingh, chairperson of the drafting group, presented a preliminary report prepared by former Committee member and rapporteur Mr. Emmanuel Decaux on the topic (A/HRC/AC/7/2). Committee members, Government observers and one observer for non-governmental organizations took part in the ensuing discussion (see annex II).

Enhancement of international cooperation in the field of human rights

- 27. At the Committee's 8th meeting, on 12 August, Mr. Seetulsingh introduced draft text A/HRC/AC/7/L.4, sponsored by Ms. Laurence Boisson de Chazournes, Mr. Shiqiu Chen, Ms. Chinsung Chung, Mr. Wolfgang Heinz, Mr. Latif Hüseynov, Mr. Alfred Ntunduguru Karokora, Mr. Vladimir Kartashkin, Mr. Obiora Chinedu Okafor, Ms. Anantonia Reyes Prado, Mr. Shigeki Sakamoto, Mr. Dheerujlall Seetulsingh, Mr. Ahmer Bilal Soofi, Ms. Halima Embarek Warzazi and Ms. Mona Zulficar.
- 28. At the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

5. Human rights and international solidarity

29. At its 6th meeting, on 10 August, pursuant to Council resolutions 9/2, 12/9 and 15/13, the Committee held a discussion on human rights and international solidarity. Mr. Chen, chairperson of the drafting group, presented an overview of the most recent developments. Committee members and one Government observer took part in the ensuing discussion (see annex II).

Human rights and international solidarity

30. At the Committee's 8th meeting, on 12 August, Mr. Chen introduced draft text A/HRC/AC/7/L.2, sponsored by Mr. Shiqiu Chen, Ms. Chinsung Chung, Mr. Latif Hüseynov, Mr. Dheerujlall Seetulsingh and Ms. Halima Embarek Warzazi. Subsequently, Mr. Kartashkin joined the sponsors.

31. At the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

IV. Implementation of sections III and IV of the annex to Human Rights Council resolution 5/1 of 18 June 2007

A. Agenda and annual programme of work, including new priorities

- 32. At a closed meeting held on 11 August, Committee members exchanged views on possible research proposals to be submitted to the Council for consideration and approval.
- 33. At its 7th and 8th meetings, held on 11 and 12 August, Committee members made statements on possible research proposals to be submitted to the Council for consideration and approval, in which Government observers and observers from civil society took part (see annex II). Following these discussions, a letter was sent by the Chairperson of the Committee to the President of the Human Rights Council (see annex IV).

B. Appointment of members of the Working Group on Communications

34. Pursuant to paragraphs 91 and 93 of annex IV to Council resolution 5/1 providing for the mandate of members to the Working Group on Communications to be of three years and renewable only once, at its 8th meeting, on 12 August, the Advisory Committee decided by consensus to appoint Mr. Bengoa Cabello, Mr. Chen, Mr. Heinz, Mr. Kartashkin and Ms. Warzazi as member of the Working Group on Communications to serve until the end of their term as members of the Advisory Committee.

V. Report of the Advisory Committee on its seventh session

- 35. At the Committee's 8th meeting, on 12 August, the Rapporteur of the Advisory Committee presented the draft report of the Committee on its seventh session (A/HRC/AC/7/4).
- 36. At the same meeting, Mr. Seetulsingh and Ms. Warzazi made statements in relation to the draft report.
- 37. Also at the same meeting, the Advisory Committee adopted the draft report *ad referendum* and decided to entrust the Rapporteur with its finalization.
- 38. At the same meeting, Mr. Bengoa, Ms. Boisson de Chazournes, Mr. Chen, Mr. Kartashkin, Mr. Hüseynov and Ms. Zulficar made statements.

Letter from the Chairperson of the Advisory Committee to the President of the Human Rights Council

12 August 2011

Excellency,

As Chairperson of the Advisory Committee, I would like to express our gratitude to you and members of the Bureau for the informal meeting held on 9 August in the margins of the seventh session of the Committee. We value the steps envisioned in Council resolution 16/21 to strengthen the relationship between the Council and its subsidiary body, the Advisory Committee, and were extremely appreciative of the substantive discussion held with your Bureau on 9 August 2011. We support any step which would strengthen the interaction between the Council and the Advisory Committee, in particular through:

- Making a contribution to the half-day panel discussion on promoting the mainstreaming of human rights throughout the United Nations system to be held on a yearly basis, possibly through a video message, starting with March 2012 or 2013 as would be deemed appropriate by the Council;
- Further encouraging sponsors of resolutions, which provide for a mandated research
 to the Advisory Committee, to engage more systematically with the Committee in
 order to indicate thematic priorities and clarify the scope of the specific mandate/s;
- Facilitating interaction with other subsidiary organs and mechanisms of the Council, including supporting a yearly short meeting of representatives of the Advisory Committee, the Forum on Minority Issues, the Social Forum, and the Expert Mechanism on the Rights of Indigenous Peoples concomitantly with the annual meeting of Chairpersons of Treaty Bodies and of Special Procedures of the Council.

Furthermore, on behalf of the Committee, I would also like to follow up on a suggestion made during the meeting, notably the possibility for the Committee to identify in a memorandum addressed to the President and Bureau of the Council a list of specific research proposals, in particular with regard to contemporary and/or insufficiently dealt with human rights issues, for the consideration of the Council.

In responding to this proposal, and in line with paragraph 77 of the Annex to Council resolution 5/1, the Committee brainstormed both in private and public meetings, and I have the pleasure to transmit to you the following priority research proposals:

- youth, globalization and human rights;
- impact of the use of new information technologies, including Internet and social networking, on human rights;
- discrimination against the poor and other marginalized groups in the context of access to justice;
- human rights strategies in the fight against corruption;
- price speculation on corn, rice and wheat in the context of the right to food.

We look forward to your consideration of the above research proposals and to receiving feedback from the Council.
