I. Action taken by the Advisory Committee at its eighth session

8/1. Rights of peasants

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolutions 7/14 of 27 March 2008, 10/12 of 26 March 2009, 13/4 of 24 March 2010 and 16/27 of 25 March 2011,

Recalling also the request of the Human Rights Council that the Advisory Committee continue its work on the advancement of the rights of people working in rural areas, and present the final study thereon to the Council at its nineteenth session,

1. *Welcomes* the final study on the advancement of the rights of peasants and other people working in rural areas and the annexed declaration on the rights of peasants and other people working in rural areas prepared by its drafting group;¹

2. *Submits* herewith to the Human Rights Council the above-mentioned study;²

3. *Requests* the Human Rights Council to consider the recommendations made by the Advisory Committee in its study, in particular:

(a) The creation of a new special procedures mandate on the promotion and protection of the rights of peasants and other people working in rural areas;

(b) The development of a new international human rights instrument on the rights of peasants and other people working in rural areas.

8/2. Right to food

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolutions on the right to food, in particular resolutions 7/14 of 27 March 2008, 10/12 of 26 March 2009, 13/4 of 24 March 2010 and 16/27 of 25 March 2011,

Recalling also the request of the Human Rights Council, in its resolution 16/27, that the Advisory Committee undertake, as a follow-up to the study on discrimination in the context of the right to food,³ comprehensive studies on the urban poor and their enjoyment of the right to food, rural women and their enjoyment of the right to food, and the relationship between severe malnutrition and childhood diseases,

1. *Welcomes* the study on severe malnutrition and childhood diseases with children affected by noma as an example and the human rights principles and guidelines to

improve the protection of children at risk or affected by malnutrition, specifically at risk of or affected by noma, annexed thereto, prepared by its drafting group;⁴

2. *Submits* herewith to the Human Rights Council the above-mentioned study and the annex thereto;⁵

3. *Requests* the Human Rights Council to consider the recommendations made by the Advisory Committee in the above-mentioned study, and to encourage States to implement the human rights principles and guidelines to improve the protection of children at risk or affected by malnutrition, specifically at risk of or affected by noma, annexed thereto;

4. *Welcomes* the preliminary study on the theme “promotion of human rights of the urban poor: strategies and best practices” prepared by its drafting group;⁶

5. *Invites* the Office of the United Nations High Commissioner for Human Rights to collect the views and comments on the preliminary study of all Member States, relevant United Nations special agencies and programmes and all other relevant stakeholders, as requested by the Human Rights Council, in order that the Advisory Committee may take them into account in the preparation of its final study;

6. *Assigns* the completion of the above-mentioned study to the drafting group on the right to food, to be presented to the Advisory Committee at its ninth session for submission to the Human Rights Council at its twenty-second session;

7. *Welcomes* the concept note for the preliminary study on rural women and the right to food prepared by the drafting group;⁷

8. *Assigns* the preparation of a preliminary study on rural women and their enjoyment of the right to food to the drafting group on the right to food, to be presented to the Advisory Committee at its ninth session.

8/3. Human rights and international solidarity

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolutions 9/2 of 24 September 2008, 12/9 of 1 October 2009, 15/13 of 30 September 2010 and 18/5 of 29 September 2011, in which the Council requested the Advisory Committee to prepare inputs to contribute to the elaboration by the independent expert on human rights and international solidarity of a draft declaration on the right of peoples and individuals to international solidarity, and to the further development of guidelines, standards, norms and principles with a view to promoting and protecting that right,

1. *Takes note* of the draft paper prepared by the Chairperson-Rapporteur of the drafting group established by the Advisory Committee to consider this issue, Chen Shiqiu,⁸

as well as of the comments and suggestions made during the discussions on the issue in the Advisory Committee at its eighth session;

2. *Welcomes* the participation of the independent expert on human rights and international solidarity and encourages the drafting group to continue to cooperate closely with her, and to submit the revised paper on the issue to the Advisory Committee at its ninth session;

3. *Designates* Mr Shiqiu and Dheerujlall Seetulsingh to participate in the workshop convened by the United Nations High Commissioner for Human Rights pursuant to Human Rights Council resolution 18/5 for an exchange of views on, inter alia, the gender implications of international solidarity, the impact of a right to international solidarity, the role of international solidarity in achieving the Millennium Development Goals and the realization of the right to development;

4. *Requests* the Office of the High Commissioner to provide the drafting group with all the assistance necessary to enable it to accomplish its task.

8/4. Drafting group on the promotion of the right of peoples to peace

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 14/3 of 17 June 2010, in which the Council requested the Advisory Committee to prepare a draft declaration on the right of peoples to peace,

Recalling also that, at its fifth session, the Advisory Committee designated Chinsung Chung, Miguel d'Escoto Brockmann, Wolfgang Stefan Heinz and Mona Zulficar as members of the drafting group, which subsequently elected Ms Zulficar as Chairperson and Mr Heinz as Rapporteur, and that Shigeki Sakamoto and Latif Hüseyinov joined the drafting group at the sixth session of the Committee,

Recalling further that the Human Rights Council, in its resolution 17/16 of 17 June 2011, requested the Advisory Committee, in consultation with Member States, civil society, academia and all relevant stakeholders, to present a draft declaration on the right of peoples to peace and to report on progress thereon to the Council at its twentieth session,

1. *Takes note* of the progress report on the right of peoples to peace submitted by the drafting group to the Advisory Committee at its eighth session;⁹

2. *Welcomes* the submissions and comments received during its eighth session by various stakeholders and members of the Advisory Committee;

3. *Also welcomes* the initiatives of civil society actors to organize discussions on the draft declaration of the Advisory Committee;

4. *Requests* the drafting group to finalize its work on the draft declaration on the right of peoples to peace in the light of the discussions held by the Advisory Committee at its eighth session, and to submit it to the Human Rights Council at its twentieth session;

5. *Also requests* the drafting group to include in its revision, inter alia:

- (a) Reference to the link between the right to peace and all civil, political, economic, social and cultural rights in article 1;
- (b) Reference to the importance of citizen security and a preventive approach;
- (c) Strengthening of gender mainstreaming in article 8;
- (d) Reference to the right to truth in article. 11;
- (e) More explicit wording on a monitoring mechanism in article 13;

6. *Expresses the wish* that a representative of the drafting group on the right of peoples to peace of the Advisory Committee be invited to participate in the discussions of the Human Rights Council on the draft declaration;

7. *Also expresses the wish* that the drafting group be kept informed of the follow-up to the work of the Human Rights Council, and that it might be involved, in appropriate ways, in the ongoing debate;

8. *Requests* the Office of the United Nations High Commissioner for Human Rights to provide the drafting group with all the assistance necessary to enable it to accomplish its task.

8/5. Terrorist hostage-taking

The Human Rights Council Advisory Committee,

Noting that, in Human Rights Council resolution 18/10 of 29 September 2011, the Council requested the Advisory Committee to prepare a study on the issue of terrorist hostage-taking for the purposes of promoting awareness and understanding, paying particular attention to its impact on human rights and the role of regional and international cooperation in this field,

Noting also that, in its resolution 18/10, the Human Rights Council also requested the Advisory Committee to submit the study to the Council at its twenty-third session and to present an interim report thereon at its twenty-first session,

Taking note of the discussions held by the Human Rights Council panel on the issue of human rights in the context of action taken to address terrorist hostage-taking at its eighteenth session,¹⁰

Taking into account the preliminary discussions held by the Advisory Committee at its eighth session,

1. *Decides* to establish a drafting group consisting of Wolfgang Stefan Heinz, Latif Hüseyinov, Obiora Chinedu Okafor, Shigeki Sakamoto, Ahmer Bilal Soofi and Jean Ziegler;

2. *Appoints* Mr Hüseyinov as Chairperson and Mr Heinz as Rapporteur of the drafting group;

3. *Encourages* all interested stakeholders, such as Member States, international organizations, national human rights institutions and non-governmental organizations, to contribute to the study process;

4. *Recommends* that the Human Rights Council extend the time schedule envisaged to allow for better informed work, and requests the drafting group to submit a preliminary study to the Advisory Committee at its ninth session with a view to submitting an interim report to the Council at its twenty-second session and a final report at its twenty-fourth session;

5. *Recommends* that the Human Rights Council consider adopting the following decision:

“The Human Rights Council takes note of the recommendation of the Advisory Committee on the progress of work on terrorist hostage-taking, and requests the Advisory Committee to submit an interim report to the Council at its twenty-second session, and the final report at its twenty-fourth session.”;

6. *Requests* the Office of the United Nations High Commissioner for Human Rights to provide the drafting group with all the assistance necessary to enable it to accomplish the above-mentioned task.

8/6. Traditional values of humankind

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 16/3 of 24 March 2011, in which the Council requested the Advisory Committee to prepare a study on how a better understanding and appreciation of traditional values of dignity, freedom and responsibility can contribute to the promotion and protection of human rights, and to present that study to the Council before its twenty-first session;

Recalling also that, at its seventh session, the Advisory Committee established a drafting group with the task of preparing the above-mentioned study, and appointed Ahmer Bilal Soofi as Chairperson and Vladimir Kartashkin as Rapporteur of the group,

1. *Takes note* of the comments and suggestions made during the discussions on the preliminary study prepared by Mr Kartashkin;

2. *Requests* the drafting group to submit the revised preliminary study to the Advisory Committee at its ninth session for further consideration.

8/7. Enhancement of international cooperation in the field of human rights

The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 13/23 of 26 March 2010, in which the Council requested the Advisory Committee to explore ways and means to enhance

cooperation in the field of human rights, taking into account the views contained in the report of the United Nations High Commissioner for Human Rights on the enhancement of international cooperation in the field of human rights¹¹ and further views from States and relevant stakeholders, and to submit proposals thereon to the Council at its nineteenth session,

1. *Welcomes* the responses received to its questionnaire submitted to States, non-governmental organizations and relevant stakeholders;

2. *Approves* the final report on the enhancement of international cooperation in the field of human rights presented by Dheerujlall Seetulsingh, Chairperson of the drafting group established by the Advisory Committee to prepare the above-mentioned task,¹² together with Laurence Boisson de Chazournes, Rapporteur of the drafting group;

3. *Submits* herewith to the Human Rights Council the above-mentioned final report.

II. Officers, adoption of the agenda and organization of work

A. Opening and duration of the session

1. The Human Rights Council Advisory Committee, established pursuant to Human Rights Council resolution 5/1, held its eighth session at the United Nations Office at Geneva from 20 to 24 February 2012. The session was opened by the Chairperson for its eighth session, Latif Hüseyinov.

2. The President of the Human Rights Council, MsLaura Dupuy Lasserre, addressed the Advisory Committee at its 1st meeting, on 20 February 2012.

3. At the same meeting, Mrthe Director of the Human Rights Council and Special Procedures Division made a statement on behalf of the United Nations High Commissioner for Human Rights.

B. Composition of the Advisory Committee

4. 5. In its decision 18/121, the Human Rights Council decided that, as a transitional measure, the period of office of members of the Advisory Committee ending in March 2012 would be exceptionally extended until 30 September 2012.

C. Attendance

6. The session was attended by members of the Advisory Committee, observers for States Members of the United Nations, observers for non-Member States and for intergovernmental organizations, United Nations bodies, specialized agencies, other organizations, national human rights institutions and non-governmental organizations. Mr d'Escoto Brockmann was not able to attend the session due to medical reasons.

D. Meetings and documentation

7. The Advisory Committee held eight plenary meetings, one closed meeting on agenda item 3, two closed meetings on agenda item 2 and one closed meeting on agenda item 1. The Advisory Committee adopted seven texts (see chapter I above).

E. Officers

8. In accordance with rule 103 of the rules of procedure of the General Assembly and rule 5 of the rules of procedure of the Advisory Committee, the following officers elected by acclamation at the 1st meeting of the seventh session of the Advisory Committee, held on 8 August 2011, also served as officers at the eighth session:

9. At the same meeting, the Advisory Committee observed a minute of silence in memory of Purificacion V. Quisumbing.

10. Also at the same meeting, the Advisory Committee observed a minute of silence for the victims of human rights violations around the world.

F. Adoption of the agenda

11. At its 1st meeting, the Advisory Committee had before it a note by the Secretary-General containing the provisional agenda for the eighth session (A/HRC/AC/8/1). The annotations to the provisional agenda are contained in document A/HRC/AC/8/1/Add.1 and Corr.1.

12. At the same meeting, the Advisory Committee adopted the agenda (see annex I).

G. Organization of work and conduct of business

13. The Advisory Committee considered item 2 of the agenda at its 1st meeting, on 20 February.

14. At the 1st meeting, the modalities with respect to the organization of work and conduct of business were recalled by the Chairperson on the basis of the modalities applied at the previous sessions of the Committee.

15. It was agreed that the deadline for submitting draft recommendations would be 23 February 2012.

16. Statements were made by members of the Advisory Committee (see annex II).

III. Requests addressed to the Advisory Committee stemming from Human Rights Council resolutions

17. The Advisory Committee considered agenda item 2 at its 1st and 2nd meeting, on 20 February, at its 3rd and 4th meetings, on 21 February, and at its 5th and 6th meetings, on 22 February.

Requests currently under consideration by the Committee

1. Promotion of the right of peoples to peace

18. At its 1st and 2nd meetings, on 20 February, the Advisory Committee, pursuant to Human Rights Council resolutions 11/4, 14/3 and 17/16, held a discussion on the promotion of the right of peoples to peace. Mr Heinz made a presentation on the progress report on the issue (A/HRC/AC/8/2). During the ensuing discussion, statements were made by members of the Advisory Committee, Government observers and observers for non-governmental organizations (see annex II) as well as by Mr Victor Manuel Rodríguez Rescia on behalf of the Subcommittee on Prevention of Torture and other Cruel, Inhuman or Degrading Treatment or Punishment.

19. At the 9th meeting, on 24 February, Mr Sakamoto introduced draft text A/HRC/AC/8/L.4, sponsored by Ms Boisson de Chazournes, Mr Chen, Ms Chung, Mr Heinz, Mr Hüseyinov, Mr Ntunduguru Karokora, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Soofi, Ms Warzazi, Mr Ziegler and Ms Zulficar.

20. At the same meeting, Mr Bengoa made a statement with regard to the draft text.

21. Also at the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I). Subsequently, Mr d'Escoto Brockmann informed the secretariat in writing that he wished to be dissociated from recommendation 8/4.

2. Traditional values of humankind

22. At its 2nd meeting, on 20 February, and ^{its} 3rd meeting, on 21 February, the Advisory Committee, pursuant to Human Rights Council resolution 16/3, held a discussion on promoting human rights and fundamental freedoms through a better understanding of traditional values of humankind. At its 2nd meeting, Mr Kartashkin made a presentation on his preliminary report on the issue (A/HRC/AC/8/4). Committee members took part in the ensuing discussion (see annex II). At the 3rd meeting, a discussion followed in which Committee members, Government observers, observers for non-governmental organizations and an observer for an intergovernmental organization took part (see annex II).

23. At the 9th meeting, on 24 February, Mr Soofi introduced draft text A/HRC/AC/8/L.6, sponsored by Ms Boisson de Chazournes, Mr Chen, Ms Chung, Mr Kartashkin, Mr Karokora, Mr Chinedu Okafor, Ms Reyes Prado, Mr Seetulsingh, Mr Soofi, Ms Warzazi, Mr Ziegler and Ms Zulficar.

24. At the same meeting, Mr Bengoa, Mr Kartashkin, Mr Karokora and Ms Warzazi made statements with regard to the draft text.

25. Also at the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

3. Right to food

26. At its 3rd and 4th meetings, on 21 February, and at its 6th meeting, on 22 February, the Advisory Committee, pursuant to Human Rights Council resolutions 7/14, 10/12, 13/4 and 16/27, held discussions on the promotion of the right to food.

(a) Advancement of the rights of peasants and other people working in rural areas

27. At its 3rd and 4th meetings, the Advisory Committee held a discussion on the final study on the advancement of the rights of peasants and other people working in rural areas (A/HRC/AC/8/6). Mr Bengoa introduced the study. During the ensuing discussion, statements were made by Committee members, observers for Governments and observers for non-governmental organizations (see annex II).

28. At the 9th meeting, on 24 February, Mr Bengoa introduced draft text A/HRC/AC/8/L.1, sponsored by Mr Bengoa, Mr Chen, Ms Chung, Mr Heinz, Mr Hüseyinov, Mr Karokora, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Soofi, Ms Warzazi, Mr Ziegler and Ms Zulficar.

29. At the same meeting, the draft text was adopted unanimously, without a vote (for the text as adopted, see chapter I).

(b) Severe malnutrition and childhood diseases with children affected by noma as an example

30. At the 4th meeting, Mr Ziegler, as chairperson of the drafting group on the right to food, made an introductory statement on the final study on severe malnutrition and childhood diseases, with children affected by noma as an example (A/HRC/AC/8/7).

31. At the 9th meeting, on 24 February, Mr Bengoa introduced draft text A/HRC/AC/8/L.2, sponsored by Mr Bengoa, Mr Chen, Ms Chung, Mr Heinz, Mr Hüseyinov, Mr Karokora, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Soofi, Ms Warzazi, Mr Ziegler and Ms Zulficar.

32. At the same meeting, the draft text was adopted unanimously, without a vote (for the text as adopted, see chapter I).

(c) Rural women and the right to food

33. At its 6th meeting, on 22 February, the Advisory Committee, pursuant to Human Rights Council resolution 16/27, held a discussion on the concept note for the preliminary study on rural women and the right to food (A/HRC/AC/8/CRP.2). Ms Zulficar, rapporteur of the drafting group, presented the concept note. A discussion followed, in which Committee members and an intergovernmental organization took part (see annex II).

(d) Promotion of human rights of the urban poor: strategies and best practices

34. At its 6th meeting, on 22 February, the Advisory Committee, pursuant to Human Rights Council resolution 16/27, held a discussion on the preliminary study on the promotion of human rights of the urban poor (A/HRC/AC/8/5). Ms Chung, rapporteur of the drafting group, presented an introduction to the study. Committee members took part in the ensuing discussion (see annex II).

4. Human rights and issues related to terrorist hostage-taking

35. At its 5th meeting, on 22 February, the Advisory Committee, pursuant to Human Rights Council resolution 18/10, held a preliminary discussion on human rights and issues relating to terrorist hostage-taking. Observers for Algeria and Senegal, on behalf of the African States, made introductory statements regarding the background of Council resolution 18/10 and the study requested by the Council. During the ensuing discussion, statements were made by members of the Advisory Committee and Government observers (see annex II).

36. At the 9th meeting, on 24 February, Mr Hüseyinov introduced draft text A/HRC/AC/8/L.5, sponsored by Ms Boisson de Chazournes, Mr Chen, Mr Heinz, Mr Hüseyinov, Mr Karokora, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Soofi and Mr Ziegler.

37. At the same meeting, Mr Chen, Ms Chung, Mr Kartashkin and Ms Warzazi made statements with regard to the draft text.

38. At the same meeting, the draft text was adopted without a vote (for the text as adopted, see chapter I).

5. Human rights and international solidarity

39. At its 5th meeting, on 22 February, pursuant to Human Rights Council resolutions 9/2, 12/9 and 15/13, the Advisory Committee held a discussion on human rights and international solidarity. The Independent Expert on human rights and international solidarity, Virginia Dandan, made an introductory statement on a draft declaration on the right of peoples and individuals to international solidarity and on her mandate. Mr Chen, chairperson of the drafting group, presented the draft paper on human rights and international solidarity (A/HRC/AC/8/CRP.1). Committee members and government observers took part in the ensuing discussion (see annex II).

40. At the 9th meeting, on 24 February, Mr Chen introduced draft text A/HRC/AC/8/L.3, sponsored by Mr Bengoa, Ms Boisson de Chazournes, Mr Chen, Ms Chung, Mr Heinz, Mr Hüseyinov, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Bilal Soofi, Ms Warzazi and Mr Ziegler.

41. At the same meeting, the draft text was adopted unanimously, without a vote (for the text as adopted, see chapter I).

6. Enhancement of international cooperation in the field of human rights

42. At its 6th meeting, on 22 February, the Advisory Committee, pursuant to Human Rights Council resolution 13/23, held a discussion concerning final proposals for the enhancement of international cooperation in the field of human rights. Mr Seetulsingh, the chairperson of the drafting group, and Ms Boisson de Chazournes made a statement on the final study (A/HRC/AC/8/3). Committee members, Government observers and an observer for a non-governmental organization took part in the ensuing discussion (see annex II).

43. At the 9th meeting, on 24 February, Mr Seetulsingh introduced draft text A/HRC/AC/8/L.7, sponsored by Mr Bengoa, Ms Boisson de Chazournes, Mr Chen, Ms

Chung, Mr Heinz, Mr Hüseyinov, Mr Karokora, Mr Kartashkin, Mr Okafor, Ms Reyes Prado, Mr Sakamoto, Mr Seetulsingh, Mr Soofi, Ms Warzazi and Mr Ziegler.

44. At the same meeting, the draft text was adopted unanimously, without a vote (for the text as adopted, see chapter I).

Agenda and annual programme of work, including new priorities

45. At the 7th meeting, held on 23 February, Committee members made statements regarding possible research proposals to be submitted to the Human Rights Council for consideration and approval (see annex II).

46. At its 9th meeting, on 24 February, the Advisory Committee considered agenda item 4.

47. At that meeting, the Rapporteur of the Advisory Committee presented the draft report on its eighth session (A/HRC/AC/8/8).

48. Also at the same meeting, statements in relation to the draft report were made by Mr Chen, Ms Chung and Ms Warzazi.

49. At the same meeting, the Advisory Committee adopted the draft report ad referendum and decided to entrust the Rapporteur with its finalization.

50. Also at the same meeting, the Chairperson of the Advisory Committee made concluding remarks.
