The General Assembly,

 $\underline{\mbox{Guided}}$ by the purposes and principles of the Charter of the United Nations,

<u>Guided also</u> by the principles of international humanitarian law, in particular the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, as well as international standards of human rights, in particular the Universal Declaration of Human Rights and the International Covenants on Human Rights, 3

<u>Recalling</u> its relevant resolutions, including resolution 2443 (XXIII) of 19 December 1968, and relevant resolutions of the Commission on Human Rights,

Recalling also relevant resolutions of the Security Council,

 $\underline{\text{Aware}}$ of the lasting impact of the uprising ($\underline{\text{intifadah}}$) of the Palestinian people,

 $\underline{\text{Convinced}}$ that occupation itself represents a primary violation of human rights,

<u>Having considered</u> the reports of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories 4 and the relevant reports of the Secretary-General, 5

Noting the signing of the Declaration of Principles on Interim Self-Government Arrangements by the Government of Israel and the Palestine Liberation Organization in Washington on 13 September 1993, 6 as well as the subsequent implementation agreements, including the Interim Agreement on the West Bank and the Gaza Strip signed in Washington on 28 September 1995,

<u>Expressing the hope</u> that, with the progress of the peace process, the Israeli occupation will be brought to an end and therefore violation of the human rights of the Palestinian people will cease,

- 1. <u>Commends</u> the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories for its efforts in performing the tasks assigned to it by the General Assembly and for its impartiality;
- 2. <u>Demands</u> that Israel cooperate with the Special Committee in implementing its mandate;
- 3. <u>Deplores</u> those policies and practices of Israel which violate the human rights of the Palestinian people and other Arabs of the occupied territories, as reflected in the reports of the Special Committee covering the reporting period;
- 4. <u>Expresses concern</u> over the recent deterioration of the situation in the occupied Palestinian territory, including Jerusalem, as a result of Israeli practices and measures and the impasse facing the Middle East peace process;
- 5. <u>Requests</u> the Special Committee, pending complete termination of the Israeli occupation, to continue to investigate Israeli policies and

practices in the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967, especially Israeli lack of compliance with the provisions of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, and to consult, as appropriate, with the International Committee of the Red Cross according to its regulations in order to ensure that the welfare and human rights of the peoples of the occupied territories are safeguarded and to report to the Secretary-General as soon as possible and whenever the need arises thereafter;

- 6. <u>Also requests</u> the Special Committee to submit regularly to the Secretary-General periodic reports on the current situation in the occupied Palestinian territory, including Jerusalem;
- 7. <u>Further requests</u> the Special Committee to continue to investigate the treatment of prisoners in the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967;
 - 8. <u>Requests</u> the Secretary-General:
- (a) To provide all necessary facilities to the Special Committee, including those required for its visits to the occupied territories, so that it may investigate the Israeli policies and practices referred to in the present resolution;
- (\underline{b}) To continue to make available such additional staff as may be necessary to assist the Special Committee in the performance of its tasks;
- (\underline{c}) To circulate regularly to Member States the periodic reports mentioned in paragraph 6 above;
- (\underline{d}) To ensure the widest circulation of the reports of the Special Committee and of information regarding its activities and findings, by all means available, through the Department of Public Information of the Secretariat and, where necessary, to reprint those reports of the Special Committee that are no longer available;
- (\underline{e}) To report to the General Assembly at its fifty-second session on the tasks entrusted to him in the present resolution;
- 9. <u>Decides</u> to include in the provisional agenda of its fifty-second session the item entitled "Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories".
