# **Note by the Secretary-General\***

- 1. In accordance with articles 7 and 9 of the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the fourth meeting of States parties to the Optional Protocol will be convened by the Secretary-General at the United Nations Office at Geneva, on Thursday, 25 October 2012, to elect 12 members of the Subcommittee on Prevention to replace those whose terms are due to expire on 31 December 2012 (see annex I). The names of the other members, who will continue to serve on the Subcommittee on Prevention until 31 December 2014, appear in annex II.
- 2. In compliance with article 6, paragraph 3, of the Optional Protocol, the Secretary-General, in a note verbale dated 9 May 2012, invited the States parties to the Optional Protocol to submit their nominations for the election of 12 members of the Subcommittee on Prevention by 9 August 2012. The Secretary-General has the honour to list below, in alphabetical order, all the names of persons nominated by 9 August 2012, indicating the States parties that have nominated them.
